The application for Economic Hardship Exemption must be denied for the following reasons:

Based on the first and most important guideline for demolition, the application for economic hardship exemption should not even be considered.

Applicant's Failure to provide any of the financial information,

Applicant's Failure to maintain the building, thus seeking demolition by neglect,

Insufficient evidence that the structures cannot be put to any beneficial use,

Insufficient evidence that rehabilitation is not economically feasible, and

For failure to show ANY Evidence at all of "bone fide efforts to sell or lease the Property or Structure" as required by the guidelines for economic hardship exemptions.

The Holy Name Complex meets at least 6 of the designated criteria as set forth in the ordinance in effect when the petition was filed plus one of the new criteria.

1. Under the amended ordinance, petitioners must prove that the Holy Name Complex's character, interest, or value as part of the development or heritage of the city, the Commonwealth, or the nation.

The Holy Name complex is a defining character and point of interest in this neighborhood. The archdiocese initially bought the entire block and then obviously sold off parcels north of the complex. Three of the four corner markers still exist. The neighborhood developed around Holy Name Complex. While each of the 4 buildings have individual value, they all complement each other in design, height, varying roof levels, elevated front entrances, and the use of two different stones or bricks on each building. The complex has value as an institutional presence in the development of the neighborhood. Many of our Derby visitors likely use the Holy Name Complex as a true Landmark.

2. Using the ordinance in effect at the time the petition was filed, petitioners state The buildings represent historic, beauty, educational, architectural, as well as cultural heritage of the City. These buildings are just gorgeous. The use of the two-colored bricks is brilliant. The decorative vergeboard, brick edging along roof lines, blended roof levels, and windows are stunning. These buildings are so beautiful that one's eyes are immediately drawn upward and into the buildings. The cultural heritage of the neighborhood grew up and around the Holy Name complex

- 3. Holy Name is also identified with a woman who significantly contributed to the culture of the nation. This is our very own Mother President Catherine Marie Schuhmann. She is the one who is leading the Passionist Nuns all around the world. She is not quite in the same category as Pope Francis, but as close as a woman can become in the Catholic Church.
- 4. Architect Gaffney used distinctive architectural designs in Buildings 1-3. None of the three buildings has a definitive style such as craftsman or gothic revival. Gaffney added features and blended the features into a Gaffney style. Building 3 has a decorative vergeboard unlike other vergeboard styles. Architect Nolan also did not use a standard style for building 4. Many design elements were mixed to compliment buildings 1-3.
- 5. Holy Name complex is identified with the well-known architect James J. Gaffney. He designed 3 of the 4 buildings. Gaffney was a prolific architect that greatly impacted the architect and development of Louisville. He had a unique fusion of styles. He was a man ahead of his time.
- 6. Using the ordinance in effect at the time the petition was filed, Holy Name complex has a relationship with areas south and west of the complex. The parish became so large that six new parishes were founded from Holy Name. Nearby neighborhoods where these parishes exist are eligible for the National Register of Historic Places. Furthermore, Roscoe Goose Historical Marker and house is just ½ block away.
- 7. The new ordinance includes the following criteria:

Its historic significance is based on its association with underrepresented history within the city, the Commonwealth, or the nation and it broadens our understanding of these underrepresented histories.

Louisville Women in history are underrepresented in this city. Louisville only has one statute of a woman. A female student of Holy Name School became Mother President Catherine Schumann. This is our very own Mother President Catherine Marie Schuhmann. She is the one who is leading the Passionist Nuns all around the world. She is not quite in the same category as Pope Francis, but as close as a woman can become in the Catholic Church. Holy Name Complex must be landmarked to represent women who have an underrepresented history in this City.
