RE: Request for Annexation Approval; Jeffersontown Ordinance No. 1421, Series 2021

Louisville Metro Public Works & Assets has reviewed the request to annex a certain area commonly known as Kirby Estates Subdivision. Within this area, Louisville Metro Public Works' assets include roadways, sidewalks and traffic signs.

The table below lists the public roads within the boundary described within Jeffersontown Ord No. 1421, Series 2021, the Pavement Condition Index (PCI) as measured in December of 2020, and the quantity of asphalt currently maintained by Louisville Metro. The condition of the roads within this area is considered Good to Very Good.



Traffic control signage maintained by Louisville Metro Public Works within this area includes, stop signs, yield signs, street name signs, No Outlet signs, speed limit signs and various supplemental plaques. The map below shows the current signage within Kirby Estates Subdivision. The overall condition of this signage is considered GOOD based on the 2020 Sign Assessment.



Louisville Metro Public Works has no current or proposed road network plans that would be impacted by this annexation however connectivity across public roads through current subdivision, and extensions of local classified roads to serve new compatible development, are encouraged in order to accommodate additional traffic in the future and provide alternative connectivity.
