AND I ALSO WANT TO SAY THAT, UH, THAT WE'RE HERE TO SUPPORT YOU AS WE MOVE FORWARD AND TACKLE CHALLENGES LIKE THE, YOU MENTIONED LIKE LG AND E UH, SAYING THAT THEY'RE GOING TO STILL BE DOING 80% CONVENTIONAL GENERATION FOUR YEARS BEFORE THE, UH, THE WE'RE SUPPOSED TO HAVE A HUNDRED PERCENT RENEWABLE ENERGY.

SO IT JUST DOESN'T JIVE.

AND, UM, AND IT DOESN'T MAKE SENSE.

AND, YOU KNOW, LIKE SAYING ALSO MENTIONED, THIS IS, YOU KNOW, FOR THE BIGGER PICTURE, THIS IS LIKE THE ONLY PLACE IN THE UNIVERSE.

WE KNOW WE HAVE HAD LIFE.

AND I THINK IT'S REALLY IMPORTANT FOR US TO, UH, CHERISH THAT AND TO, UH, KEEP THAT IN MIND, EVEN WHEN WE'RE DEALING WITH THESE DAY TO DAY LEGISLATIVE ISSUES.

SO, UM, THANKS VERY MUCH.

ONCE AGAIN, I SALUTE YOU FOR YOUR, UH, UH, UH, THE RESOLUTION AND I'M HERE TO SUPPORT YOU, WHETHER THAT MEANS PUSHING TOWARDS A DEREGULATED MARKET OR SOME SORT OF PPA OR WHATEVER NEEDS TO HAPPEN TO MAKE SURE THAT WE FULFILL THAT MANDATE. THANK YOU.

THANK YOU, STEPHANIE SINGLETON.

IS IT FINE IF I TAKE MY MASK OFF?

GOOD EVENING, MY NAME IS STEPHANIE SINGLETON.

THIS IS MY DAUGHTER, ELLIE SINGLETON.

SHE'S A SENIOR AT SACRED HEART ON NOVEMBER 8TH, JUST A FEW WEEKS AGO.

I CAME HOME AND I FOUND MY DAUGHTER LAYING ON THE BATHROOM FLOOR.

SHE HAD TRIED TO OVERDOSE.

I CALLED AN AMBULANCE.

THEY SAID THAT THEY WOULD SEND ONE, SEEMED LIKE MINUTES, WENT BACK CALLED AGAIN.

THEY SAID, THEY'D SEND ONE CALLED A THIRD TIME, SAID THEY WOULD SEND ONE THE FOURTH TIME.

YOU CAN IMAGINE A FRANTIC MOTHER WITH HER DAUGHTER LAYING ON THE FLOOR, WONDERING WHERE AN AMBULANCE IS WHEN YOU LIVE IN THE HIGHLANDS, RIGHT OFF NEWBURG ROAD, RIGHT BY THE EXPRESSWAY, LOTS OF HOSPITALS AROUND.

AND THERE'S STILL KNOWING AMBULANCE.

I WAS INFORMED THAT THERE'S A SHORTAGE OF

AMBULANCES AND ONE HAD NOT BEEN DISPATCHED BECAUSE THERE ONE THEN BECAUSE OF BUDGET CUTS.

SO I ASKED, SHOULD I JUST DRIVE MY DAUGHTER TO THE HOSPITAL?

AND THE NINE 11 CALLER SAID, WE CAN'T MAKE THAT DECISION FOR YOU.

BUT THEY PUT ME THROUGH TO THE HOSPITAL IN THE HOSPITAL, LAUGHED AND SAID, YEAH, YOU BETTER GET YOUR, YOUR DAUGHTER TO THE HOSPITAL.

SO LIVING OFF ME ABOUT GRAND, WE DROVE DOWN CASTLEWOOD TO BARRETT DOWN TO CO'S AIR.

AND AS WE'RE DRIVING, I'M LOOKING AT THESE BIKE LANES THINKING WE CAN AFFORD BIKE LANES, BUT WE CAN'T AFFORD AMBULANCES.

WE OWE OUR CITIZENS, OUR CHILDREN, OUR MOTHERS, AND FATHERS MORE.

IT'S A BASIC NEED TO HAVE AN AMBULANCE OR HAVE A POLICE OFFICER SHOW UP AT YOUR HOUSE.

THAT'S NOT A WANT, THAT'S A NEED.

IF IT WAS YOUR MOTHER, YOUR FATHER, OR SOMEONE THAT YOU HAD LAYING ON THE FLOOR, HOW WOULD YOU FEEL RIGHT NOW?

WHEN I HAVE TOLD PEOPLE WHAT HAPPENED, NO ONE CAN BELIEVE THAT WE COULDN'T GET AN AMBULANCE.

WHEN THE POLICE SHOWED UP, THEY EVEN SAID, YES, YOU NEED TO TAKE YOUR DAUGHTER.

THERE'S NO AMBULANCES.

THERE IS A BUDGET SHORTAGE.

I DON'T BELIEVE THERE'S A BUDGET SHORTAGE.

I BELIEVE WE'RE JUST NOT SPENDING OUR MONEY THE RIGHT WAY.

HOW IN THE WORLD ARE WE SPENDING \$8 MILLION ON THE INTERRUPTER PROGRAM?

AGAIN, WE ALREADY KNOW THAT IT FAILED.

THERE'S \$8 MILLION.

OUR EMPTIES, OUR POLICE OFFICERS DESERVE TO BE PAID MORE MONEY.

MAYBE IF WE'RE PAYING THEM MORE, MAYBE WE'LL GET MORE.

MAYBE WE'LL GET MORE QUALITY.

THE MAJORITY OF OUR CITIZENS HAVE ACCEPTED THE FAILURE OF GREG FISCHER, BUT WE ACCEPT.

WE WANT MORE METRO COUNCIL.

I ASKED YOU, WHAT ARE YOU EACH GOING TO DO TO IMPROVE OUR CITY?

AND I LEAVE YOU WITH ONE LAST THOUGHT.

I LOVE JIM KING.

AND I KNOW JIM KING WOULD NOT LET LOUISVILLE GO WITHOUT BASIC NEEDS OF AMBULANCES AND THE RESPECT FOR OUR POLICE OFFICERS.

THANK YOU, DANIEL CABO.

NOW THE FASCIA AND THE METRO COUNCIL RECEIVED MY OCTOBER 21, ARTICLE ONE PETITION TO CONGRESS TO REMOVE THE BIDEN ADMINISTRATION FROM OUR OFFICE.

THE EVIDENCE CLEARLY SHOWS THAT BIDEN IS MOVING TO TURN THE U S OVER TO COMMUNISM.

YOU ALSO RECEIVE MY SEPTEMBER 28 CRIMINAL COMPLAINT AGAINST THE FDA COMMISSIONERS FOR APPROVING THE VISOR VACCINES, ET CETERA.

FOR EXAMPLE, THERE HAS TO DO ONE INJURIOUS SIDE EFFECTS THAT WERE ACCIDENTALLY PUBLISHED IN THE OCTOBER 22ND, 2020 FDA.

IT IS AN IMPROPER LMPD POLICY THAT ALLOWED OFFICER MEGAN BELL TO STOP THE CAR AND THE 55 MILES PER HOUR TRAVEL LANE WITH THAT IMMEDION LANE TO SELFLY STOP.

THIS MATTER BECAME SUSPICIOUS.

WHEN THE OPEN RECORDS DEPARTMENT DENIED MY
REQUEST FOR THE LMPD ACCIDENT REPORT, THEN
PRIOR TO THE CRASH WITH ROGER BIRTHS, SIX, MS D
AUTO ACCIDENTS AND DRUG ABUSE ILLNESS, HE SHOULD
NOT HAVE BEEN DRIVING MOST, ESPECIALLY THE

WHEN MOST DAYS KNOWLEDGES WAS ONLY A MATTER OF TIME

THE MANSION IS THAT HE OUGHT TO BE CHARGED WITH
THE [INAUDIBLE] AND TO INVESTIGATE THE APPARENT
MARRIAGES OF EVERY PD MSD LEADING TO MOVE AND DON'TS
DEATH.

THANK YOU, CASSANDRA COLLIN, ARIANA LEVENSON EVENING COUNCIL MEMBERS, AS SOME OF YOU KNOW, I'M A FULL PROFESSOR AT THE UNIVERSITY OF LOUISVILLE, BRANDEIS SCHOOL OF LAW. AND I'M A MEMBER OF THE

FOUR 90 PROJECT, BUT TONIGHT I'M SPEAKING IN MY PERSONAL CAPACITY AS A RESIDENT OF DISTRICT EIGHT, AND AS A LABOR LAW EXPERT, HAVING STUDIED, PRACTICED OR TAUGHT LABOR LAW FOR OVER 25 YEARS. MY OVERARCHING POINT TODAY IS THAT THE FOP SHOULD NOT RECEIVE A LARGE MONETARY CONFESSION FROM A METRO LOUISVILLE, METRO RECEIVING MAJOR SUBSTANTIVE CONCESSIONS FROM THE FOP CONCESSIONS THAT ENSURE TRANSPARENCY AND ACCOUNTABILITY OR REVIEW OF THE CBAS FROM CINCINNATI, INDIANAPOLIS, AND NASHVILLE DEMONSTRATES, BUT NONE OF THE OTHER CONTRACTS PROHIBIT SUSPENSION WITHOUT PAY.

ALTHOUGH THEN IN EXTRAORDINARY
CIRCUMSTANCES, NONE CONTAIN A NO LAY-OFF
CLAUSE AND THEN SPECIFY THAT SUPERVISORY FILES
SHOULD BE DESTROYED AFTER ONE YEAR INDIANA AND
TENNESSEE LIGHT KENTUCKY ARE EACH ONE OF THE 21
STATES THAT HAVE A STATE LAW POLICE, BILL OF RIGHTS
AND THOSE NOTHING IN KENTUCKY'S LAW, KRS 67 C
THAT PROHIBITS REMOVING THESE PROVISIONS FROM OUR
PROPONENTS CBI RATHER DOES KENTUCKY LAW PROHIBIT,
INCLUDING A CBA PROVISION THAT REQUIRES INFORMAL
COMPLAINTS, BE PACED LACED IN PERSONNEL FILES AND
PERMANENTLY RETAINED.

AND IN FACT, LEXINGTON METRO RECENTLY REACHED AN AGREEMENT ON THEIR CBA.

THAT REPORTEDLY INCLUDES SECTION THREE E FIVE, WHICH REQUIRES INFORMAL COMPLAINTS TO BE DOCUMENTED ACCURATELY, AND TO BE PROVIDED TO THE PIU FOR ENTRY INTO THE EARLY INDICATIONS.

THAT SYSTEM, PERHAPS METRO LOUISVILLE IS NOT READY TO DEMILITARIZE THE POLICE AND IS NOT READY TO STOP THE FOPS FORUM SHOPPING, BUT IS THERE REALLY TOO MUCH TO ASK THAT GLOBAL CBA BE EQUALLY AS CLEAR AS LEXINGTON'S ABOUT RETAINING COMPLAINTS?

THE COMMUNITY WANTS YOU TO TAKE ACTION THAT EVERYONE BELIEVES THE POLICE NEED MORE MONEY IS NOT A SATISFACTORY ANSWER TO WHY THE CVA IS NOT REQUIRING TRANSPARENCY AND ACCOUNTABILITY.

AT ONE POINT IN TIME, EVERYONE THOUGHT THE WORLD WAS FLAT, OR AT LEAST IF YOU DEFINED EVERYONE AS EUROPEANS LATER IN HISTORY, EVERYONE THOUGHT THAT SLAVERY WAS FINE.

IF EVERYONE IS DEFINED AS THE U S COURTS A BIT LATER THAN THAT, EVERYBODY BELIEVED THAT SEPARATE WAS

EQUAL.

AT LEAST IF EVERYONE WAS DEFINED AS THE SUPREME COURT, BUT THAT TIME, THANKFULLY ONE PERSON DESCENDED DISSENTED.

METRO COUNCIL HAS TWO MEANS AT YOUR DISPOSAL TO ENFORCE TRANSPARENCY AND ACCOUNTABILITY FROM LMPD. BUT FIRST IS THE BUDGET WHICH HAS ALREADY PASSED THE VOTING, NOT TO RATIFY THIS CBA UNTIL IT IS FIXED.

PLEASE DON'T LET THIS OPPORTUNITY PASS BY TO THANK YOU.

I'M MARCELLUS MAYES.

I'M HERE TODAY AS CHAIR OF THE METRO DISABILITY CORRELATION.

AND I'M HERE IN REFERENCE TO THE TRANSIT AUTHORITY OF RIVER CITY.

I'VE BEEN HERE TO THE PUBLIC WORKS MEETING GOVERNMENT OVERSIGHT, AND I'M HERE TO PLEAT THE METRO COUNCIL THAT THEY TERMINATE.

THE CONTRACT IS CURRENTLY WITH MV TRANSIT.

I WAS HERE TO COORDINATE THE TRANSPORTATION AT 1:30 AM OF THE QUADRIPLEGIC THAT WAS LEFT OUT.

IT ESCAPED THE THEATERS AND ALSO DEALT WITH HIM PREVIOUSLY WHEN HE WAS LEFT OUT OF ANOTHER THEATER IN ST. MATTHEWS ARE HERE, PEOPLE'S PLEAS AND CRASH TO BE TREATED LIKE KENTUCKY ANS UH, CITIZENS OF LOUISVILLE.

AND I JUST WAS IN A TWO HOUR MEETING WITH ONE OF YOUR METRO COUNCIL MEMBERS WHO REPRESENTS TORQUE ALONG WITH A FORMER JUDGE, DAVID HOLTON AND FORM A CHAIR THAT THE HUMAN RELATIONS COMMISSION, UH, DR. PATTERSON, WE MET WITH THEM FOR TWO HOURS, WENT OVER A NUMBER OF ISSUES RELATING TO TRANSPORTATION AND TRANSPORTATION, TRANSPORTING PEOPLE WITH DISABILITIES.

THEY SAY IN REFERENCE TO THE PANDEMIC, WE MET HERE FOUR OR FIVE YEARS AGO WITH DAVID.

JAMES HAD PUBLIC SAFETY.

I FILLED UP THIS ROOM FULL OF PEOPLE WITH THESE SAME ISSUES.

ALL THE PANDEMIC HAS DONE HAS MADE IT WORSE FOR

PEOPLE WITH DISABILITIES.

LOUISVILLE CANNOT BE A COMPASSIONATE CITY. IF YOU TREAT ANY CITIZEN, THE WAY THAT THE DISABLED AND THE ELDERLY, THE HOMELESS, AND ALL OF US DISABLED PEOPLE ARE INCLUDED.

ALL THE CATEGORIZED SOCIOECONOMICALLY IN KENTUCKY.

THERE ARE OVER 300,000 IN THIS STATE LIKE MYSELF. UM, I'VE, I'VE BEEN TRAINED IN LAW ENFORCEMENT AND I HAVE A DEGREE IN HUMAN SERVICES AS WELL, BUT EVERY AMERICAN YOU CANNOT HAVE BILL'S PAST CALLING AMERICAN RESCUE.

WHEN PEOPLE LIKE MYSELF ARE LEFT BEHIND, CAN GET THE JOBS, CAN GET TO DOCTOR'S OFFICES OWN TIME. AND EVERYBODY JUST TURNS TO HATE.

YOU HAVE 160 MILLION SURPLUS DOLLARS THAT ARE LEFT A ONE TIME INFLUX MONEY.

I DON'T WANT TO HEAR ABOUT THE MASS TRANSIT THING.

HASN'T BEEN IN 74 WHEN EVERYBODY'S BEEN GIVEN MONEY, BUT THE DISABLED AND WE DESERVE BETTER. YOU HAVE TO TRUST THE DRIVERS WHERE JCPS HAS GIVEN \$5,000 SENT ESSENTIAL WORKERS.

THEY GIVE \$500 TO THOSE GUYS THAT ARE FACE TO FACE WITH THE COVID EVERY DAY.

THAT'S NOT RIGHT.

AND SO AN AUDIT TO TREAT EVERYBODY FAIRLY. WE HAVE TO LOOK AT EVERYBODY AS HUMAN BEINGS, REACH OUT TO EACH OTHER AND LOVE EACH OTHER BETTER, BUT THAT HAS TO START.

IF YOU'RE GOING TO GET \$391 MILLION WITH THIS INFRASTRUCTURE, BEAUTIFUL PUBLIC TRANSPORTATION IN KENTUCKY, MORE MONEY DOES THANK YOU. THANK YOU, ABBY LONG.

YES.

CAN YOU HEAR ME?

YES.

YOU CAN GO AHEAD.

MA'AM

MY NAME IS AVALON I'M FROM DISTRICT FOUR SHELBY PARK

I'M HERE TO SPEAK ABOUT THE OFFICER AND SERGEANT CBAS.

AND WHEN THE TIME COMES, I'M ASKING YOU TO VOTE. NO, ON THIS CONTRACT, YOU AS COUNCIL MEMBERS HAVE ONLY TWO WAYS OF BEING INVOLVED IN THIS PROCESS.

THOSE WAYS ARE BY VOTING ON A BUDGET AND VOTING ON THE CBAS THAT THE MAYOR CONTINUES TO NEGOTIATE BEHIND CLOSED DOORS.

YOU HAVE APPROVED THE BUDGET.

SO THERE'S NO GOING BACK THERE IN THIS VERY MURKY NEGOTIATION PROCESS.

THIS IS YOUR ONLY CHANCE TO HAVE A SAY ON THIS CONTRACT FOR THE NEXT TWO YEARS.

MANY OF YOU SAID THIS CONTRACT ISN'T PERFECT, BUT HOW SOME REFORMS, LIKE WHAT MONETARILY INCENTIVIZING OFFICERS TO MOVE TO NEIGHBORHOODS OR PAID VOLUNTEER HOURS WHERE POLICE COULD LITERALLY VOLUNTEER FOR THE FOP, A POLITICAL PARTY OR A HATE GROUP AND GET PAID FOR IT.

I SEE NOTHING BEING REFORMED HERE IN THIS CONTRACT.

AN OFFICER CAN UNJUSTIFIABLY USE

EXCESSIVE FORCE AND STILL KEEP THEIR JOB IN THIS CONTRACT.

INFORMAL COMPLAINTS ARE DESTROYED AFTER TWO YEARS. HOW CAN AN EARLY WARNING SYSTEM BE EFFECTIVE? IF WE ARE DESTROYING INFORMAL COMPLAINTS EVERY TWO YEARS, I'M TALKING ABOUT THE EARLY WARNING SYSTEM THAT LMPD HAS BEEN TOUTING SINCE 2015, BUT WHEN PRESSED ON IT, THEY SAY IT'S NOT ACTUALLY WORKING.

AND THE CHIEF GIVES ALONG WITH THE REASONS WHY YET RIGHT DOWN THE STREET, LEXINGTON, KENTUCKY HAS A WORKING SYSTEM, A SYSTEM THAT WOULD HAVE FLAGGED SOMEONE LIKE BO GOT A GUARD IN HIS 18 MONTHS AS AN OFFICER, HE RACKED UP 10 USE OF FORCE REPORTS. IF HE HAD WORKED IN LEXINGTON, HE WOULD HAVE BEEN FLAGGED FOUR TIMES IN SIX MONTHS.

WHY DON'T WE REQUIRE THAT LMPD UTILIZE THE SAME SYSTEM IN THAT SAME VEIN BETWEEN 2010 AND 2020 LMPD HAS SHOT 72 PEOPLE.

AND HOW MANY MORE LIBERAL UNIONS ARE GOING TO BE A CASUALTY OF BAD POLICING BEFORE YOU DO SOMETHING ABOUT IT.

I'VE YET TO SEE ANYTHING IN THE CBA THAT WILL HOLD THEM MORE ACCOUNTABLE THAN YEARS PRIOR.

YOU MUST ENSURE THAT THE CBA IN NO WAY RESTRICTS OR SHIELDS ITS WORST OFFICERS.

THIS CONTRACT IS A SLAP IN THE FACE OF EVERY PERSON WHO WALKED THE STREETS LAST YEAR, BEGGING FOR CHANGE FROM CITY LEADERS, WE ASK YOU TO MAKE THESE

CONTRACTS STOP PROTECTING THE WORST OF THE WORST. INSTEAD, YOU'RE SITTING HERE CONSIDERING A CONTRACT THAT GIVES A 15% RAISE TO A DEPARTMENT WHO HAS DOCUMENTED INSTANCES OF THROWING DRINKS AT HOMELESS PEOPLE, LEAVES INCIDENT REPORTS, NEARLY BLANK, HARASSES WOMEN, AND HAVE SEXUALLY ASSAULTED CHILDREN.

DID THESE PEOPLE SOUND DESERVING OF A MASSIVE RAISE WITHOUT PILLARS OF TRANSPARENCY, MISCONDUCT, TRACKING, AND ACCOUNTABILITY BEING PUT IN PLACE?

I THINK NOT.

AND SORT OF GETTING THE PLATITUDES ABOUT REFORM. I WANT YOU TO DO SOMETHING ABOUT IT BY NOT PASSING A CBA THAT CONTINUES TO CATER TO THE FOP.

LOUISVILLIANS DESERVE BETTER VOTE.

NO, PLEASE SEND IT BACK IN.

THANK YOU, CASSANDRA.

SO SORRY.

YOU CAN GO AHEAD.

YES.

UM, I'M CONCERNED WITH MSD AND THE WATER COMPANY MSD HAS BEEN CHARGING EXCESSIVE PRICES OR THE WATER.

UH. THEY CALL IT CLEANSING OF THE WATER.

THEY'RE CHARGING OVER 120 TO \$180.

YOUR WATER BILL MAY ONLY BE 20 TO \$30, BUT YOUR MSD BILL IS CLOSE TO \$200 BY ITSELF.

AND I'M CONCERNED WITH WHY THIS IS BEING ALLOWED BY METRO COUNCIL.

PLUS METRO COUNCIL ISSUE THAT OUT ISSUE.

THEY RECEIVE OVER \$2 MILLION TO HELP

INDIVIDUALS WHO WERE HAVING PROBLEMS WITH THEIR WATER BILLS IF THEY WERE BEHIND IN IT.

I KNOW ONE FAMILY OF A YOUNG LADY RIGHT NOW THAT HAS FOUR YOUNG CHILDREN AT HOME, HER WATER'S OFF AND YET WHEN SHE APPLIED TO THE PROGRAM THAT YOU HAVE IN PLACE TO HELP THESE TYPES OF PEOPLE, SHE WILL SEE NO MONEY.

THEY HAVE BEEN NOW ALMOST TWO MONTHS WITHOUT ANY WATER.

AND AS I UNDERSTAND THAT OUT OF THAT \$2 MILLION, YOU'VE ONLY HELPED 11,000 CUSTOMERS.

WHERE'S THE MONEY GOING?

MAY I HAVE A MOTION AND A SECOND SUM OF MOTION BY COUNCILMAN HOLLANDER.

ARTHUR.

SECOND BY COUNCILMAN ARTHUR.

UH, IS THERE ANY DISCUSSION COUNCIL, WOMAN MCCRANEY?

YES.

THANK YOU.

MR. PRESIDENT COLLEAGUES TONIGHT, WE HAVE AN OPPORTUNITY TO PASS AN ORDINANCE THAT WILL HELP THOSE WHO ORDINARILY, PERHAPS COULD NOT HELP THEMSELVES FROM WHAT I HAVE RESEARCHED AND FROM WHAT I HAVE HEARD FOR NO OTHER REASON THAN UNEMPLOYMENT AND PERHAPS SOME UNFORTUNATE CALCULATIONS OF BILLS, MOUNTING, MEDICAL DEBT, PEOPLE HAVE GOTTEN BEHIND IN THEIR CREDIT.

AND SOME PEOPLE HAVE BAD CREDIT BECAUSE OF THAT. I AM PROPOSING THIS URBAN, THAT I AM HOPEFUL THAT YOU ALL WILL SUPPORT BECAUSE RESEARCH SUGGESTS THAT EMPLOYERS DO NOT HAVE TO USE CREDIT CHECKS IN ORDER TO JUDGE SOMEONE'S ABILITY TO BE A GREAT EMPLOYEE, BETTER CHECKS WERE NOT DESIGNED FOR PEOPLE TO USE AS A HIRING TOOL.

CREDIT REPORTS WERE DESIGNED FOR A NATURAL INSTITUTIONS TO DETERMINE CREDIT WORTHINESS. AND SO I AM ASKING FOR YOUR SUPPORT OF THIS ORDINANCE TONIGHT, BECAUSE SO MANY PEOPLE HAVE BEEN UNEMPLOYED AND A LOT OF PEOPLE HAVE MOUNTING MEDICAL BILLS AND THEY MAY HAVE FLAWED CREDIT. AND IF THEY ARE BEING JUDGED BASED ON THOSE UNFORTUNATE MISHAPS ON THEIR CREDIT SCORE AND THE CREDIT REPORT, THEN THEY ARE NOT ABLE TO GET A JOB AND GET THE MONEY THAT THEY NEED IN ORDER TO FIX THEIR CREDIT AND TO HELP THEIR OWN HOUSEHOLDS SURVIVE.

PEOPLE ARE BEING DENIED JOBS BECAUSE OF THE CREDIT CHECKS FOR CREDIT IS ASSOCIATED WITH HOUSEHOLD UNEMPLOYMENT, LACK OF HEALTH COVERAGE, AND MEDICAL DEBT.

THAT'S CONTINUING TO MOUNT.

AND AGAIN, I AM ASKING FOR YOUR SUPPORT OF THIS ORDINANCE TONIGHT.

AND IF I HAVE ANY QUESTIONS, IF YOU HAVE ANY QUESTIONS THAT YOU'D LIKE FOR ME TO ANSWER, I AM CERTAINLY HOPEFUL THAT YOU WOULD ASK THOSE QUESTIONS. I'M HERE TO ANSWER YOUR OUESTIONS.

THANK YOU, MR. PRESIDENT, FOR ALLOWING ME TO PRESENT THIS ORDINANCE.

THANK YOU, COUNCILWOMAN.

COUNCILMAN ARTHUR.

THANK YOU MR. PRESIDENT.

I'M A PROUD CO-SPONSOR OF THIS ORDINANCE AND THERE ARE PLENTY OF REASONS WHY I WOULD ENCOURAGE MY COLLEAGUES TO SUPPORT IT, BUT I'LL JUST SHARE A HANDFUL.

CREDIT REPORTS ARE HISTORICALLY INACCURATE.
THE PUBLIC INTEREST RESEARCH GROUP STUDY SHOWS
THAT ONE IN FOUR CREDIT REPORTS CONTAINED SERIOUS
ERRORS AND 79% OF ALL CREDIT REPORTS CONTAIN
ERRORS OF SOME KIND CREDIT CHECKS BY EMPLOYERS
VIOLATE WORKER'S PRIVACY.

WHEN CREDIT CHECK IS PERFORMED, YOU CAN RELEASE

PERSONAL INFORMATION, INCLUDING MEDICAL CONDITIONS, DISABILITY, FAMILY STATUS INFORMATION THAT ANTI-DISCRIMINATION LAWS ARE INTENDED TO PROTECT CREDIT HISTORY DOES NOT.

AS YOU HAVE HEARD, DOES NOT PREDICT JOB PERFORMANCE.

THERE ARE THREE MAJOR CREDIT BUREAUS, EXPERIAN, EQUIFAX TRANSUNION.

AND WHEN SIMILAR LEGISLATION WAS BEING

CONSIDERED AN OREGON, ERIC ROSENBERG, THE DIRECTOR OF STATE GOVERNMENT RELATIONS FOR TRANSUNION ADMITTED UNDER OATH.

WHOA, WE DO NOT HAVE ANY RESEARCH TO SHOW ANY STATISTICAL CORRELATION BETWEEN WHAT'S IN SOMEBODY'S CREDIT REPORT AND THEIR JOB PERFORMANCE OR THEIR LIKELIHOOD TO COMMIT FRAUD.

BUT I LEE ENOUGH, HE WAS THERE TO SPEAK IN OPPOSITION TO THE LEGISLATION AND THE AGENCIES JUST LIKE HIS MARKET.

THE USE OF CREDIT REPORTS LOBBY AGAINST BILLS.

LIKE THE ONE BEFORE YOU TODAY, CREDIT CHECKS ARE DISCRIMINATORY BY NOW.

YOU SHOULD KNOW ALL OF THE WAYS IN WHICH BLACK AMERICANS HAVE BEEN TARGETED FOR PREDATORY AND HIGH COST LOANS, WHICH CREDIT.

I WOULD LIKE TO SPEAK TO ANOTHER DEMOGRAPHIC TONIGHT.

WOMEN, THE NATIONAL PARTNERSHIP FOR WOMEN AND FAMILIES FOUND THAT ONLY 45% OF WOMEN REPORT THAT THEY ARE ABLE TO PAY CREDIT CARD BALANCES IN FULL COMPARED TO 68% OF MEN.

ONLY 43% OF WOMEN SAY THAT THEY HAVE AN EMERGENCY FUND TO SUPPORT THEMSELVES.

IF THEY LOSE THEIR JOBS COMPARED TO 63% OF MEN FOR WOMEN, MEDICAL DEBT IS OFTEN IN CREDIT CARD DEBT. WHEN THE AFFORDABLE CARE ACT WAS PASSED, 19 MILLION WOMEN WERE UNINSURED.

WOMEN ARE MORE LIKELY TO BE TARGETED FOR TOXIC WOUNDS.

32% MORE LIKELY TO RECEIVE SUBPRIME MORTGAGES OF ALL TYPES AND 41% MORE LIKELY TO RECEIVE COSTS, SUBPRIME MORTGAGES, PUTTING THEM AT GREATER RISK OF FORECLOSURE.

84% OF DOMESTIC VIOLENCE SURVIVORS SAY THEIR ABUSERS CONTROL THEIR CASH BANK ACCOUNTS, CREDIT CARDS, AND 59% SAY THAT DEBT IS BUILT IN THEIR

NAME.

ALL OF THIS LEADS TO MY FINAL REASON FOR SUPPORTING THIS ORDINANCE AND THAT YOU SHOULD SUPPORT THIS ORDINANCE.

IT CAN HELP US BREAK THE CYCLES THAT SOME OF OUR CONSTITUENTS ARE IN.

IF YOU'VE HAD TO MAKE A DIFFICULT DECISION THAT IMPACTS YOUR CREDIT, YOU CAN'T PAY THAT OFF UNLESS YOU ARE PROPERLY EMPLOYED AND YOU CAN'T BE PROPERLY EMPLOYED.

IF THERE ARE PRACTICES IN PLACE TO KEEP YOU FROM BEING EMPLOYED, YOU ARE STUCK.

YOU ARE IN A TRAP.

SOME OF YOU MAY HEAR THE LANGUAGE, THE TERM TRAP THAT IS SYNONYMOUS WITH LOW INCOME NEIGHBORHOODS, BECAUSE YOU ARE LITERALLY TRAPPED IN A CYCLE. THIS ORDINANCE WILL HELP US OPEN UP THAT TRAP. IT WILL HELP US GIVE SOMEONE AN OPPORTUNITY FOR FINANCIAL FREEDOM.

AND I'M GRATEFUL AS WE HAVE THIS SURPLUS OF MONEY FROM THE FEDS, WITH THE AMERICAN RESCUE PLAN, THERE ARE SO MANY GOALS TO GET PEOPLE EMPLOYED, GET THEM BACK WORKING, BUT NONE OF THESE GOALS WILL BE MET.

NONE OF THESE GOALS WILL BE MET.

NONE OF, NONE OF US WILL BE SATISFIED WITH THESE GOALS.

AND FAR AS EMPLOYMENT GOES, IF THERE ARE OPPORTUNITIES FOR EMPLOYERS TO DISCRIMINATE AGAINST PEOPLE TO COME IN AND WORK.

SO I ASKED FOR YOUR SUPPORT.

I HOPE YOU CAN VOTE.

YES.

I HOPE YOU CAN PUT ALL OF YOUR CONCERNS ASIDE AND WE'RE HAPPY TO ANSWER ANY QUESTIONS AND LET'S GET THIS PASS.

THANK YOU.

THANK YOU, COUNCILMAN COUNCILMAN PIAZZA, TEENIE. THANK YOU MR. PRESIDENT.

UM, UM, ONE OF THE FOLKS THAT VOTED AGAINST THIS IN COMMITTEE AND I'M GOING TO SORT OF LAY OUT WHY I DID AND THEN, UH, AGAIN, SIMILAR TO CATHERINE ARTHUR, GLAD TO ANSWER QUESTIONS ABOUT SOME OF THE POINTS I'M GOING TO MAKE HERE.

NUMBER ONE, I ACTUALLY AGREE WITH, TO BE CLEAR. I AGREE WITH COUNCILMAN ARTHUR ABOUT THE TARGETING

THE PREDATORY TACTICS USED BY LENDING AGENCIES, PAYDAY LOANS, AND THESE TYPES OF THINGS, UH, THAT, UH, CAN PREY ON PARTICULARLY LOW-INCOME COMMUNITIES AND KEEP THEM IN POVERTY. KEEP IN MIND, THIS WILL DO ABSOLUTELY NOTHING TO CHANGE THAT.

UH, WE ARE NOT TARGETING PREDATORY LENDERS HERE. WE ARE TARGETING BUSINESSES AND HOW THEY MAKE DECISIONS ON WHO THEY HIRE.

IT IS ILLEGAL AND HAS BEEN FOR MANY YEARS TO DISCRIMINATE ON PEOPLE FOR PEOPLE WHO ARE APPLYING FOR CREDIT.

SO YOU CANNOT DISCRIMINATE ON RACE, GENDER, AND A MYRIAD OF OTHER FACTORS.

WHEN SOMEBODY IS APPLYING FOR CREDIT, YOU CANNOT DISCRIMINATE ON GENDER RACE AND A MYRIAD OF OTHER FACTORS.

WHEN YOU ARE HIRING SOMEBODY, THERE ARE MASSIVE GOVERNMENT AGENCIES THAT ENFORCE THESE EXISTING LAWS.

THEY'RE FEDERAL THAT COVER THE ENTIRE UNITED STATES. SO IF IT WAS ILLEGAL, WHEREVER WAS DISCRIMINATORY.

EXCUSE ME.

IF IT WAS DISCRIMINATORY TO USE A CREDIT RATING WHEN HIRING SOMEBODY, IT WOULD ALREADY BE BY DEFINITION, ILLEGAL CREDIT SCORES, MEASURE BEHAVIOR. THEY DON'T CARE ABOUT YOUR RACE.

AGAIN, THAT WILL BE ILLEGAL ALREADY.

THEY DON'T CARE ABOUT YOUR GENDER.

THAT WOULD ALREADY BE ILLEGAL IF IT DID, BUT IT MEASURES BEHAVIOR.

YOU MAKE A PROMISE.

YOU'RE NOT ABLE TO FULFILL THAT PROMISE.

UNFORTUNATELY, WITH THIS BILL AS WITH MANY BIG BUSINESSES IN MANY GOVERNMENT ORGANIZATIONS ARE EXEMPT.

SO I ASK YOU SOMETHING, IS THERE ANY OTHER LAW? IS THERE ANY OTHER TYPE OF DISCRIMINATION THAT ONCE WE'VE ESTABLISHED, IT IS DISCRIMINATION THAT WE EXEMPT BANKS, BIG BUSINESSES, FINANCIAL INSTITUTIONS, AND GOVERNMENT AGENCIES FROM ENGAGING IN THAT DISCRIMINATION. OF COURSE NOT.

IF, IF, IF THIS WAS TRULY DISCRIMINATORY, THERE SHOULD BE ZERO EXEMPTIONS, BUT THERE ARE EXEMPTIONS

IN THE BELL CLEARLY INDICATING IT IS NOT A MATTER OF DISCRIMINATION.

IT IS A MATTER OF BEHAVIOR IN WHETHER OR NOT THIS IS SOMEBODY WHO YOU WANT TO HIRE.

BASED ON PAST THE BEHAVIOR IN COMMITTEE, WE HAD A FEW PERSONAL EXAMPLES.

AS FAR AS I COULD TELL, I WAS THE ONLY PERSON THAT ACTUALLY HAD DEFAULTED ON CREDIT AND HAD A REALLY, REALLY BAD, GREATEST WARFARE PERIOD OF TIME AND WAS STILL ABLE TO GET A JOB.

WE HAD STORIES FROM OTHER COMMITTEE MEMBERS ABOUT TIMES WHEN THEY HAD, UH, HAD SCARES IF YOU WILL, TO THEIR CREDIT, BUT NOT ONE EXAMPLE OF SOMEBODY FROM THE COMMITTEE OR ANYBODY ELSE, NOT ONE SPECIFIC EXAMPLE OF SOMEBODY WHO DID NOT GET A JOB SIMPLY BECAUSE OF THEIR CREDIT SCORE AND FOR NO OTHER REASON, NOT ONE EXAMPLE.

I SAW ARTICLES THAT THE FREE MARKET IS WAIVING EVERYTHING, INCLUDING BACKGROUND TRACKS. UH, THERE WAS A WALL STREET JOURNAL ARTICLE THAT TALKED ABOUT, UH, BECAUSE THE LABOR MARKET IS SO TIGHT.

PRIVATE EMPLOYERS ARE WAIVING EVERYTHING, INCLUDING BACKGROUND CHECKS AND THEY CITED UPS IS ONE OF THOSE COMPANIES BECAUSE THEY'RE SO DESPERATE FOR LABOR, THE FREE MARKET IS ADJUSTING TO THIS.

THE FOOD MARKET IS NOT DOING THIS AGAIN. WE DID NOT HAVE EXAMPLES OF PEOPLE OR COMPANIES DISCRIMINATING OR ONLY CREDIT RATING AND SAYING THAT WAS THE ONLY PROBLEM OTHER JURISDICTIONS HAVE DONE THIS.

AND THAT WAS POINTED OUT.

I DID THE RESEARCH, EVERY SINGLE JURISDICTION OTHER THAN ONE.

AND THAT WAS THE STATE OF VERMONT, WHETHER IT WAS A STATE OR A CITY THAT DID THIS HAD FAR WORSE, UNEMPLOYMENT THAN LOUISVILLE, BECAUSE THIS IS THE KIND OF BEAR IN OUR SITE.

SOME EXAMPLES IN A SECOND THAT HAVE SIGNIFICANT UNIN, UNINTENDED CONSEQUENCES, EVEN BEING WELL-INTENTIONED.

AND WE SEE THAT OVER AND OVER AGAIN IN PUBLIC POLICY, THE, THIS HAS BEEN PROPOSED TO SOME DEGREE AT THE FEDERAL LEVEL, THE SOCIETY OF HUMAN RESOURCE MANAGERS, QUOTE, BELIEVES, AND PLUMBERS MUST HAVE THE

ABILITY TO ENACT POLICIES AND PROCEDURES THAT BEST MEET THE NEEDS OF THEIR INDIVIDUAL ORGANIZATIONS SAYS JOHNNY C.

TAYLOR, JR. SHRM PRESIDENT AND CEO OF THE ORGANIZATION.

AND THAT'S MY UNDERLYING POINT, WHICH I'LL DRIVE HOME AGAIN IN A SECOND.

I DO NOT HAVE THE HUBRIS TO UNDERSTAND ALL OF THESE BUSINESSES AND SMALL BUSINESSES ARE THE ONES THAT ARE TRULY NOT EXEMPTING.

THIS BIG BUSINESS, LOTS OF EXEMPTIONS BAGS, LOTS OF EXCEPTIONS, GOVERNMENT, LOTS OF EXEMPTIONS, BUT IT HAS ALL THESE OTHER SMALL BUSINESSES THAT I DON'T KNOW MUCH ABOUT.

AND I'M NOT SMART ENOUGH TO KNOW ALL ABOUT THEM, THAT THEY MIGHT HAVE SOME CORRELATION IN SPECIFIC INSTANCES RELATED TO BAD CREDIT IN THEIR PERFORMANCE IN THE JOB THAT MEN RUN INTO A PROBLEM NOW.

AND I'LL SAY ONE MORE THING.

THERE WAS AN ARTICLE DONE BY, UM, FOR BEAR WITH ME A SECOND.

I'LL CITE THE SOURCE ARTICLE IN US, WORLD NEWS CREDIT CHECK BANDS HURT THOSE.

THEY MEAN TO HELP IT'S CITED A STUDY DONE BY A PAIR OF ECONOMISTS READS TWO HIGHLIGHTED PORTIONS. THIS OF COURSE ALSO PRODUCES WINNERS AND LOSERS PEOPLE WITH LESS WORK EXPERIENCE AND WHOSE EDUCATIONAL BACKGROUND IS LESS STRONG, WILL NOW HAVE A HARDER TIME FINDING WORK.

AND WHEN CLIFFORD AND SHOWED THESE WERE THE AUTHORS, THE ECONOMIST THAT WROTE THIS ESTIMATE, THE NET EFFECT OF THESE TWO EFFECTS, THE BAN ON CREDIT CHECKS AND THE EMPLOYER RESPONSE. AND THEY LOOKED AT THE OTHER JURISDICTIONS THAT HAD DONE THIS.

THEY FIND THAT QUOTE, AFRICAN AMERICANS LOSE OUT THE LIKELIHOOD OF UNEMPLOYMENT FOR BLACKS IN THEIR PRIME AGE IS 1.1 PERCENTAGE POINTS HIGHER IN PLACES WITH THE BAN THAN IN THOSE WITHOUT A SIMILAR LOGIC APPLIES TO YOUNG PEOPLE WHO NATURALLY HAVE LESS WORK EXPERIENCE.

ALTHOUGH THE SIZE OF THE EFFECT OF SMALLER OF, OF THIS STORY IS ONE OF UNINTENDED CONSEQUENCES THAT ALSO REINFORCES THE IMPORTANCE OF ECON 1 0 1 STYLE SUPPLY AND DEMAND DYNAMICS.

WHEN FIRMS ARE CONFRONTED WITH GOVERNMENT IMPOSED RISK RESTRICTIONS ON APPLICATION PROCEDURES LIKE BANS ON CREDIT CHECKS, THEY WILL TRY TO COME UP WITH NEW WAYS TO GET AN APPROPRIATE SENSE OF WHAT, WHICH APPLICANTS TO HIRE.

THEY POINTED TO THE FACT THAT THESE JURISDICTIONS EMPLOYERS ACROSS THE BOARD RAISED EDUCATIONAL AND OTHER STANDARDS TO RESTRICT ACCESS TO THOSE.

THEY THOUGHT, UH, THAT MIGHT HAVE THAT.

NOW THEY WERE BANNED FROM TRACKING RELATED TO THEIR CREDIT.

AGAIN, I DON'T KNOW HOW EVERY BUSINESS IN THIS CITY OPERATES.

THEY MAKE DECISIONS THAT IS THEIR PRIVATE BUSINESS ON HOW THEY MAKE DECISIONS ON WHO TO HIRE. IF THEY USE THINGS LIKE CREDIT TREKS, AND PEOPLE THINK THAT'S RIDICULOUS, GO SOMEPLACE ELSE. NOT EVERYBODY USES THEM.

I DON'T HAVE EVIDENCE HERE OF MASS UNEMPLOYMENT. AS A MATTER OF FACT, WE HAVE RECORD EMPLOYMENT. THE BIGGEST PROBLEM WE HAVE RIGHT NOW IS REALLY MORE PEOPLE IN THIS CITY TO WORK AND FILL THESE JOBS, RIGHT?

SO I THINK WHAT WE HAVE HERE IS A SOLUTION LOOKING FOR A PROBLEM.

AND THEN I ASK, RIGHT, IF WE DON'T HAVE A PROBLEM AND WE'RE PROPOSING THIS SOLUTION, WHERE DOES THAT TREND END AND RUN?

DO WE ACKNOWLEDGE THAT WE HAVE SIGNIFICANT ANTI-BUSINESS IN ANTI-FREE MARKET PRINCIPLES DICTATING THIS CITY, FAKE YOUR COLLEAGUES, AND LASTLY, AND VOTE DOWN THIS ONE MEETING, UH, BUT, UH, FRAUGHT WITH PROBLEMS ORDINANCE. THANK YOU.

THANK YOU.

COUNSELING COUNSELING.

I THANK YOU, MR. PRESIDENT, I'LL BE

VERY BRIEF MAINLY BECAUSE COUNCILMAN ARTHUR ALREADY SAID MOST OF WHAT I WANTED TO TALK ABOUT, BUT I THINK THE EVIDENCE INDICATES THAT THE USE OF CREDIT REPORTS FOR EMPLOYMENT DECISIONS, IT DOES NOT LAY INTO BETTER HIRING DECISIONS AND DISPROPORTIONATELY IMPACTS WOMEN AND PEOPLE OF COLOR. I THINK THE DOWNWARD SPIRAL THAT COUNCILMAN ARTHUR TALKED ABOUT IS PARTICULARLY IMPORTANT. WHAT WE'RE TALKING ABOUT AS PEOPLE WHO ARE

UNEMPLOYED FOR ONE REASON OR ANOTHER, OR WHO HAVE BAD CREDIT RESULTING FROM MEDICAL BILLS, WHO THEN HAVE CREDIT RATINGS USED AGAINST THEM AND TRYING TO FIND EMPLOYMENT, AND THEY'RE UNABLE TO FIND EMPLOYMENT AND THEIR CREDIT GETS WORSE AND THE SPIRAL JUST CONTINUES.

AND THAT'S WHY MANY STATES AND CITIES HAVE RESTRICTED THE PRACTICE.

AND I THINK THAT'S WHY WE SHOULD DO THAT HERE AT LOWVILLE AS WELL.

I THINK COUNCILWOMAN RECURRINGLY FOR HER WORK ON THIS AND OUR URGE YOUR APPROVAL.

THANK YOU, COUNCILMAN COUNCILMAN ARTHUR. THANK YOU.

I LIKE OUR COLLEAGUES TO KEEP IN MIND THAT THE DESIRE FOR EXAMPLES WOULD REALLY REQUIRE OUR PRIVATE CORPORATIONS ADMITTING TO DISCRIMINATION AND IN A POST CIVIL RIGHTS UNITED STATES OF AMERICA, I'M WILLING TO BET THAT'S NOT GOING TO HAPPEN. AND THEN THIS IDEA OF A SOLUTION LOOKING FOR A PROBLEM IS QUITE UNFORTUNATE.

I CONSIDER THIS COUNCIL TO BE FULL OF SO MANY BRILLIANT PEOPLE, AND I'M REALLY HOPING THAT WE'RE NOT ONLY REACTIVE, BUT WE CAN ALSO BE PROACTIVE. SO AS OUR AIP WORKFORCE DEVELOPMENT GROUP LED BY COUNCILMAN WINKLER LED BY COUNCILMAN, PIACENTINI LOOKED TO EMPLOY 5,000 PEOPLE WHO ARE CURRENTLY UNEMPLOYED.

WELL, I REALLY HOPE THAT YOU'RE NOT WILLING TO LEAVE ANY TOOLS OF DISCRIMINATION ON THE TABLE FOR THOSE PEOPLE SEEKING EMPLOYMENT. ESPECIALLY IF WE'RE TALKING FOR SMALL BUSINESSES, WHICH I SHARE CONCERNS OF SMALL BUSINESSES LAST COMMITTEE.

AND BECAUSE OF THAT, I WENT OUT AND DID SOME HOMEWORK

AND IF YOU DIDN'T KNOW, GLI WAS CONSULTED WITH IN TERMS OF HOW WE'RE WORKING WITH BUSINESSES, BUT I DID SOME OTHER HOMEWORK AND I REACHED OUT TO JENNIFER RUBINSTEIN, THE EXECUTIVE DIRECTOR FOR LIBOR, THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE. AND SHE DID SOME INVESTIGATING ON HER OWN. SHE REACHED OUT TO HER MEMBERS, SENT MULTIPLE NOTIFICATIONS AND SHE SENT OUR ORDINANCE AND SHE ASKED IF ANYONE HAD CONCERNS, EVERYONE WHO RESPONDED SAID THAT THEY DO NOT USE THE PRACTICE

AND EVEN WENT AS FAR AS TO SAY, THEY DO NOT BELIEVE THE PRACTICE SHOULD BE USED ANYWAY.

SO THERE IS NO CONCERN AS FAR AS HOW THIS WILL IMPACT SMALL BUSINESSES.

IN FACT, THE ONES, AS I SAID, THAT RESPONDED ARE IN SUPPORT OF THIS ORDINANCE.

AND THEN LASTLY, I WOULD LIKE TO CALL ON COUNTY ATTORNEY JASON FOWLER TO SPEAK TO, UH, THE FEDERAL LEVEL OF WHAT THIS LOOKS LIKE AS WELL AS HOBSON'S CHOICE AND HOW WE CAN'T SAY THAT THIS ISN'T DISCRIMINATORY BECAUSE IT'S NOT LAW.

WHEN IN FACT THERE IS SOME PRECEDENT, AS FAR AS THIS NOT BEING USED AT THE FEDERAL LEVEL. THANK YOU.

UH.

GOOD EVENING COUNSEL, JASON FOWLER ON BEHALF OF THE COUNTY ATTORNEY, THE DEBATE IS, UM, BEEN VERY INTERESTING FOLLOW ALONG AND TRACK WITH REGARD TO, UH, THE FEDERAL LAW AND THESE CREDIT CHECKS. THE, UM, DISPARATE IMPACT THAT THE EVIDENCE IS TENDING TO SHOW IS THAT APPLICANTS WILL SELF-SELECT IN THEIR, UH, UM, INFORMATION THAT THEY'RE PROVIDING ON JOB APPLICATIONS, BECAUSE THEY ARE EXPECTING TO BE DISCRIMINATED AGAINST. THIS IS ESSENCE, UH, SOME OF DISCRIMINATION THAT WOULD QUALIFY A DISPARATE IMPACT STUDY, UH, TO FORM A BASIS FOR THIS, THIS LAW BEING A LEGITIMATE ENDED OF THIS COUNCIL'S LEGISLATIVE AUTHORITY. UM, BUT I THINK IT, IT TENDS TO CLOUD THE DEBATE. SOME, I THINK THIS BODY CAN, I THINK THAT THE PRETEXTUAL DISCRIMINATION IS DIFFICULT TO FIND AND IT'S DIFFICULT TO PROVE.

UM, BUT THAT THIS BODY IS ON SOUND LEGAL FOOTING GOING FORWARD UNDER, UM, UM, THE MISTAKES THAT ARE ROUTINELY FOUND IN CREDIT REPORTS AND HOW THOSE MISTAKES WORK, UM, AN UNFAIR DISADVANTAGE TO EVERYDAY CITIZENS AS CITIZENS AT LARGE.

SO ON, UH, JUST THAT BASIS ALONE, THAT'S A LEGITIMATE AND AN IRRATIONAL, UM, IRRATIONAL RELATED PIECE OF LEGISLATION TO THAT END.

SO, UM, THE, THE KNOCK ON EFFECTS THAT, THAT WE CAN, WE CAN DEBATE AND, AND, AND FIND REGARDING THE DISCRIMINATION ARE THERE.

UM, BUT WITH REGARD TO WHETHER, OR THIS IS A SOUND, UH, EXERCISE, INSPIRES AUTHORITY, IT IS BASED ON THAT, THAT RATIONAL.

THE ONE.

THANK YOU.

THANK YOU.

WERE YOU FINISHED?

THANK YOU, UH, COUNSEL, UH, COUNSEL ONE MCCRANEY, MR. PRESIDENT.

I DO WANT TO LET MY COLLEAGUES KNOW THAT I CONSULTED THE CHAMBER OF COMMERCE AND THE CHAMBER ALSO SENT THE ORDINANCE AROUND TO ITS MEMBERSHIP OF THE RESPONDENTS.

NO ONE HAD A PROBLEM WITH THE ORDINANCE, THE ONLY ORGANIZATIONS THAT DID WERE THE BANKS AND THE CREDIT UNIONS AND I IN THE COUNTY ATTORNEY'S OFFICE, MET WITH THEM.

AND WE TALKED ABOUT THE EXEMPTIONS THAT MUST BE MADE.

I HAD THE OPPOSITION TALK ABOUT WHY ARE THERE SO MANY EXEMPTIONS?

WELL, IF YOU LOOK AT WHAT THOSE EXEMPTIONS ARE, IT SOUNDS TO BE REASONABLE.

THOSE WHO ARE BONDED, THOSE WHO ARE DEALING WITH ON A DAILY BASIS, \$10,000 OR MORE, THOSE WHO DEAL WITH SENSITIVE CLASSIFIED INFORMATION.

SO WE MADE THOSE EXEMPTIONS BASED OFF OF THE KNOWLEDGE THAT WE GAINED THROUGH THE RESEARCH THAT WE DID.

THAT'S WHY THOSE ARE THERE.

AND AS COUNCILMAN ARTHUR TALKED ABOUT SPEAKING WITH THE BUSINESS ALLIANCE, I TOO HAD HAD A CONVERSATION WITH JENNIFER.

THE SAME EXACT INFORMATION WAS GIVEN TO ME AS FAR AS THE SMALL BUSINESSES AND THEIR SUPPORT OF THIS ORDINANCE AND THE, THE RESEARCH THAT I DID ON SMALL BUSINESSES, YIELDED INFORMATION THAT STATED THEY DON'T USE THIS AS A TOOL BECAUSE THEY CAN'T EVEN AFFORD TO USE IT IF THEY WANT IT TO USE IT.

SO IT DOES NOT HURT SMALL BUSINESSES AT ALL. AND IF THE ARGUMENT IS ABOUT BEHAVIOR, WHICH I HEARD EARLIER, LET ME SAY AGAIN, THAT CREDIT CHECKS WERE NOT INVENTED FOR US TO USE THEM AS CHARACTER WITNESSES, CHINA CREDIT CHECKS WERE CREATED SO THAT FINANCIAL INSTITUTIONS CAN LOOK AT CREDIT WORTHINESS.

THERE IS NO.

AND I SAY AGAIN. NO CORRELATION BETWEEN

SOMEONE'S ABILITY TO BE A GREAT EMPLOYEE AND THE FACT THAT THEY MIGHT HAVE SOME SCARS ON THEIR CREDIT REPORTS.

SO BEHAVIOR CANNOT BE A PART OF THIS ARGUMENT BECAUSE THE STUDIES HAVE SHOWN THERE'S NO CORRELATION.

AND EVEN THE PERSON WITH THE BEST OF CREDIT RATINGS COULD BE A SCAM ARTISTS TO BE A FEE, TO BE A POOR WORKER.

SO I DISPELLED THE BEHAVIOR BECAUSE THE EVIDENCE IN THE RESEARCH HAS SHOWN THERE'S NO CORRELATION BETWEEN YOUR CREDIT RATING AND YOUR ABILITY TO BE A GREAT EMPLOYEE. THANK YOU.

THANK YOU, COUNCILWOMAN AND COUNCIL ON THE PURPOSE.

THANK YOU, MR. PRESIDENT.

UM, I JUST WANT TO SAY A FEW THINGS.

UH, I'VE LISTENED TO BOTH SIDES OF THE ARGUMENT AND, UM, I AGREE WITH COUNCILMAN, HOW UNDER AND COUNCILMAN AUTHOR.

UH, AND I DO WANT TO POINT OUT THAT I DON'T THINK THIS IS BASED ON BEHAVIORS.

IT'S COUNCILWOMAN MCCRANEY IS JUST POINTED OUT. UM, I FEEL LIKE WHEN YOU, UM, FRAME IT THAT WAY, I FEEL LIKE YOU'RE IN THE JUDGMENT MODE AND I DON'T THINK ANY OF US HAVE THE RIGHT TO DO THAT. WE DON'T KNOW ANY EVERYONE'S CIRCUMSTANCES AS TO WHY THEY'RE IN THE PREDICAMENT THAT THEY ARE IN.

SO I DON'T CONSIDER THIS AS A SOLUTION LOOKING FOR A PROBLEM, BUT I CONSIDER THIS TO BE, UH, FOR ACTIVE TAKING THE STEPS AS COUNCILMAN OFFICE SAID TO REMOVE ANY TOOLS TO DISCRIMINATE.

AND THIS WOULD NOT ONLY BE DISCRIMINATION AGAINST ANYONE BASED ON RACE FOR MORE OR LESS, UH, IT WOULD BE DISCRIMINATING AGAINST THOSE THAT ARE ALREADY POOR.

SO I SUPPORT THIS AND I WOULD LOVE TO BE EDITED AS A CO-SPONSOR.

THANK YOU.

THANK YOU, COUNCILMAN COUNCILMAN FLOOD. MR.

PRESIDENT, I HAVE A QUESTION FOR THE COUNTY ATTORNEY, UM, MR. FOWLER, IS THERE ANY LAWS ON THE BOOK NOW ON THE BOOKS NOW THAT SAYS THAT IF, UM,

YOU'RE TURNED DOWN, IF YOU, IF, UH, AN EMPLOYER IS GOING TO TURN YOU DOWN FOR A JOB THAT YOU HAVE TO BE NOTIFIED THAT IT'S DUE TO YOUR CREDIT REPORT, AND YOU HAVE SO MANY DAYS TO REPAIR THAT, YOU KNOW, TO EXPLAIN THE, EXPLAIN THE RED FLAGS TO THE EMPLOYER AND TO, UM, GETTING THING THAT'S FIXED, FIX ANYTHING THAT'S DEROGATORY ON YOUR CREDIT REPORT. THANK YOU FOR THE QUESTION, COUNCILWOMAN FOR THE TRUTH AND MUNDANE ACT REQUIRES THAT IF, AND, AND SLOWLY, UH, AN EMPLOYER RATHER USES A CREDIT, UH, REPORT AND ITS DECISION THAT THE EMPLOYEE MUST FIRST BE NOTIFIED.

AND THEN IF IT TAKES AN ADVERSE EMPLOYMENT DECISION, BASED ON THAT REPORT, UM, THE EMPLOYEE HAS TO BE, HAS TO RECEIVE NOTIFICATION THAT IT WAS, UH, AN ADVERSE EMPLOYMENT ACTION WITH REGARD TO THE CREDIT REPORT.

SO THEY HAVE TO AGREE IN WRITING, AND THEN IF THEY DON'T GET THE JOB BECAUSE OF THE CREDIT REPORT, THEY HAVE TO BE INFORMED OF THAT.

BUT THERE IS NOT, UM, IN MY READING OF THAT LAW AND A REQUIREMENT OR AN OPPORTUNITY FOR THEM TO REPAIR THAT.

AND CERTAINLY, UM, UM, IT, I'M NOT AN EMPLOYMENT LAWYER AND THERE'S A LOT OF OTHER LAWS THAT WOULD COME INTO PLAY WITH REGARD TO THAT EMPLOYMENT RELATIONSHIP.

SO THEY DON'T HAVE TO NOTIFY YOU PRIOR TO THE DECISION.

CAUSE THE WAY I READ IT, IT SAYS THAT YOU HAD TO, THEY HAD TO NOTIFY YOU PRIOR TO THE, TO THE DECISION SO THAT YOU CAN ANSWER RED FLAGS AND REPAIR THAT,

UM, COUNCILMAN FLOOD.

I CAN DOUBLE CHECK THAT FOR YOU BECAUSE IT HAS BEEN SOME TIME SINCE I'VE READ THAT PROVISION. UM, MY MEMORY IS THAT THEY HAD TO HAVE WRITTEN INFORMED CONSENT, UH, AND THAT THEY BE NOTIFIED IF THERE WAS AN ADVERSE ACTION TAKEN BECAUSE OF THE DEPLOYMENT AT THE EMPLOYEES' CREDIT. OKAY.

THANK YOU.

YES MA'AM.

THANK YOU, COUNCILMAN COUNCILMAN FOX.
THANK YOU, MR. PRESIDENT, UH, I'LL BE VOTING AGAINST
THIS AND I'LL, I'LL TELL YOU WHY I'VE LED

INVESTIGATORS THAT DID BACKGROUND INVESTIGATIONS, UH, FOR POLICE OFFICERS, FOR CORRECTIONS OFFICERS AND FOR SENSITIVE POSITIONS WITHIN THIS GOVERNMENT.

AND WHEN YOU GET THE CREDIT REPORT BACK, IT GENERALLY LEADS TO A CONVERSATION IN THE INTERVIEW, UH, WHERE, WHEN THE DEBT IS MEDICAL, UH, IS EASILY EXPLAINED AND, AND UNDERSTOOD. I MEAN, EVERYBODY UNDERSTANDS THE HIGH COST OF, UH, OF MEDICAL PROCEDURE.

IF YOU HAVE TO HAVE IT DONE A STUDENT LOAN, SAME WAY, THAT COMES UP A LOT IN A LOT OF CONVERSATIONS, IT'S PRETTY EASILY EXPLAINED A LARGE PERCENT OF THE AMERICAN POPULATION HAS STUDENT LOANS MOST COMMONLY THE REASON FOR BAD CREDITS DIVORCE. AND THAT'S EXPLAINED TO, UH, WHEN, SO THESE THINGS GIVE YOU THE TOOLS.

AND IT'S KIND OF INTERESTING TO ME THAT WE MADE CARVE-OUTS FOR GOVERNMENT.

WE MADE CARVE-OUTS FOR, UH, SPECIFIC OCCUPATIONS, BUT WE'RE PUTTING OUR POOR GUY THAT RUNS A PLUMBING COMPANY.

WHO'S GOING TO LET ONE OF THESE PEOPLE, HE HIRES GO INTO A CUSTOMER'S HOME AND, AND DO WORK, OPERATE A COMPANY VEHICLE.

UH, THERE IS A LARGE LEVEL OF TRUST THERE, AND I THINK A CREDIT CHECK, UH, GIVES AN OPPORTUNITY TO LOOK INTO THE WINDOW OF THAT PERSON'S WORD AND HOW THEY'VE DELIVERED UPON THEIR WORD.

IF THERE ARE THINGS BEYOND SOMEONE'S CONTROL, LIKE YOUR EX-SPOUSE RAN UP, UH, UH, THE CREDIT CARDS BUYING A BOAT RIGHT BEFORE YOU GOT DIVORCED, THAT'S PRETTY, THAT'S SOMETHING EVERYONE CAN UNDERSTAND, BUT I THINK THIS IS AN OVERREACH OF GOVERNMENT, UH, TELLING OUR SMALL BUSINESS OPERATORS, BECAUSE AS ONE OF MY COLLEAGUES MENTIONED IN AN EARLIER, UH, STATEMENT, THAT'S WHO IT MOST GENERALLY IMPACTS.

I THINK IT'S AN OVERREACH OF GOVERNMENT, UH, TO TELL THEM WHAT THEY CAN AND THEY CAN'T DO WHEN THEY'RE GOING TO HIRE SOMEONE, PAY THEM AND TRUST THEM, UH, WITH THEIR EQUIPMENT, WITH THEIR VEHICLES, TRUSTING THEM AGAIN, TO GO INTO THE OFFICES AND THE HOMES OF THEIR CLIENTS.

UH, AND I JUST DON'T FEEL IT'S, UH, SOMETHING WE NEED TO BE DOING TO TELL THEM, UH, TELL THEM NOT TO

DO THAT.

ANOTHER COLLEAGUE MENTIONED THAT CREDIT WAS NOT INTENDED TO BE USED AS A CHARACTER REFERENCE. AND, AND I BELIEVE THAT TO BE TRUE, BUT CHARACTER STILL MATTERS.

CHARACTER STILL MATTERS.

AND IF YOU'RE RUNNING A BUSINESS, I THINK YOU SHOULD HAVE THE RIGHT TO MAKE SURE THAT THE PERSON YOU'RE HIRING HAS THE SAME CHARACTER THAT YOU DO IN RUNNING YOUR BUSINESS.

BECAUSE GOVERNMENT SURE.

LOOKING OVER THE SHOULDER, THAT BUSINESS OWNER TO MAKE SURE THEY HAVE CHARACTER AND THEY'RE PAYING THEIR FINES, THEIR FEES, AND THEY'RE GETTING THEIR LICENSING.

I MEAN, IT'S PART OF THE LICENSING PROCESS.

AND, AND SOMETIMES THESE THINGS ARE INVOLVED IN THAT AS WELL.

SO I'LL BE A NO VOTE.

AND THAT'S THE REASON.

THANK YOU, MR. PRESIDENT.

THANK YOU.

CAN YOU COUNT, SPEND COUNSELING AND RECLAIMING? THANK YOU, MR. [INAUDIBLE].

I WOULD LIKE TO REMIND MY COLLEAGUES THAT YES, CHARACTER MATTERS, BUT THERE IS NO CORRELATION BETWEEN A BAD CREDIT RATING OR A BAD SCORE AND, UH. ANYBODY'S JOB PERFORMANCE.

AND I ALSO WANT TO REMIND YOU THAT IN THE ORDINANCE I MENTIONED, THERE ARE SOME EXCEPTIONS AND THOSE EXEMPTIONS LOOK TO THOSE WHOLE MUST BE BONDED. I'M GOING TO HOPE THAT MY PLUMBER WOULD NOT SEND SOMEONE INTO MY HOME THAT IS NOT BONDED. SO THAT ARGUMENT IS NOT A PART OF WHAT WE'RE TALKING

AND I WILL ALSO REMIND EVERYBODY THAT IT IS OUR JOB AS LAWMAKERS TO MAKE SURE WE'RE TAKING CARE OF THE LEAST, THE LOST AND THE OFTEN LEFT BEHIND, BECAUSE THOSE ARE THE ONES THAT NEED OUR HELP. THE MOST, WE ARE TRYING TO BE PROACTIVE HERE. WE'RE TRYING TO SET ASIDE AN OPPORTUNITY FOR THOSE

WE'RE TRYING TO SET ASIDE AN OPPORTUNITY FOR THOSE WHO CANNOT SPEAK FOR THEMSELVES TO NOT HAVE THAT BARRIER BEFORE THEM.

HERE'S THE DEAL.

ABOUT HERE TODAY.

EMPLOYERS LOOK AT THE CREDIT AND IF THE ARGUMENT IS THE CREDIT MATTERS AND THE JUDGMENT MATTERS, AND

IT'S EASY TO EXPLAIN YOUR CREDIT RATING, BUT WHAT IS THE OPPORTUNITY TO EXPLAIN IT?

BECAUSE IF THE EMPLOYER IS FREE TO PULL YOUR CREDIT, ASSESS YOUR CREDIT, AND THEN SAY NO TO YOUR APPLICATION, THEY'RE NOT CALLING YOU BACK AND SAYING, HEY, BY THE WAY, CAN YOU EXPLAIN THIS? YOU'RE LOOKING GOOD ON YOUR APPLICATION THAT DOESN'T NORMALLY HAPPEN, ESPECIALLY TO MINORITIES AND WOMEN.

IT JUST DOESN'T HAPPEN.

WHAT WILL HAPPEN IS THEY PULL THE CREDIT.

THEY LOOKED AT THE SCORE, THEY LOOK AT WHAT IS PRESENTED BEFORE THEM, AND THEY THROW THAT OUT TO PATIENT, TO THE SIDE.

THEY GO ON TO THE NEXT.

IT WOULD BE WONDERFUL IF THEY WOULD LOOK AT IT AND CALL UP JANE DOE OR JOHN DOE AND SAY, I SEE A FEW FLAWS ON YOUR CREDIT REPORT.

CAN YOU EXPLAIN?

I'D LIKE TO HIRE YOU, UNFORTUNATELY, THAT DOES NOT HAPPEN.

SO I'M ASKING AGAIN FOR MY COLLEAGUES TO CONSIDER WHAT WE'RE PRESENTING HERE TODAY AND HOW WE HAVE MADE THESE PROFOUND EXCEPTIONS, BECAUSE WE KNOW AND UNDERSTAND WHAT NEEDS TO BE DONE IN ORDER TO PROTECT THE SMALL, BUT ALSO THE BUSINESSES, ESPECIALLY THE SMALL BUSINESSES, WHICH BY THE WAY, AGAIN, WE'VE DONE MANY, MANY, MANY PHONE CALLS AND A LOT OF RESEARCH AND SMALL BUSINESSES DON'T NECESSARILY USE THIS AS A TOOL OR EMPLOYMENT DECISIONS.

I JUST WANT TO GO A STEP FURTHER AND SAY THAT AS A FORMER BUSINESS OWNER, I WAS HEAVILY BONDED. HEAVILY INSURED TO DO BUSINESS HERE IN THE CITY OF LOUISVILLE.

AS YOU ALL MAY BE AWARE THAT I PROVIDE A COMMERCIAL CLEANING SERVICES WITH SEVERAL BUILDINGS IN THIS CITY, BUILDINGS THAT A LOT OF YOU ALL HAVE GONE INTO.

AND I THINK THAT THAT IF I HAD USED THAT TYPE OF PRACTICE. THESE BUILDINGS WOULD NOT HAVE EVER BEEN

IF I HAD SAID, WELL, YOU KNOW, YOU CAN'T CLEAN THE

LOCAL WATER COMPANY BECAUSE YOUR CREDIT SCORE IS ONLY FOUR 50.

AND SO I'M, I'M THANKFUL, BUT YOU KNOW, I, I WAS AN EMPLOYEE THAT DID NOT ENGAGE IN SUCH PRACTICE, BUT I, I REALLY THINK, UM, THIS IS, UH, THIS IS REALLY BEATING UP ON PEOPLE'S CHARACTER. AND I JUST, I THINK WE NEED TO MOVE FORWARD AND VOTING FOR THIS, UH, AS COUNCILMEN AUTHOR SAID TO

ERASE OR TO GET RID OF THIS TOOL OF

DISCRIMINATION.

SO I'M DONE WITH IT.

I JUST WANTED TO, UH, MAKE THAT ADDITIONAL COMMENT. THANK YOU.

THANK

I THINK I JUST WANTED TO REMIND MY COLLEAGUES. AS WE'VE SAID, WE HAVE WORKED DIRECTLY WITH LIBA AND DIRECTLY WITH GLI LIBA HAS OVER 1300 MEMBERS. GLI HAS OVER 1800 MEMBERS.

WE'VE WORKED DIRECTLY WITH THE PEOPLE WHO HAVE EXPERIENCED AND THE EXPERTISE TO CONSULT WITH US AS IT PERTAINS TO SMALL BUSINESS.

SO WHILE I APPRECIATE THE OPINIONS OF SOME OF OUR COLLEAGUES, WE HAVE WORKED WITH THE EXPERTS AND THEY HAVE SAID, AND MADE IT VERY PLAIN.

THIS WILL NOT HURT SMALL BUSINESSES.

THANK YOU.

ALRIGHT.

THANK YOU, COUNCILMAN COUNSELING, BLACKWELL. THANK YOU, MR. PRESIDENT.

I JUST, JUST A COUPLE OF THINGS I'M STILL CONFUSED ABOUT IS SO IF WE, IF WE MAKE THE ARGUMENT THAT THERE'S NO CORRELATION BETWEEN THE CREDIT RATING AND, UM, AND BEING A GREAT EMPLOYEE, WHICH IS WHAT I HEARD, UM, THEN THAT, THAT DOES MAKE ME CONFUSED ABOUT THE EXEMPTIONS.

THEN IF WE, WE, CAUSE WE'RE MAKING EXEMPTIONS FOR BANKS.

AND SO I HAVE, UH, SEVERAL AREN'T THOSE BEING MADE UNDER THE ASSUMPTION THAT THE CREDIT RATING REALLY DOES MAKE A DIFFERENCE IN TERMS OF GOOD EMPLOYEE. WOULD THAT BE A QUESTION TO ONE OF THE SPONSORS, THE QUESTION TO THE CHAIR AND YOU CAN DIRECT IT WHEREVER YOU WANT.

COUNSELING, COUNSELING, UKRAINE. YES.

THANK YOU.

THANK YOU, COUNCILMAN BLACKWELL FOR ASKING THAT QUESTION BECAUSE IT'S IMPORTANT.

AND WHEN YOU TO GET THAT UNDERSTANDING, I REALLY WANT YOU TO KNOW, AS FAR AS THE BANKING INDUSTRY IS CONCERNED, THERE IS A LAW THAT, UH, REQUIRES THEM TO DO, UH, THE CREDIT CHECKS AND THOSE OTHER EXEMPTIONS.

YOU WILL NOTE ALL THE INVESTIGATORY, UM, LAW ENFORCEMENT AGENCIES AND THOSE THAT AGAIN, UH, THAT DEAL WITH, UH, FINANCIAL MONEY OVER A CERTAIN AMOUNT.

BUT I WANT TO ASK, UH, THE COUNTY ATTORNEY'S OFFICE, JASON, TO EXPLAIN PARTICULARLY THE POINT ABOUT THE FINANCIAL INSTITUTIONS AND WHY THAT'S AN EXEMPTION.

AND AGAIN, KEEP IN MIND CREDIT CHECKS ARE CREDIT WORTHINESS, NOT JUDGING SOMEONE'S BEHAVIOR ON THE JOB AND ASSESSING WHETHER OR NOT THEIR CHARACTER IS GOOD ENOUGH PEOPLE WITH GREAT CREDIT CAN BE GOOD MODELS, BUT IT'S NOT WHERE THE CREDIT REPORT SHOULD REALLY BE ABOUT IT.

SHOULDN'T REALLY BE ABOUT CREDIT. WASN'T IT.

SO, JASON, IF YOU COULD PLEASE EXPLAIN WHAT WE HAVE LEARNED AS FAR AS THE BANKING INDUSTRY IS CONCERNED IN THOSE EXEMPTIONS.

CERTAINLY THANK YOU, COUNCIL WOMAN, THE SAFE ACT REQUIRES, UH, MORTGAGE ORIGINATORS TO COMPLY WITH CERTAIN FEDERAL REGULATIONS.

AND IN, UH, DOING THAT, YOU KNOW, BANKS ARE GIVEN MORE LATITUDE TO INVESTIGATE INDIVIDUALS BECAUSE THEY ARE, UH, TAKING ON MORE SORT OF FIDUCIARY ROLES WITHIN THE, THE FINANCIAL SYSTEM. UM, AND THE OTHER REASONS AROUND, UM, INVESTIGATORS AND THINGS OF THAT NATURE.

IT'S A, IT'S A USEFUL TOOL THAT IT PROVIDES A LOT OF INFORMATION.

UM, AND SO WHAT LEGISLATORS SUCH AS YOURSELVES HAVE DONE AS YOU'VE DEBATED OVER WHAT EXEMPTION SHOULD BE MADE AND TO WHOM THEY SHOULD APPLY, UH, FEDERAL LAW GUIDES ASSUME THAT, UM, YOU KNOW, UM, THE BANKS ASK THAT THESE EXEMPTIONS BE INCLUDED.

UH, WE DIDN'T WANT TO INCLUDE THEM, BUT, UM, I
BELIEVE, UH, BID THAT CHAIRWOMAN MCCARTNEY AND
OTHER LEGISLATORS, UH, WERE, WERE INCREDIBLY, UM,
UM, UH, ENGAGING WITH COMPROMISE AND REACHING
OUT TO THEIR PARTNERS AND DID A WONDERFUL JOB IN
SHAPING LEGISLATION THAT WOULD, UH, BRING ON, UH,
ON BOARD, UH, BUSINESSES THAT HAD CONCERNS.
AND THESE, UH, LEGITIMATE CONCERNS ARE THE ONES THAT
OTHER LEGISLATORS PREVIOUS TO YOU, UH, HAVE ADDRESSED
AND FOUND, UM, USEFUL WITH THE EXEMPTIONS AS THEY'RE
WRITTEN, RIGHT?

SO GUIDED BY, UH, FEDERAL LAW, OTHERS BY, UM, UH, INDUSTRY AND MOSTLY BY THE WISDOM OF THE BODY PASSING THE LOSS.

THANK YOU.

SO

MR.

PRESIDENT SOMETIMES FOLLOW UP.

SO I UNDERSTAND, I UNDERSTAND FEDERAL LAW AND IT'S LIKE STEPS IN THAT IT'S GENERALLY MORE IMPORTANT THAN OURS.

UM, HOWEVER, ARE THOSE FEDERAL LAWS AND THOSE EXEMPTIONS STILL MY QUESTION, ISN'T WHY WE NEED TO PUT THEM IN BECAUSE THE FEDERAL LAW, BUT AREN'T THEY SAYING ABOUT THOSE EXEMPTIONS? ISN'T THE FEDERAL WALL SAYING SOME THINGS RISE TO THE LEVEL THAT WE NEED TO BE ABLE TO USE EVERYTHING THAT WE CAN TO DETERMINE IF THE PERSON'S GOING TO BE A GOOD EMPLOYEE AND IT'S GOING TO BE AN HONEST EMPLOYMENT, WHATEVER IT IS THAT YOU, HOWEVER YOU WANT TO CALL IT.

AND THE BANKING IS ONE OF THE, THE, UH, INVESTIGATIVE POWERS IS ANOTHER.

AND WHAT THEY'RE STILL MAKING, WHETHER THE, THE STUDY SHOWED OR NOT, THEY ARE STILL IN THOSE INSTANCES, MAKING THE CONNECTION BETWEEN THIS CREDIT RATING SCORE AND GOOD EMPLOYMENT. CORRECT.

I MEAN, ISN'T THAT CORRECT?

I MEAN, WHAT OTHER BASIS WOULD THEY HAVE FOR IT THEN

I WOULD ASK ANY OF THE SPONSORS TO RESPOND TO COUNSELING BLACKWELL.

I DON'T THINK HIS QUESTION HAS BEEN SATISFIED. WELL, I THINK IT'S BASICALLY DEALING WITH MONEY AGAIN.

THAT'S WHAT CREDIT REPORTS ARE REALLY MEANT FOR RIGHT.

TO LOOK AT THE CREDIT WORTHINESS.

SO A LOT OF THE EXEMPTIONS WERE BASICALLY ABOUT CREDIT WORTHINESS, NOT SO MUCH WHETHER OR NOT THIS COULD BE A GOOD, UH, AN HONEST EMPLOYEE.

IT'S ABOUT THOSE ENTITIES THAT HAVE TO DEAL WITH SENSITIVE INFORMATION AND MONEY.

AND IT IS BASED ON THE CREDIT WORTHINESS OF THESE FOLKS.

THANK YOU, COUNCILMAN, COUNCILMAN BLACKWELL. UH, I DO HAVE ONE OTHER, SO IF, UM, AND THEN THE OTHER THING, THE OTHER PART I'M CONFUSED TO US, AND ONE OF THE SPONSORS CAN HELP ME WITH, SO FOR SAYING THAT SMALL BUSINESSES WON'T BE AFFECTED AND WE'RE MAKING EXEMPTIONS FOR THE LARGE BUSINESSES.

AND WE'RE SAYING, SO I GUESS I'M CONFUSED ABOUT TO WHAT COUNSEL ON PIACENTINI WAS SAYING IS SO WHO, IF YOU'RE EXEMPTING SMALL AND WALTERS, WHO IS IT THAT WE'RE SAYING IS ACTUALLY USING THESE PRACTICES.

BUT WE'RE NOT EXEMPTING.

EVEN THE BANKS CANNOT DISCRIMINATE USING THE SCRAP.

IT'S ONLY THOSE WHO ARE BONDED.

THOSE WHO ARE DEALING WITH MONEY, IF THEY'RE HIRING SOMEONE THAT DEALS WITH \$10,000 MORE, I, YEAH. IF MY SON GOES INTO A BANK TO MAKE AN APPLICATION TO WORK, YOU KNOW, AS A JANITOR OR AS, UH, YOU KNOW, UH, CUSTOMER SERVICE REPRESENTATIVE, THEY, THE BANK CANNOT USE THAT CREDIT REPORT TO JUDGE HIS CHARACTER RIGHT NOW, IF HE GETS EMPLOYED AS A STOCK BROKER, THEY HAVE EVERY RIGHT TO LOOK AT HIS CREDIT.

CAUSE HE'S GOING TO BE DEALING WITH SENSITIVE INFORMATION AND MONEY.

THANK YOU.

BUT THEY'RE NOT EXEMPT TOTALLY FROM THE ORDINARY CITIZENS THAT WE'RE TRYING TO HELP.

SO THEN, UH, SO THE EXEMPTION BIN THAT WE REALLY ARE TRYING TO ESTABLISH AS SOMEBODY WHO'S GOING TO HAVE IN WHATEVER BUSINESS ARE, IN FACT, THE COUNSELOR, IN FOX'S EXAMPLE, WHO'S GOING TO HAVE FIDUCIARY RESPONSIBILITY INSIDE OF BUSINESS, RIGHT?

I MEAN, ISN'T THAT THE EXEMPTION THAT WE'RE TRYING TO MAKE

COUNCILMAN MCQUAIN, I'M NOT, I DON'T, I'M SORRY.
COULD YOU ASK THE QUESTION AGAIN?
IT JUST SEEMS TO ME THAT THE EXEMPTION THAT WE'RE
REALLY TRYING TO MAKE, THEN ISN'T, WHETHER IT'S,
IT'S NOT ABOUT BANKING OR ABOUT A PLUMBING COMPANY
OR WHATEVER, IT'S THE EXEMPTION THAT AS, AS YOU
JUST GAVE THE EXAMPLE WHERE, YOU KNOW, A BANK
EMPLOYEE, THAT'S NOT GOING TO BE RESPONSIBLE FOR
MONEY IS EXEMPT, BUT SOMEBODY WHO'S GOING TO BE
RESPONSIBLE FOR THE MONEY IS NOT EXEMPT OR THE OTHER
WAY AROUND.

UM, IT SEEMS TO ME THAT THE EXEMPTION THAT WE'RE TRYING TO MAKE IS IF YOU'VE GOT A BUSINESS AND THAT BUSINESS IS EMPLOYING SOMEBODY TO DO TASKS OR, OR, OR DOING LABOR THAT ISN'T, THAT DOESN'T INVOLVE ANY FIDUCIARY RESPONSIBILITY, THEN, THEN WE WOULD, THEN WE WOULD ALLOW, I MEAN, WE WOULDN'T ALLOW THE CREDIT SCORE TO APPLY TO THEM, BUT SOMEBODY WHO HAS, I DON'T KNOW WHAT THE DIFFERENCE IS BETWEEN SOMEBODY WHO IS IN A BANK OR A CREDIT UNION WHO HAS FIDUCIARY RESPONSIBILITY, HOW BAD IS DIFFERENT FROM SOMEBODY WHO IS IN A PLUMBING COMPANY OR A, OR WHATEVER, WHO HAS GOT THE RESPONSIBILITY OF, OF MONEY OVER THAT SAME LEVEL THAT YOU JUST TALKED ABOUT AGAIN.

AND I WILL ASK JASON TO BE VERY CLEAR IN HIS RESPONSE AND HOW THE BANKS ARE EXEMPTED FROM FEDERAL LAW.

NO LIE.

OKAY.

ALL I CAN TELL YOU IS STUDIES HAVE SHOWN THAT PEOPLE ARE NOT GETTING HIRED BECAUSE OF CREDIT SCORES AND TO USE CREDIT REPORTS AS AN INDICATOR OF CHARACTER IS SO UNFAIR BECAUSE THERE IS NO CORRELATION THAT WE HAVE BEEN ABLE TO FIND IN OUR STUDIES THAT SHOW THAT IF YOU HAVE A BAD CREDIT RATING, OR IF YOUR CREDIT REPORT IS FLAWED, THAT YOU ARE GOING TO BE A BAD EMPLOYEE.

NOW, I COULD ONLY HOPE BECAUSE THERE'S NO

NOW, I COULD ONLY HOPE BECAUSE THERE'S NO REPORTING REQUIREMENT THAT SAYS TO THESE COMPANIES, THEY MUST REPORT EVERY TIME THEY DON'T HIRE SOMEONE BASED ON THEIR CREDIT. THERE'S NO, THERE'S NO STANDARD THERE.

SO WE DON'T KNOW HOW MANY TIMES THIS HAS OCCURRED. BUT WHAT WE DO KNOW IS THAT IT OCCURS AND THAT SO MANY PEOPLE IN A FIELD OF STUDIES HAVE INDICATED THAT THEY'D BEEN TOLD THAT THEY WILL NOT HIRE BECAUSE OF THEIR CREDIT RATING.

AND I WISH THAT I COULD TRUST THAT COMPANIES WOULD NOT USE PEOPLE'S CREDIT REPORT AS A CHARACTER WITNESS, BUT THAT IS NOT SOMETHING THAT I CAN EMBRACE AND TRUST BECAUSE I KNOW IT HAPPENS. AND THAT'S WHAT WE'RE TRYING TO, UH, THAT'S, THAT'S REALLY WHAT WE'RE TRYING TO DEFEAT HERE. UH, AN OPPORTUNITY FOR SOMEONE TO USE JUST SOME OTHER MEASURE OF DISCRIMINATION AGAINST THE PEOPLE WHO NORMALLY DON'T GET AN OPPORTUNITY. THE PEOPLE WHO KNOW SOMEBODY WHO KNOWS SOMEBODY WHO KNOWS, SOMEBODY CAN HAVE THE BEST OF CREDIT AND STILL BE THE WORST OF EMPLOYEES. BECAUSE THEY KNEW SOMEBODY THAT GOT INTO THAT JOB. BUT IF YOU HAVE A BAD CREDIT RATING, YOU DON'T KNOW ANYBODY NOBODY'S LOOKING OUT FOR YOU. YOU MAY NOT EVER GET AN OPPORTUNITY TO APPLY AGAIN FOR THAT JOB OR TO GET THAT PARTICULAR JOB YOU WILL NEVER KNOW.

BUT WHAT WE DO KNOW IS STUDIES HAVE SHOWN THAT THE CREDIT REPORT HAS BEEN USED AGAINST PEOPLE AND THEY'VE BEEN MISSING OUT ON SOME GREAT EMPLOYEES. THANK YOU, COUNCILMAN COUNCILMAN, DR. ROCKWELL, I WOULD SAY, I THINK THAT'S THE BEST ANSWER THAT YOU'RE GOING TO GET.

OKAY.

ALL RIGHT.

THANK YOU.

UH, COUNSELING AKERSON.

THANK YOU, MR. PRESIDENT COLLEAGUES, I MAKE A GREAT LIVING DEALING WITH DISCRIMINATION, TITLE SEVEN, AND THE KENTUCKY VERSION IS A KRS 3 45. UH, THERE ARE 44 CARES, 3 44 DEALING WITH

DISCRIMINATION.

AND WHEN WE TALK ABOUT DISCRIMINATION, DISCRIMINATION BOILS DOWN TO PROTECTED STATUSES. YOU CAN'T DISCRIMINATE BASED UPON SOMEONE'S RACE, THEIR RELIGION, THEIR GENDER, THEIR NATIONAL ORIGIN, OR THEIR AGE.

YOU CAN'T NOT HIRE SOMEONE JUST BECAUSE THEY'RE BLACK OR HISPANIC.

YOU CAN'T HIRE, NOT HIRE SOMEONE OR TAKE ADVERSE

ACTION AGAINST THEM BECAUSE THEY'RE JEWISH OR JEHOVAH WITNESS, OR BECAUSE THEY'RE OVER THE AGE OF 55, THOSE ARE DISCRIMINATIONS AND THEIR STATUSES WITHOUT REGARD TO ANYTHING ELSE IN LIFE. AND THAT'S WHAT DISCRIMINATION LAWS ARE MEANT TO PROTECT AGAINST.

WHEN I HEAR DISCRIMINATION BASED UPON CREDIT, YOU KNOW, I'VE GOT REAL CONCERNS HERE ABOUT THE PASTEURIZATION OF, OF WHAT WE'RE TRYING TO DO. BAD BUSINESS DECISIONS ARE NOT ILLEGAL. SO WHEN I HEAR THERE'S LOTS OF GOOD PEOPLE OUT THERE THAT COULD BE HIRED THAT HAVE BAD CREDIT AND A BUSINESS MADE A BAD BUSINESS DECISION TO MISS OUT ON THAT EMPLOYEE, SHAME ON THEM, SHAME ON THEM

AND IN FACT, BUSINESS DECISIONS CONSTANTLY SHIFT.

I'VE HEARD OF, UH, YOU KNOW, I THINK IN METRO GOVERNMENT WAS THAT YOU COULDN'T HAVE USED MARIJUANA WITHIN FIVE YEARS, AND NOW IT'S DOWN TO LIKE TWO OR THREE YEARS TO GET HIRED. THIS IS DECISIONS THAT FLUCTUATE BASED UPON THE NEEDS, THE NEED FOR EMPLOYMENT, THE NEED FOR EMPLOYEES.

I FIRST TALKED TONIGHT THAT THERE IS NO CONNECTION BETWEEN YOUR, YOUR CREDIT SCORE AND HOW GOOD OR HOW BAD A WORK YOU'LL BE.

AND I WOULD ACKNOWLEDGE THAT ALSO, BUT IF THAT'S THE CASE, THE BUSINESSES THAT ARE STUPID, STUPID ENOUGH TO USE A CREDIT SCORE TO MISS THAT UP IN A POLICE, THAT'S THEIR FAULT.

THAT'S THEIR FAULT.

IT'S A BAD BUSINESS DECISION, BUT NOTHING ILLEGAL ABOUT IT, NO MARKET MARKETING, OUR WAGES ARE GOING UP THIS BODY.

WE TRY TO ADVOCATE FOR \$15 AN HOUR.

YOU KNOW, WE HAD SOME TROUBLE WITH THE SUPREME COURT, SORT OF KNOCKED US DOWN ON THAT AS WE WERE MOVING TOWARDS, UH, INCREASES.

BUT THE GREATEST THING ABOUT THAT, AND I BOUGHT IT FOR THOSE, THOSE THAT, THAT MINIMUM WAGE INCREASE.

I BELIEVE THAT THE MARKET HAS ACTUALLY CORRECTED IT. HELL YOU COULD MAKE \$20 AN HOUR TO MCDONALD'S TODAY WHO WOULD HAVE THOUGHT THAT, YOU KNOW, UH, COSTCO ENTERED, ENTERED TWO WAGES, \$17.

SO AT THE END OF THE DAY, MY CONCERN HERE IS, IS, YOU KNOW, WE SAY IT DOESN'T AFFECT SMALL BUSINESSES.

IF IT DOESN'T EXPECT SMALL BUSINESSES AND IT'S LARGE BUSINESSES THAT ARE MAKING THIS STUPID DECISION, I COME BACK TO STUPID DECISION AND SHAME ON THEM.

THEN THEY'RE MISSING OUT ON THOSE EMPLOYEES. I JUST DON'T SEE WHERE IT'S OUR JOB TO TRY TO REGULATE THIS ISSUE.

A LOT OF PEOPLE LOOK AT MY BOAT, SHE'D SAY ACKERSON IS A PRETTY LIBERAL GUY.

UH, BUT AT THE SAME TIME, MAYBE NOT AS LIBERAL AS SOME IN THIS ROOM, BUT AT THE SAME TIME, THIS IS NOT A FIGHT THAT I THINK THAT WE SHOULD BE FIGHTING. UH, I RESPECT MY COLLEAGUES WHO WERE AT PERSONAL LEGISLATION, BUT I WILL BE A NOVO TONIGHT BECAUSE THIS IS NOT ONE OF THOSE AREAS OF DISCRIMINATION THAT I THINK IT'S OUR JOB TO RIDE TO.

CORRECT.

UH, I HOPE THAT THE NATURAL MARKET WILL CORRECT ITSELF.

UH, THERE ARE SOME BAD PEOPLE THAT GET HIRED THAT HAVE GOOD CREDIT AND THEY'RE TERRIBLE EMPLOYEES, AND THERE'S PROBABLY SOME GREATER BOYS THAT GETS GET MISSED OUT ON, BUT ULTIMATELY THAT'LL BE UP TO THE INDEPENDENT BUSINESS, WHETHER IT BE SMALL OR LARGE TO MAKE THAT GOOD OR BAD DECISION. AND THAT IS THE REASON FOR MY NO VOTE TONIGHT.

BEING IN UNINCORPORATED AREA OF THE FORMER COUNTY

OF JEFFERSON.

RIGHT IN FULL.

HE MAY HAVE A MOTION AND A SECOND MOTION, A MOTION BY COUNCILMAN INGLES.

SECOND MAC COUNCILMAN WINKLER.

THE ORDINANCE IS BEFORE US.

IS THERE ANY DISCUSSION?

COUNCILMAN ANDERSON.

THANK YOU, MR. PRESIDENT.

UH, THIS WAS AN ITEM THAT, UH, CAME TO US.

THEY'RE LOOKING TO INCORPORATE A PORTION

INTO, UH, COUNCILLOR KRAMER'S AREA INTO THE

SEAT, JEFFERSON TOWN.

IT CAME OUT OF MY COMMITTEE WITH 95% APPROVAL.

I WAS THE ONE, NO VOTE AND COLLEAGUES.

I'M NOT HERE TONIGHT TO TELL YOU HOW TO VOTE.

UH, I'LL EXPLAIN MY NO VOTE.

AND THEN I WANT TO TURN THE MICROPHONE OVER TO COUNSELOR KRAMER, UH, WHO CHAMPIONED THIS LEGISLATION?

I HAVE BEEN A NO VOTE ON MOST ANNEXATIONS PERIOD. UH, WHEN IT INVOLVES THE CITY OF LOUISVILLE GIVING UP PORTIONS OF, UH, OF OUR POPULATION TO SMALL CITIES.

I HAVE BURNED THAT BECAUSE THE ONLY TIME THAT YOU'VE SEEN ME SUPPORT SOMETHING LIKE THAT IS WHEN THE ECONOMIC SITUATION WAS SO UPSIDE DOWN.

I REMEMBER WE HAD A STREET THAT WE GAVE TO THE CITY OF ST. MATTHEWS AT THE STREET NEEDED TO BE PAVED.

THERE WERE MAYBE 10 OR 12 HOUSES ON THAT STREET.

IT WAS GOING TO COST US, YOU KNOW, CLOSE TO A HUNDRED THOUSAND.

AND AT THAT POINT, THE TAX DOLLARS, DIDN'T JUSTIFY KEEPING THAT IN THE CITY AND LOSING THE MONEY. THIS IS NOT A MAJOR ECONOMIC SITUATION WE'RE DEALING WITH.

IT'S ABOUT, MAYBE I WANT TO SAY \$28,000 A YEAR IS WHAT WE'D LOSE WHEN YOU CONSIDER THE OCCUPATIONAL TAXES.

PLUS THE \$6,000 A YEAR IN ROAD FUNDS THAT WE WOULD GET.

HOWEVER, THIS IS A SITUATION WHERE WE HAVE THE ROADS ARE PRETTY DARN GOOD CONDITION. I BLEW COUNCILMAN KRAMER RECENTLY PUT IN SOME SIDEWALKS OVER THERE.

SO WE SPENT MONEY OVER THERE.

WE'RE NOT IN A FINANCIALLY UPSIDE DOWN SITUATION REGARDING THIS AREA OF TOWN.

AND SO IF WE BELIEVE IN MERGER, WE SHOULD BE LOOKING TO, RATHER THAN SENDING PEOPLE OUTSIDE THE CITY, WE SHOULD BE KEEPING EVERYONE IN ONE POT WITH THE ATTITUDE BEING, UH, ONE OF THE ARGUMENTS MADE WAS THESE FOLKS WANT THE CITY OF J TOWN POLICE DEPARTMENT BECAUSE IT'S BETTER THAN THE SAME RULES

WHY RECOGNIZE THAT?

BUT THE SOLUTION IN MY MIND IS NOT TO LET PEOPLE FLIEST IT'S TO RECOGNIZE OUR PROBLEMS AND OUR FAILURES AS A GOVERNMENT WITH ME, THE ADMINISTRATION, OR THIS COUNCIL, AND WORK TO IMPROVE GARBAGE PICKUP AND WORK TO IMPROVE POLICE PROTECTION, WHICH WOULD INCLUDE POTENTIAL PAYING [INAUDIBLE] HIRING BETTER AND DOING A BETTER JOB VERSUS ALLOWING PEOPLE TO SAY, WELL, I'LL JUST GO OVER HERE AND PAY A LITTLE MORE TAXES AND GET BETTER SERVICES.

IF WE BELIEVE WE ARE TRUE ONE METRO GOVERNMENT THAT WE OUGHT TO BE LOOKING FOR.

UNITY, THAT UNITY BEING, IF GARBAGE PICKUP IS A PROBLEM IN THE WEST END, IT SHOULD ALSO BE A PROBLEM IN PROSPECT IN THE EAST END, BECAUSE THEN IT BECOMES ONE CONSISTENT PROBLEM THAT WE HAVE TO WORK TO ADDRESS.

I'M NOT AFRAID OF ANNEXATION, UNLESS IT

FINANCIALLY MAKES SENSE.

I DON'T SEE THIS AS ONE IS MAKING FINANCIAL.

IT'S NOT A FINANCIAL DETRIMENT, BUT IT ALSO

DOESN'T MAKE FINANCIAL SENSE TO ME.

AND AS SUCH, I WAS THE NO VOTE.

I WANT TO TURN IT OVER TO COUNCILMAN KRAMER WHO WILL BE A YES VOTE.

HE WILL CHAMPION THIS CAUSE.

AND, UH, AND I WELCOME HIS ENTHUSIASM.

MR. PRESIDENT, I'D LIKE TO TEND TO THE MIC TO

COUNSELOR KRAMER.

CLIDE

THANK YOU.

SURE.

COUNCILMAN KRAMER.

THANK YOU, MR. PRESIDENT.

UM, I HOPE I BRYCE THE LEVEL OF EXPECTATION FOR ENTHUSIASM.

UM, COUNCILMAN ACKERSON, AND I, UH, I WILL SAY COUNCILMAN ACKERSON AND I HAVE, UH, A VERY DECIDEDLY, A DIFFERENT PHILOSOPHY WHEN IT COMES TO SUBURBAN CITIES AND I, AND I I'M QUITE COMFORTABLE THAT THAT'S WHERE, UM, HIS COMMENTS COME FROM.

AND, AND I DO VERY MUCH APPRECIATE THAT.
UM, AND I AM IN FACT, THE PERSON IN COMMITTEE THAT
HE REFERENCES, WHO SUGGESTED THAT, UM, THAT
THESE ARE CONSTITUENTS OF MAN AND THAT MY
CONSTITUENTS HAVE ASKED THAT THEY BE ALLOWED TO
PAY A HIGHER RATE OF TAXES IN ORDER TO RECEIVE
SERVICES THAT METRO LOUISVILLE WILL NEVER
PROVIDE.

UM, THEY WANT SERVICES SUCH AS GARBAGE COLLECTION.

THEY WANT SERVICES SUCH AS SNOW REMOVAL.
UM, THEY WANT THE KINDS OF SERVICES THAT THOSE OF US
WHO LIVE OUTSIDE THE URBAN SERVICE DISTRICT, UM,
CAN'T EXPECT FROM METRO GOVERNMENT.
AND, YOU KNOW, I HAVE THIS CONVERSATION WITH
FOLKS WHO I REPRESENT, WHO LIVE IN UNINCORPORATED
AREAS, WHO, WHO FEEL LIKE METRO LOUISVILLE SHOULD
EXTEND THESE SERVICES ACROSS ALL OF JEFFERSON
COUNTY.

YOU KNOW, FOLKS WHO MAKE EXACTLY THE ARGUMENT THAT COUNCILMAN ACKERSON, TID THAT, UM, YOU KNOW, WHEN WE MERGED GOVERNMENTS, WE SHOULD ALL BE GETTING EXACTLY THE SAME LEVEL OF SERVICE.

THERE WOULD NOT BE A WAY FOR US TO PROVIDE STREETLIGHTS OR GARBAGE COLLECTION OR SNOW REMOVAL ACROSS ALL OF JEFFERSON COUNTY.

IF WE ALL PAID THE SAME TAX RATE, EVEN IF THAT TAX RATE WERE RAISED TO BE EQUIVALENT TO THE TAX RATE OF THOSE LIVING IN THE URBAN SERVICE DISTRICT, UM, THE DISTANCE BETWEEN HOMES MAKES IT MORE EXPENSIVE TO DO SNOW REMOVAL.

UM, THE LAYOUT OF NEIGHBORHOODS WHERE STREETS ARE NOT IN, IN 90 DEGREE ANGLES, UH, MAKES IT MUCH MORE DIFFICULT TO TRY AND FIGURE OUT WAYS TO DO GARBAGE COLLECTION, UM, UM, EFFICIENT, OR I SHOULDN'T SAY EFFICIENTLY, BUT, BUT AS INEXPENSIVELY. SO THERE ARE A MERIT OF REASONS WHY I WOULD ARGUE THAT, UM, WE, METRO LOUISVILLE ACTUALLY BENEFIT FROM, FROM THE SERVICES THAT ARE PROVIDED BY THE SUBURBAN CITIES, UM, AND FOLKS WHO LIVE IN

THIS PURPOSE CITIES WHO ARE WILLING TO ASK FOR EXTRA TAXES AND, UM, THEY'RE WILLING TO PAY THAT IT FREES UP SOME OF THE RESPONSIBILITIES THAT METRO GOVERNMENT HAS AND OTHER AREAS I WOULD BE, YOU KNOW, TO COUNCILMAN ACTIONS POINT, I WOULD BE SPENDING MONEY ON, ON SIDEWALKS IN SUBURBAN CITIES.

IF MY CONSTITUENTS IN CERTAIN SUBURBAN CITIES NEEDED SIDEWALKS, I PARTNERED IS ONE OF THE PROUDEST MOMENTS OF MY TIME ON THIS COUNCIL WAS IN THE FIRST TWO YEARS OF MY ELECTION.
I PARTNERED WITH THE STATE OF KENTUCKY, THE CITY OF JEFFERSON TOWN AND OUR OWN METRO PUBLIC WORKS DEPARTMENT TO PUT A SIDEWALK ALONG HERSBORN LANE, WHICH IS A STATE ROAD THAT RUNS IN AND OUT OF, OF THE URBAN CITY OF JEFFERSON TOWN.
SO I THINK THOSE KINDS OF PARTNERSHIPS ARE GREAT. I DO APPRECIATE VERY MUCH SUBURBAN CITY. SO I'M GOING TO ASK TONIGHT FOR, UH, FOR MY COLLEAGUES YES.

VOTE.

UM, IT'S WHAT MY CONSTITUENTS ASK FOR IN, UH, WITH AN OVERWHELMING MAJORITY OF RESIDENTS, UM, FILLING OUT THE SURVEY THAT SAID, UM, I FINISHED OUT MY COMMENTS AND THEN, UM, TURN THE FLOOR OVER TO COUNCILMAN, UM, UH, HOLLANDER, I BELIEVE HE WANTS TO OFFER AN AMENDMENT.

AND SO I DON'T WANT TO STEAL TOO MUCH OF HIS THUNDER.

UM, I WANT TO POINT OUT THAT IN COMMITTEE, WHEN THIS WAS DISCUSSED, UM, THERE WAS A BIT OF CONVERSATION ABOUT, UH, UH, INFRASTRUCTURE THAT MSD HAS PAID FOR, FOR DRAINAGE.

THERE WAS SOME, SOME CONVERSATION AROUND, UM, GOING FORWARD, HOW THAT WOULD WORK IN TERMS OF WHO WOULD, WHO WOULD PAY, HOW THEY WOULD PAY, HOW THAT WOULD ALL BE TAKEN CARE OF.

UM, IF WE GO BACK AND LOOK AT THE MINUTES, UM, THERE WERE A COUPLE EVERY MUNICIPAL, UM, EVERY MUNICIPAL, UM, ENTITY THAT WOULD HAVE BEEN AFFECTED BY THIS PUBLIC WORKS.

UM, AND, AND ULTIMATELY MSD WERE ASKED, UH, WHAT THE IMPACT WOULD BE.

MST DID SEND A REPORT.

UM, BUT NO ONE FROM MSD TESTIFIED AT THE COMMITTEE, UH, MEMBERS FROM JEFFERSON DOWN DID IN

FACT, TESTIFIED THE COMMITTEE WE HEARD FROM THE MAYOR OF JEFFERSON TOWN, UH, BILL DEER FROM, WE ALSO HEARD FROM, UH, JEFF'S TOWN'S ATTORNEY, UH, SCALOR ALT UM, IN ALL OF THAT CONVERSATION, IT'S CLEAR TO US AT THE COUNCIL LEVEL THAT THERE IS DISCUSSION ONGOING DISCUSSION BETWEEN J TOWN AND MSD ABOUT HOW THAT ALL IS GOING TO PLAY OUT. AND I, THE WAY I READ COUNCILMAN HOLLANDER'S, UM, UM, AMENDMENT, IT ACKNOWLEDGES THAT THAT IS THE CASE AND, AND SAYS THAT NOTHING WE DO THIS EVENING, UM, TAKES THE SIDES ON THAT ISSUE AND THAT HOWEVER, THEY RESOLVE THAT AS HOW THEY RESOLVE IT.

UM, I WOULD POINT OUT THAT THE, THE AMENDMENT DOES ACKNOWLEDGE MSDS POSITION.

IT DOESN'T ACKNOWLEDGE JEFFERSON TOWN'S POSITION, BUT AGAIN, IF YOU WANT TO KNOW WHAT YOUR TOWN'S POSITION IS, ALL YOU HAVE TO DO PLEASE IS GO LOOK AT THE MINUTES.

UM, SO IT IS ON RECORD.

IT'S OFFICIALLY THERE.

UM, WE HAVE ACCESS TO IT.

SHOULD WE WANT IT?

SO I'LL BE VOTING YES.

ON THE, ON THE ORDINANCE ITSELF.

AND I'LL, I'LL THROW THE FLORIDA COUNCILMAN HOLLANDER IF THAT'S OKAY.

AND I'LL ALSO THROW MY SUPPORT TO HIS AMENDMENT, UM, AS I RELINQUISHED THE SPEAKER.

THANK YOU, COUNCILMAN COUNCIL AND HOLLANDER.

THANKS TO GIVE US PRESENT.

THANK YOU, COUNCILMAN KRAMER.

UM, THAT'S CORRECT.

SO, YOU KNOW, WHAT I, WHEN I FIRST GOT ON THE COUNCIL, I WAS ACTUALLY ON AN AD HOC COMMITTEE ON ANNEXATION BECAUSE ANNEXATIONS WERE JUST ALLOWED FOR THE FIRST TIME, UH, AFTER MERGER. AND I SERVED ON THAT WITH COUNCILMAN DOWNER AND WE LOOKED AT SORT OF WHAT WE SHOULD BE LOOKING AT AS FIDUCIARY, UM, FIDUCIARIES FOR, FOR LOCAL METRO. AND WE LOOKED AT, UH, THE CONDITION OF THE STREETS AND THE SIDEWALKS AND HOW MUCH TAX REVENUE WOULD, WOULD BE LOSING BECAUSE WE DO LOSE LOSE INSURANCE, PREMIUM TAX REVENUE AND, AND, AND WHAT STATE ROAD MONEY MIGHT BE LOSING AND WHAT THE DEVELOPABLE LAND WAS IN THE AREA AND SO FORTH AND SO ON.

UH, AND WE ACTUALLY, I THINK UNANIMOUSLY PUT THAT INTO AN ORDINANCE FORM LAST YEAR SO THAT WE WOULD GET REPORTS FROM, UH, FROM EACH OF THOSE METRO DEPARTMENTS.

AND WE GOT THOSE WE DID NOT PUT IN, AND I'LL PROBABLY BE TRYING TO AMEND THIS NEXT YEAR. WE DID NOT ASK FOR ANYTHING FROM MSD BECAUSE FRANKLY I HAD NEVER, UH, SOUGHT IN OF THIS WHOLE ISSUE.

IT DID NOT COME UP IN 2015 WHEN I WAS ON THAT COMMITTEE WITH COUNCILMAN DOWNER.

SO WE DID GET A LETTER FROM MSD THIS TIME.

I WISH WE HAD, I HAD INVITED THEM TO COME TO THE MEETING.

THEY DID NOT COME TO THE MEETING.

THEY DID PRESENT A LETTER.

SO THE POINT IS OF THE FLOOR AMENDMENT.

AND IT'S IN THE SYSTEM RIGHT NOW.

I'M NOT GOING TO READ IT.

IT'S THE FIRST ITEM ON THE AGENDA.

UM, THERE ARE THREE WHEREAS CLAUSES, UH, WHICH I WOULD LIKE TO ADD.

AND I'LL JUST SAY BASICALLY WHAT THE THREE SAY.

THE FIRST IS THE VARIOUS MUNICIPAL AGENCIES WERE ASKED TO PROVIDE AN OPPORTUNITY OR WERE GIVEN AN OPPORTUNITY TO SPEAK AND COMMENT ON THE REOUEST.

MSD PROVIDED A RESPONSE, ASSERTING CERTAIN RIGHTS AND DUTIES REGARDING, UH, INFRASTRUCTURE FOR STORM WATER DRAINAGE IN THIS SUBDIVISION.

AND FINALLY, AND I THINK THIS IS THE SORT OF REAL OPERATIVE, UM, UH, WHEREAS CLAUSE WE'RE SAYING WE DON'T INTEND FOR THE APPROVAL OF THIS

ANNEXATION TO AFFECT IMPAIR AND P WAVE OR OTHERWISE ALTER THEIR ASSERTED RIGHTS.

AGAIN, THIS IS WHAT THEY ARE ASSERTING OR RESOLVE ANY POTENTIAL DISPUTE BETWEEN MSD BETWEEN J TOWN, UH, OR THE PROPERTY OWNERS IN, IN KIRBY

THAT'S IT?

STATES.

UH, THIS IS AN ONGOING DISCUSSION.

I HOPE IT CONTINUES.

I DO THINK IT'S A LEGITIMATE ISSUE FOR BOTH SIDES

UH, AND, UH, AND SO I WOULD, I WOULD MOVE TO

AMEND THIS, JUST TO ADD THOSE THREE WAREHOUSE CLAUSES, WHICH ARE, WHICH ARE IN THE FLOOR AMENDMENT IN THE SYSTEM.

LET ME PULL UP THE

ORDINANCE.

I MEAN, IT MADE ME UNDERSTAND MAYBE TWO

TRACKS OF LAND, BUT I DIDN'T WANT SOMEONE TO

THINK THAT BECAUSE WE'RE INCLUDING ALL ACREAGE THAT

WE'RE CHANGING ALL ACREAGE BECAUSE WE'RE NOT RIGHT.

AND THE REALITY HERE IS EVEN THE, IN LIGHT OF THAT MUCH BUDGE, MUCH HIGHER TAX RATE IN THEIR SERVICE DISTRICT.

WE STILL FALL SHORT WITH THE LIGHTING.

SO, UH, IF WE'RE GOING TO BE EXAMINING GETTING LIGHTING OUT THERE, WE NEED TO ALSO LOOK AT HOW TO ECONOMICALLY MAKE IT FAIR.

IF WE'RE GOING TO SPREAD THAT AROUND THE ENTIRE COUNTY POTENTIAL, WHICH I DON'T THINK WE'LL HAVE THE DOLLARS TO DO.

WE NEED TO LOOK AT THE FACT THAT PEOPLE IN THE URBAN SERVICE DISTRICT ARE PAYING A MUCH HIGHER PRICE.

IT'S STILL NOT GETTING THE LIGHT THAT THEY DESERVE. THANK YOU, MR. PRESIDENT.

THANK YOU, COUNCILMAN COUNCILMAN.

THANK YOU GLAD TO HAVE THOSE CONVERSATIONS. AND I ACTUALLY DID SOME ROUGH ANALYSIS AFTER GETTING DATA FROM THE REVENUE COMMISSION IN THE SHERIFF'S OFFICE.

AND I CAN TELL YOU THAT EVEN WITH THE DIFFERENTIAL THAT THE USD PAYS, THEY DON'T COVER THEIR OWN EXPENSES.

SO THOSE OUTSIDE OF THE USD ARE CONTRIBUTING TO THE SERVICES INSIDE THE USD, UH, BECAUSE EVEN WITH THE DIFFERENT RATE, THE DIFFERENT RATE DOESN'T COME COVER THE SERVICES THAT ARE GERMANE TO THE USD.

WE NEED TO HAVE A BROADER DISCUSSION ON THIS, GLAD TO OPEN UP THIS WHOLE CAN OF WORMS, BUT EITHER WAY. AND AGAIN, I'M GOING TO PICK ON IT A NEIGHBORHOOD, BUT I LIVE IN LAKE FOREST, WAKE FOREST PAYS FOR THEIR OWN STREETLIGHTS, FINE WITH THAT.

UH, THEY REALLY HAVE NO MEANS THAT A NEIGHBORHOOD LIKE LAKE FOREST HAS HAD IN ORDER TO ADDRESS THIS. SO MY POINT IS FOR, FROM AN EQUITY POINT OF VIEW, IF FOR NO OTHER, WE JUST NEED TO TAKE A LOOK AT THIS ACROSS THE CITY, PREFERABLY THIS NEXT BUDGET CYCLE, BECAUSE COUNSEL WOMEN, UH, THIS IS IN A CUSTOMER DORSEY'S DISTRICT, CORRECT? DISTRICT THREE.
