OF YEARS AGO WHEN THE CLERK'S OFFICE WAS STRUGGLING AND THOSE OF US ON THE COMMITTEE ON COMMITTEES WERE TRYING TO FIGURE

OUT HOW TO OFFER SUPPORT AND GET THINGS STRAIGHTENED OUT, WE CAME TO UNDERSTAND WE NEEDED A STRONG PERSON IN THAT ROLE, SOMEONE WHO WOULD GRAB HOLD OF WHAT WAS GOING ON. FIGURE OUT WHAT THE REAL

ISSUES AND STRUGGLES WERE. AND BRING TO BARE THE LEADERSHIP

THAT WAS NECESSARY TO TURN THAT OFFICE AROUND. I'M PROUD OF THE FACT THAT WE WERE ABLE TO FIND AND WORK WITH AND SUPPORT MISS

SONIA HARVARD. SHE'S DONE AN EXCEPTIONAL JOB IN ALL OF THE TASKS THAT WE ASK HER. ONE OF OUR CONCERNS WAS THE

NECESSITY TO HAVE THE PROPER CERTIFICATIONS AND REALIZIZATION OF THOSE CREDITS ONE NEEDS. SHE'S FINISHED TWO YEARS OF THAT

PROCESS NOW. AND THIS SUMMER WILL FINISH HER THIRD. WE'RE PROUD OF HER FOR ACCOMPLISHING THAT AS QUICKLY AS SHE HAS. NOT

CONTRACT FOR METRO SAFE CONCERNING DEFLECTION PROGRAM MOBILE RESPONSE SERVICES SEVEN COUNTIES SERVICES, INC.,

\$1,687,670. >> PRESIDENT JAMES: THANK YOU. MR. GOLDEN. >> YES, SIR. MY NAME IS MATT

GOLDEN. I WORK FOR THE MAYOR. I BELIEVE THERE MAY BE AN AMENDMENT ON THE MATTER THAT SHOULD BE OF ORDER.

>> PRESIDENT JAMES: YES, WE'LL DO THAT WHEN WE RECONVENE. >> IN TERMS OF THE CONTRACT, THIS IS A GOOD CONTRACT THAT

WOULD FUND A CRISIS RESPONSE TEAM TO DELIVER SOCIAL SERVICES AND MENTAL HEALTH SERVICES TO INDIVIDUALS IN CRISIS ON THE

STREETS. THE RIGHT SIZING OF SOCIAL SERVICES TO PEOPLE IN NEED IN OUR COMMUNITY. THANKFULLY, SEVEN COUNTIES HAS

AGREED TO PROVIDE THAT SERVICE WITH US IN THIS CONTRACT. I'M HOPEFUL YOU'LL BE VERY SUPPORTIVE OF THIS CONTRACT.

OVER THE COURSE OF THE LAST FEW DAYS, WE'VE MADE A COUPLE OF MINOR AMENDMENTS TO THIS CONTRACT, WITH THE HELP AND

GUIDANCE OF NICOLE GEORGE, THE INVOLVEMENT OF C.E.O. OF SEVEN COUNTIES, ABBY GREEN ON THE LINE. JODI FROM METRO SAFE AND THEIR COROLLARIES, KELLY JONES FROM METRO SAFE, CAN AND DAVID WHETTERSBY FROM SEVEN COUNTIES. I'M HOPEFUL YOU'RE SUPPORTIVE OF

THE CONTRACT. YOU WERE SUPPORTIVE WHEN IT WAS INITIALLY BROUGHT FOR THE AND FUNDED. AGAIN, I THINK THIS IS THE RIGHT

THING TO DO. I'M HERE TO ANSWER QUESTIONS YOU MAY HAVE. >> PRESIDENT JAMES: THANK YOU. COUNCILMEMBER GEORGE.

>> THANK YOU, PRESIDENT. FEEL FREE IF I'M NOT FOLLOWING THE CORRECT ORDER WE'RE IN. I WOULD REMIND COLLEAGUES THAT

THIS PARTICULAR CONTRACT WAS TABLED. THERE HAD BEEN FOUR PRIMARY CONCERNS WE HAD HEARD THAT HAD COME UP SINCE THE

CONTRACT WAS PASSED FROM PUBLIC SAFETY COMMITTEE. THE FIRST PIECE WAS NEED FOR EVALUATION. WE TO MY KNOWLEDGE MADE PROGRESS IN THAT WAY. THE EVALUATION PROPOSAL WAS SUBMITTED. SOME MAY HAVE CONCERNS ABOUT THAT. WE CAN DISCUSS THAT. IN THAT

PORTION, THERE'S BEEN SOME PROGRESS IN. THE SECOND PIECE IS THE STRUCTURE OF THE PROGRESS IN

TERMS OF MANAGEMENT. THERE'S BEEN SOME WORK DONE THAT WAY AND COMMITMENT TO CONTINUE THAT WORK WHILE AT THE SAME TIME EXECUTING

THE CONTRACT SO WE CAN GET THINGS MOVING AND GET STAFFED UP. THE THIRD THING WAS CONCERNS

WITH THE JOB RARITYS. THAT IS TO SAY WE WANT TO MAKE SURE WHAT WE'RE ASKING FROM INDIVIDUALS THAT THEN ENSURE THEY'RE ABLE TO DELIVER THE SERVICES NEEDED. THERE'S BEEN PROGRESS IN THAT WAY AS

WELL. I CERTAINLY WANT TO THANK BOTH CHIEF BOLDEN AS

WELL AS LEADERSHIP IN SEVEN COUNTIES AND THE ADVISORY TEAM THAT WORKED ON THIS, PARTICULARLY DURING THE

HOLIDAYS. THE FOURTH CONCERNING AREA THAT CAME ABOUT WAS AROUND ADEOUATE AND EQUITABLE PAY FOR THOSE

DOING THE WORK. EVERYONE WILL REMEMBER DEFLECTION REALLY IS DESIGNED TO BE ANOTHER TOOL AND ANOTHER RESPONSE FOR THOSE IN CRISIS. THE GOAL IS DEFLECT PEOPLE AWAY FROM THE CRIMINAL JUSTICE SYSTEM, WHEN POSSIBLE. THESE ARE NOT LAW ENFORCEMENT

POSITIONS, BUT THESE POSITIONS ARE IMPORTANT NONETHELESS AND REQUIRE A CERTAIN SKILL SET. ALL THAT TO SAY FOR MANY OF US

WHO VOTED FOR CONTRACT FOR OUR LMPD OFFICERS TO ENSURE WE KNOW RECRUITMENT AND RETENTION AND ACCOUNTABILITY ARE CONTINGENT UPON EQUITABLE COMPENSATION. THE FOR MANY OF US WHO DID THAT, I THINK THERE'S STILL WORK TO BE DONE IN THIS AREA. WITH THAT BEING SAID, THERE HAS BEEN PROGRESS. AND YOU WILL SEE THAT REFLECTED

IN -- FOR ANYONE THAT HAS QUESTIONS, YOU'LL SEE THAT REFLECTED REFLECTED IN THE AMENDED PROGRAM AGREEMENT THAT'S LOADED IN THE

SYSTEM. AGAIN, IT IS A STARTING POINT. AND ABSENT OUR ABILITY
TO DICTATE THE CONTRACT AND SPECIFICALLY WHAT IS BEING PAID, THE NEXT
BEST THING WOULD BE TO REQUEST THE -- THERE ARE FOUR

AMENDMENTS, A MONTHLY REPORT THAT WOULD BE PREPARED AND SHARED WITH US RELATED TO STAFFING AND COMPENSATION. THE

ADMINISTRATION IS AGREEABLE TO THAT. THEY SEE THE VALUE OF THE PARTNERSHIP BOTH IN THE WAY OF KEEPING FOCUS AND CONSISTENT PROGRESS AS WELL AS BEING ABLE TO LOOK OUT INTO THE FUTURE AS WE ESTIMATE FUTURE BUDGETS AND COSTS FOR THE PROGRAM.

SO WITH THAT, PRESIDENT, I'M HAPPY TO READ THE FLOOR AMENDMENT, OR DO YOU WANT US TO WAIT?

>> PRESIDENT JAMES: I WOULD WAIT UNTIL WE GET BACK INTO THE REGULAR COUNCIL. LET'S USE THIS FOR DISCUSSION AND TALKING ABOUT

IT. IF YOU WANT TO TALK ABOUT WHAT YOUR FLOOR AMENDMENT WOULD BE, THAT WOULD BE GOOD. >> THE FLOOR AMENDMENT WILL

SIMPLY ADD AN ADDITIONAL SECTION. IT WILL STATE LOUISVILLE METRO GOVERNMENT THAT SHALL PROVIDE MONTHLY REPORTS

FOR THE COUNCIL WITH THE UPDATED NUMBER OF POSITIONED STAFF AND COMPENSATION UNDER THE CONTRACT AGAIN, I DON'T KNOW IF CHIEF

WANTS TO SPEAK TO THAT. MY UNDERSTANDING IS EVERYONE IS SUPPORTIVE.

>> WITH THE ADDITIONAL FLOOR

AMENDMENT, YES, MA'AM, ABSOLUTELY. WE APPRECIATE THAT AND ARE TOTALLY AGREEABLE. I ALSO SUGGEST THERE HAVE BEEN

OTHER AMENDMENTS TO THE CONTRACT THAT SHOULD BE IN YOUR GRANICUS SYSTEM. >> THANK YOU.

>> PRESIDENT, I WANT TO ACKNOWLEDGE HOLLY HOPKINS AND THE JEFFERSON COUNTY ATTORNEY'S OFFICE. THANK YOU, HOLLY.

>> PRESIDENT JAMES: THANK YOU. COUNCILMAN PIAGENTINI. >> THANK YOU, MR. PRESIDENT. ONE OF MY CONCERNS AND I KNOW WE

DISCUSSED THIS BRIEFLY AT CAUCUS, SO I WOULD SAY I KNOW THE

REPUBLICAN CAUCUS AND NICOLE TALKED ABOUT THIS BEFORE, IS

SORT OF MONITORING THE ACCOUNTABILITY RELATED TO THIS. MATT, I'M NOT -- THIS IS RELATED TO THE BIGGER PICTURE, RIGHT?

IN OTHER WORDS THIS ISN'T NECESSARILY SPECIFIC TO THIS CONTRACT, BUT MY PROBLEM IS -- I'M TRYING TO PULL IT UP HERE.

I HAD IT A SECOND AGO. I LOST IT. THERE WAS ORIGINALLY TWO CONTRACTS, RIGHT. THIS ONE AND

ANOTHER ONE THAT WAS AN EVALUATION PROGRAM THAT UVL WAS GOING TO DO TO MAKE SURE IT WAS DONE RIGHT.

ONE OF THE PROBLEMS WE HAD -- IT MATERIALIZED WHEN WE HAD THE BUDGET ISSUES A COUPLE OF YEARS AGO AND IF WE RAN INTO -- WE

SHOULDN'T WAIT UNTIL THERE'S BUDGET PROBLEMS. WE SHOULD ALWAYS ASK WHAT IS THE EFFICACY OF THE PROGRAM AND PROOF THAT IT

WORKS? I SUPPORTED THIS. I HAVE, YOU KNOW, SUPPORTED IT THE IN THE BUDGET, BUT I WANT TO MAKE SURE

WE'RE DOING THIS WELL AND SOMETHING THAT WORKS. U OF L HAD AN EVALUATION MODEL, AND I THINK THERE WAS A CONTRACT

PENDING APPROVAL AT SOME POINT, BUT THEN, IT WAS PULLED. CAN YOU CLARIFY WHERE THAT CONTRACT IS WITH U OF L TO DO

THE EVALUATION OF THIS PROGRAM? AND IS THE ADMINISTRATION COMMITTED TO GETTING THAT APPROVED AND IN PLACE AT THE

SAME TIME THAT THIS HAS BEGUN SO THAT WE DON'T HAVE A SCENARIO
WHERE THE EVALUATION ISN'T STARTING AT THE SAME TIME.
