Review of the Metro Council Agenda

Council President James reviewed the Metro Council agenda.

Council President James explained that Council Rules 7.01(b) would be invoked regarding item 35 (R-007-22) and item 37 (OR-001-22). He also explained that the Council Rule change in item 36 (R-020-22) regarding vacancies on the Council was to include a short application that includes the applicants' date of birth, and since there was not prior notice given for the Council Rule change, [Council Rule 1.01(d) would need to be suspended.]

Council Member Flood briefly spoke about items 38-42 on Old Business, and noted that there would be a motion to recommit item 41 (O-680-21) to the Planning and Zoning Committee.

Council Member Hollander briefly spoke about item 43 (R-168-21), and noted that it was only on Old Business because it was amended.

Council Member Blackwell briefly spoke about items 44 (O-671-21) and 45 (O-677-21), and noted that they had been amended.

Announcements

Council President James shared condolences for the passing of Council Member Triplett's mother and Sophia White's brother, Curtis White.

Council Member Shanklin reminded the Council Members to submit the names of their honorees for the Black History Program by February 9, 2022, and stated that the Council Member or Legislative Aide for each District would be given 2-3 minutes to speak about their honoree when s/he is recognized.

Council President James congratulated Council Member Green on her upcoming appointment as a judge. He reviewed the following dates regarding filling the vacancy this creates in District 1:

- Council Member Green's resignation will be effective at the end of the February 17, 2022 Council meeting.
- From February 18, 2022 to February 28, 2022, applications will be accepted to fill the vacant seat.
- The Jefferson County Attorney's Office will review the applications to confirm that each applicant meets the necessary qualifications and then Council President James will forward that information to the Council Members for their review.
- A special Committee of the Whole will be held on March 14, 2022 at 4:00 p.m. to interview the eligible applicants to fill the vacant seat.
- Council will vote on which applicant will fill the vacant seat at the regular Council meeting on March 17, 2022.

Council Member Green becomes a judge on February 18, 2022 and she said she would invite the Council to attend.

Council President James spoke about the three podcasts that have been streamed so far, and he encouraged the Council Members to schedule a time with Katrina Helmer to work on a podcast.

Council President James gave updates on the following:

- The construction for the clock tower is still scheduled to begin in the spring.
- The upgrade to the Chambers is in process and by summer there should be an option to vote remotely when attending a meeting virtually.
- Men's restroom on the 3rd floor is still out of order but work is being done to fix the problem.
- National League of Cities Congressional City Conference is March 14-16, 2022 in Washington, D.C., and those that want to attend need to contact Edwin Ernest as soon as possible for travel arrangements.
- Kentucky League of Cities Day and Night is February 23, 2022 in Frankfort,
 KY.
