>> ALL RIGHT. I WOULD LIKE TO WELCOME EVERYBODY. THIS IS THE METRO MEETING. I'M THE COUNCIL PRESIDENT. PLEASE RISE FOR THE PLEDGE OF ALLEGIANCE TO THE FLAG. >> PLEDGE ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA AND TO THE REPUBLIC FOR WHICH IT STANDS, ONE NATION, UNDER GOD, INDIVISIBLE WITH LIBERTY AND JUSTICE FOR ALL. THANK YOU. >> THIS BEING IS HELD TO KRS61A26 AND COUNCIL RULE 5A. >> THANK YOU. COUNCIL MEMBER WAS INTERRUPTED, WE WILL SUSPEND THE MEETING FOR TEN MINUTES WHILE AN ATTEMPT IS MADE TO FIX THE ISSUE. IF AFTER TEN MINUTES THE ISSUE CANNOT BE FIXED, THE MEETING WILL CONTINUE AS LONG AS THE QUORUM IS PRESENT. IF THE MEETING AS A WHOLE EXPERIENCES TECHNICAL DIFFICULTY, THE MEETING WILL BE SUSPENDED WHILE AN ATTEMPT IS MADE TO FIX THE ISSUE. IF AFTER 20 MINUTES THE ISSUE IS NOT RESOLVED, THE MEETING WILL BE ADJOURNED. UNFINISHED BUSINESS WILL BE ADDRESSED AT THE NEXT MEETING. COVID NUMBERS HAVE DECLINED BUT REMAIN EXTREMELY HIGH. WE ARE STILL IN THE RED ZONE. AS OF YESTERDAY, 1922 HAVE DIED AND 206,943 HAVE BEEN DIAGNOSED WITH COVID 19. THE GOOD NEWS IS THAT 490,068 OF OUR CITIZENS HAVE BEEN FULLY VACCINATED. AS MOST OF YOU KNOW, OUR COUNCIL FAMILY EXPERIENCED TWO LOSSES RECENTLY. CURTIS SERVED WITH DISTINCTION AND HONOR DOING HIS MILITARY SERVICE AND WAS BURIED WITH FULL MILITARY HONOR. DELORES TRIPLET PASSED AWAY. SHE SERVED THE CITY 29 YEARS. TO BOTH THE LEGISLATIVE AND EXECUTIVE BRANCHS OF GOVERNMENT, OUR HEARTS GO OUT TO BOTH OF THEM. BOTH WILL BE SORELY MISSED. PLEASE KEEP THEIR FAMILIES IN YOUR PRAYERS AND THOUGHTS AND PLEASE JOIN ME IN A MOMENT OF SILENCE. THANK YOU. CLERK, PLEASE CALL THE ROLL. MR. PRESIDENT, YOU HAVE 3 PRESENT AND A QUORUM. >> THANK YOU, MADAM CLERK. COUNCILMAN, WOULD YOU PLEASE TAKE THE CHAIR? >> I WILL. >> THANK YOU. PRESIDENT JAMES, I BELIEVE YOU HAVE A SPECIAL PROCLAMATION? >> THANK YOU. THANK YOU VERY MUCH. MR. PRESIDENT. I THINK SHANNON IS HERE FROM THE AMERICAN HEART ASSOCIATION. WE HAVE A PROCLAMATION FOR THE AMERICAN HEART ASSOCIATION. IT RECOGNIZES WEAR RED DAY AND SO I'M GOING TO READ THIS INTO THE RECORD. WHEREAS CARDIOVASCULAR DISEASE IS THE NUMBER ONE KILLER OF WOMEN IN THE U.S., ONE IN THREE WOMEN ALMOST ONE WOMAN EVERY 80 SECONDS. AND WHEREAS HEART DISEASE AND STROKE CAN AFFECT ALL WOMEN AT ANY AGE, HEART ATTACKS ARE ON THE RISE IN YOUNGER GENERATIONS OF WOMEN. GENERATION Z AND MILLENNIALS ARE LESS LIKELY TO BE AWARE OF

KNOWING THE WARNING SIGNS OF HEART ATTACKS AND STROKES. WHEREAS ABOUT 80% OF CARDIAC EVENTS CAN BE PREVENTED THROUGH EDUCATION AND LIFESTYLE CHANGES, ALL WOMEN ARE ENCOURAGED TO MOVE MORE, EAT SMART AND MANAGE BLOOD PRESSURE TO REDUCE THEIR RISK OF

CARDIOVASCULAR DISEASE. THE GO RED FOR WOMEN EVENT MOTIVATED WOMEN TO LEARN THEIR FAMILY HISTORY AND TO MEET WITH A HEALTH CARE PROVIDER TO DETERMINE THEIR RISK FOR CARDIOVASCULAR DISEASES AND STROKE. WHEREAS, AS A TRUSTED,

PASSIONATE AND RELEVANT FORCE FOR CHANGE, TO ERADICATE HEART DISEASE AND STROKE IN WOMEN, THE AMERICAN HEART ASSOCIATION GO RED FOR WOMEN REMAINS STEADFAST AND COMMITTED TO MEET THE COMPREHENSIVE HEALTH NEEDS FOR WOMEN AT EVERY STAGE OF LIFE. THEREFORE, WE ENCOURAGE ALL CITIZENS OF GLOBAL TO SHOW THEIR SUPPORT FOR WOMEN AND THE FIGHT AGAINST HEART DISEASE BY COMMEMORATING THIS DAY BY WEARING THE COLOR RED BY INCREASING AWARENESS, SPEAKING OUT ABOUT HEART DISEASE AND EMPOWERING WOMEN TO REDUCE THEIR RISK OF CARDIOVASCULAR DISEASES, WE CAN SAVE THOUSANDS OF LIVES EACH YEAR. >>> I'M TAKING IT. THANK YOU SO MUCH, COUNCIL PRESIDENT JAMES. I APPRECIATE THAT SO MUCH AND I SEE A LOT OF RED ON THE SCREEN RIGHT NOW. THANK YOU FOR SHOWING SUPPORT FOR WOMEN, NOT ONLY IN LOUISVILLE OR IN KENTUCKY BUT ALL OVER THE UNITED STATES. AND IT'S A TRUE HONOR TO GET THIS PROCLAMATION AND I TRULY APPRECIATE EACH AND EVERY ONE OF YOU AND CERTAINLY YOU, COUNCIL PRESIDENT JAMES, FOR READING THIS PROCLAMATION. THANK YOU. >> THANK YOU FOR EVERYTHING YOU DO. THANK YOU VERY MUCH Z. THANK YOU. THANK YOU. >> ALL RIGHT. PLEASE LET THE RECORD REFLECT THAT I HAVE THE CHAIR AGAIN.

>> LET IT BE NOTED THAT COUNCILMAN FOX AND COUNCILMAN REED HAVE EXCUSED ABSENCES. >> SO NOTED.

>> THANK YOU. AND COUNCIL, I THINK YOU HAVE A POINT OF PERSONAL PRIVILEGE. >> THANK YOU, MR. PRESIDENT.

>> I WANT TO ANNOUNCE FEBRUARY 1 WAS NATIONAL ENERGY ASSISTANCE DAY. THE FIRST GOAL THEY WANT TO RAISE AWARENESS ABOUT THE LOW INCOME HOMES IN THE ASSISTANCE PROGRAM AND ENERGY ASSISTANCE PROGRAMS AND THEY WANT TO ENCOURAGE THOSE WHO MAY NOT BE AWARE THEY ARE ELIGIBLE TO APPLY FOR THE PROGRAMS AND THEY WANT ALSO TO STRENGTHEN PARTNERSHIPS BETWEEN STATES AND LOCAL OFFICES, UTILITIES AND OTHERS GROUPS THAT INVOLVE ENERGY AFFORDABILITY. RESIDENTS CAN APPLY FOR ASSISTANCE THROUGH THE LOCAL NATIONAL OFFICES AND I DO NOT HAVE THE NUMBER FOR THEM TO CALL BUT HOPEFULLY THERE'S A LOT OF PEOPLE THAT CALL MY OFFICE ASKING FOR ASSISTANCE AND SO I'M GOING TO HAVE TO GET THE NUMBER OUT THERE. THANK YOU, MR. PRESIDENT.

>> THANK YOU, COUNCIL WOMAN. DO WE HAVE ANY ADDRESSES TO COUNCIL? >> YES, SIR. WE DO.

>> LET ME REMIND THOSE ADDRESSING THE COUNCIL, PLEASE REFRAIN FROM USING PROFANITY OR DEROGATORY STATEMENTS TO THE COUNCIL MEMBERS. PLEASE BRING THEM FORWARD. >> REGINA EDISON. >> GOOD AFTERNOON TO EVERYONE

THAT IS ON THE CITY COUNCIL. MY NAME IS REGINA EDISON AND I COME BEFORE YOU TODAY AS A PARA TRANSIT RIDER AND ON BEHALF OF OTHER CURRENT TRANS PARK THREE RIDERS TO DISCUSS THE CONTINUING ISSUES THAT WE ARE HAVING IN THE TRANSPORTATION TEST TAKEN CHARGE. SINCE TRANSPORTATION HAS TAKEN CHARGE, I MYSELF HAVE BEEN WITHOUT A WAY TO MY JOB WHICH I RELY ON THEM TO GET TO MY JOB. I'VE BEEN WITHOUT A WAY TO GET TO MY JOB ON SEVERAL OCCASIONS. I'VE BEEN EXTREMELY LATE TO MY JOB. I HAVE BEEN STRANDED FROM AN HOUR TO TWO OR THREE HOURS TO MY JOB SAYING THERE'S NO DRIVER TO MY ROUTES THAT I'M ON. IF YOU LOOK UP THE TRANSPORTATION MISSION, IT SAYS THAT THEY PROVIDE SAFE AND RELIABLE TRANSPORTATION TO THE PHYSICALLY AND MENTALLY DISABLED AND TO THE ELDERLY. AND I'M HERE TO TELL YOU THAT THEY ARE NOT PROVIDING SAFE OR RELIABLE TRANSPORTATION. IT IS NOT SAFE TO HAVE THE ELDERLY, THE PHYSICALLY OR MENTALLY DISABLED WAITING OUTSIDE ON OUR JOBS, DOCTORS' OFFICES, OR ANY OTHER PLACE THAT WE HAVE TRAVELLED SEVERAL HOURS IN THE DARK, THE RAIN, THE SNOW OR ANY TYPE OF COLD WEATHER. IT IS NOT SAFE TO CONTINUE TO PLACE FOUR PEOPLE TO A CAB DURING THIS COVID 19 PANDEMIC. I COME BEFORE YOU TODAY TO LET YOU KNOW THAT TRANSIT HAS CAUSED A LOT OF ANXIETY, FEAR AND MENTAL ANGUISH AND MANY OF US ARE NOW SCARED TO ARRANGE TRIPS THROUGH THEM BECAUSE WE DON'T KNOW IF WE'RE GOING TO GET TO OUR DESTINATION AND IF WE DO GET TO OUR DESTINATION. WE DON'T KNOW IF WE'RE GOING TO HAVE A WAY BACK.

SO I COME BEFORE YOU TODAY TO KNOW THERE ARE CONTINUING ISSUES WITH THIS. AND PLEASE DO NOT PUT THIS ON THE BACK BURNER AND

CONTINUE TO LOOK AT THIS SITUATION BECAUSE MANY PEOPLE LIKE MYSELF DEPEND ON THAT SERVICE TO GET TO THEIR JOBS.

AND I APPRECIATE YOU FOR LISTENING. THANK YOU. >> THANK YOU. TONY SWEEZEY? YOU'RE MUTED, SIR.

[INAUDIBLE] MORE FREQUENT AND SEVERE FLOODING AND THEY'RE WAITING FOR THREATS TO CIVILIANS SO THE

LOCAL GOVERNMENT, INCLUDING FEMA HEALTH EFFECTS. COMMON CONDITIONS ARE MORE SEVERE -- [INAUDIBLE]

WE'RE SEEING SEVERE FLOODING OF THE RIVER. ON PAGE TWO, AIR POLLUTION IN THE FORM OF -- [INAUDIBLE]

BRINGS ABOUT 49,000 -- [INAUDIBLE] BEING ASTHMATIC MYSELF -- [INAUDIBLE] LOW INCOME RESIDENTS ARE OFTEN IMPACTED -- [INAUDIBLE] TO ENJOY THE BENEFITS OF ENERGY

EFFICIENCY -- [INAUDIBLE] THIS IS N THE SOCIO ECONOMIC PEOPLE SEE AS SOLAR AND THE

POORER PEOPLE SUBSIDIZING THEM BUT -- [INAUDIBLE] WE HAVE TO DO BETTER FOR OUR

XHUN -- COMMUNITY AS A WHOLE. ON PAGE THREE -- I'M SORRY. THE CHANGING ENERGY BILL WOULD REQUIRE ACTION FROM GOVERNMENT, BUSINESSES AND COMMUNITY LEADERS, FACILITIES AND INDIVIDUAL CITIZENS. [INAUDIBLE]

>> MR. SWEEZEY? >> YES >> YOUR THREE MINUTES HAVE EXPIRED. >> THANK YOU FOR YOUR TIME THIS EVENING. >> THANK YOU. >> PATRICIA ALVAREZ? MARGARET

CARREIRO? >> IT'S WORKING. CAN YOU HEAR ME? >> YES, MA'AM. >> CAN YOU SEE AND HEAR ME? >> YES, MA'AM. >> OK. >> GOOD EVENING. I'M MARGARET

CARREIRO, RETIRED LOUISVILLE BIOLOGY PROFESSOR AND I'M HERE TO SUPPORT THE ORDINANCE BECAUSE I BELIEVE IT WILL BENEFIT NATURE, PEOPLE AND OUR STATE. WHY DO WE NEED A NEW ORDINANCE? WELL, THE OLD ONE, QUITE FRANKLY, IS AN ILL DEFINED, BLUNT INSTRUMENT THAT CAUSES PEOPLE WHO WANT NATURAL LANDSCAPES IN THEIR YARD GREATER RISK OF BEING CITED OR FINED BECAUSE OF VAGUE AND CONFUSING. THE ORDINANCE PROVIDES CLEAR GUIDELINES AND DEFINITION THAT REDUCES CONCERNS FOR PEOPLE WHO WISH TO REPLACE SOME OF THEIR LAWN WITH NATIVE PLANT GARDENS BUT ALSO, IT PROVIDES GUIDANCE. THE YARDS DO NOT LIKE UNMANAGED OR GIVE PEOPLE THE IMPRESSION THEY CAN PUT TURF GRASS ON HOMES. IT WOULD ALSO PROVIDE THE CLARITY NEEDED TO STIMULATE THE GROWTH OF NATIVE PLANT NURSERIES AND LANDSCAPING BUSINESSES HERE. ONE OF THE BENEFITS OF SPACE WITH NATURAL LANDSCAPES, FOR THE CITY AND PEOPLE, IT MEANS REDUCING AIR POLLUTANTS FROM LAWN MOWERS AND LEAF BLOWERS. THESE INCLUDE OZONE GASES, CARBON MONOXIDE AND NEIGHBORHOOD DUST POLLUTION THAT HARM LUNG AND HARM HEALTH. IT WILL IMPROVE GROUND WATER AND STREAM QUALITY SINCE NATIVE PLANTS REOUIRE LESS FERTILIZER AND NONE OF THE PESTICIDES

USED BY MANY TO MAINTAIN THAT PERFECT LAWN. IT MEANS REDUCING WATER CONSUMPTION FOR IRRIGATION BECAUSE NATIVE

PLANTS ARE BETTER ADAPTED TO LOCAL CLIMATES. THE BENEFITS FOR

NATURE? WELL, NATIVE PLANT GARDENS CREATE BETTER HABITAT FOR BENEFICIAL WILDLIFE, ESPECIALLY BIRDS AND NATIVE POLLINATORS LIKE BUMBLE BEES AND THE MONARCH BUTTERFLY THAT REQUIRES MILK WEED TO SURVIVE. SPECIES POPULATIONS ACROSS THE NATION ARE DECLINING WITH BREATH TAKING SPEEDS AND THIS INCLUDES BIRDS WHOSE POPULATIONS HAVE DECLINED 1 1/2 BILLION SINCE 1970. NATIVE PLANT GARDENS ARE PLAYING AN ESSENTIAL ROLE IN PREVENING LOCAL SPECIES EXTINCTION AS PART OF A COMMUNITY BASED CONSERVATION MOVEMENT BEING ENCOURAGED BY

ENVIRONMENTAL ORGANIZATIONS ACROSS OUR NATION. JUST THINK. OUR GARDENS CAN BECOME MORE THAN PLACES OF BEAUTY. THEY CAN BECOME A NEW KIND OF CONSERVATION SPACE, TOO. THIS

NATIVE PLANT GARDEN MOVEMENT IS TAKING OFF IN LOUISVILLE BECAUSE PEOPLE WANT TO ENGAGE MORE PERSONALLY WITH NATURE AT HOME AND ARE EXCITED ABOUT APPLYING NATURAL SOLUTIONS TO SOME OF THE ENVIRONMENTAL PROBLEMS OUR CITY FACES. BY REMOVING THE UNCERTAINTIES AND THE OUTDATED WEED ORDINANCE, THE REVISED ORDINANCE CAN START US ON A PATH TO CREATING HEALTHIER NEIGHBORHOODS AND A MORE SUSTAINABLE RELATIONSHIP WITH NATURE IN OUR CITY. AND THAT'S A WIN-WIN IF I EVER SAW ONE.

>> THANK YOU. I'M SO SORRY >> NO PROBLEM. MY NAME IS SARA AND I ALSO SUPPORT THE UPDATED WEED ORDINANCE AND I WOULD LIKE TO TELL YOU WHY I HOPE YOU WILL, TOO. I LIEU -- LIKE TO THINK OF MYSELF AS A CITIZEN SCIENTIST. I HAVE A DEGREE IN BIOLOGY AND

SPENT THE EARLY PART OF MY CAREER IN CLINICAL RESEARCH BUT MY TRUE CALLING IS WORKING WITH PLANTS AND THE LANDSCAPE. I

BEGAN TRAINING WITH LOCAL LANDSCAPERS WITH FOUR YEARS AGO AND I SEE A GROWING TREND IN OUR CLIENT TOWARD WANTING TO USE

BENEFICIAL NATIVE PLANTS WHENEVER POSSIBLE TO HELP COMBAT CLIMATE CHANGE AND SUPPORT LOCAL BIO DIVERSITY. NATIVE PLANTS

HAVE NATURALLY EVOLVED TO NOT ONLY THRIVE IN OUR LOCAL SOIL AND WATER CONDITIONS BUT ALSO TO BENEFIT OUR LOCAL BEES, BIRDS,

BUTTERFLIES AND WILDLIFE. I LOOK FOR OPPORTUNITIES TO IMPLEMENT PLANTS SUCH AS OAK TREES, BUTTON BUSH, SAGE AND PENNSYLVANIA

THEDGE RATHER THAN THE BURNING BUSH, HONEY SUCKLE AND TRADITIONAL LAWNS. BEING A GOOD STEWARD TO THE LAND IS SO

INTEGRATIONAL. A YEAR AGO I PURCHASED THREE WOODED ACRES WITH THE GOAL OF SAVING THE FOREST OF 30 TO 50-YEAR-OLD

TREES AND REINTRODUCING NATIVE TREES, SHRUBS AND NON WOODY PLANTS. THE FIRST FEW MONTHS I MONITORED AND ENCOURAGED THE

SPRINGTIME GROWTH AROUND THE PROPERTY TO LOOK FOR NATIVE PLANTS.

UNFORTUNATELY, IN EARLY JUNE I RECEIVED A \$100 CITATION

FROM CODE AND REGULATION BECAUSE THE GRASS WAS TOO TALL. AND THEY WARNED I NEEDED TO CUT IT DOWN IN SEVEN DAYS OR RISK BEING

FINED FURTHER BY THE CITY. EVEN AFTER LOCATING THE REGULATIONS WITHIN THE OVER 700 PAGE LAND DEVELOPMENT CODE FOR LOUISVILLE, I DID NOT FIND THE EXISTING WEED ORDINANCE EASY TO INTERPRET. MY DREAM OF MAKING A NATIVE PLANT OASIS IN THE CITY WAS SUDDENLY FEELING LIKE A NIGHTMARE. I FELT VERY DISCOURAGED ABOUT WHAT I WOULD BE ALLOWED TO GROW ON MY OWN LAND AND FEARFUL THAT CODE ENFORCEMENT WOULD BE CONSTANTLY LOOKING OVER MY SHOULDER. THIS UPDATED ORDINANCE PROVIDES MUCH CLEARER GUIDANCE, INCLUDING DEFINITIONS AND BENEFITS OF NATIVE PLANTS AND CLARIFICATION OF MAINTENANCE GUIDELINES FOR TURF GRASS LAWNS VERSUS NATIVE GRASSES. THIS IS MUCH MORE HELPFUL AND EASES MY CONCERNS ABOUT PLANTING NATIVE PLANTS ON MY LAND. THANK YOU. >> THANK YOU. REVEREND GEORGE MAYES, JUNIOR? ARE YOU THERE? >> CAN YOU HEAR ME? >> YES, SIR. WE CAN. >> OK. YES. MY NAME IS REVEREND GEORGE MAYES AND I'M CALLING, I MEAN, I'M SPEAKING ON BEHALF OF DISTRICT THREE. I LIVE IN THE PROSPECT AREA. RIDGE IS MY COUNCIL MEMBER. I CONTACTED HIM TO KNOW I WOULD BE SPEAKING ON TAR THREE. I AM A NATIVE OF LOUISVILLE. I JUST RETURNED A COUPLE OF YEARS AGO AND NOW I DEPEND ON THE SERVICE OF TAR THREE. AT THE CURRENT TIME, LIVING IN RENO, I WAS ON THE BOARD OF DIRECTORS FOR ACCESS AND I HAVE PERSONAL EXPERIENCE AND THEY DIDN'T PROVIDE ADEQUATE SERVICE FOR THE CITY OF RENO, NEVADA AND SO AFTER GIVING THEM A CHANCE TO PROVIDE ADEQUATE SERVICE AND CLIENT SERVICE TO INDIVIDUALS RIDING THE SERVICE, THEY FAILED TO MEET THE STANDARDS OF THE A.D.A. SO THE BOARD DECIDED TO TERMINATE THEIR CONTRACT. AND NOW THAT I'M LIVING IN LOUISVILLE, TAR 3 IS THE PROVIDER. I'M AFRAID TO RIDE THE SERVICE BECAUSE OF THE CURRENT COVID SITUATION BUT ALSO BECAUSE BEING LEFT AND I HAVE PERSONALLY CALLED THE MAYOR'S OFFICE AND TRIED TO SPEAK TO THE DEPUTY MAYOR ABOUT MY CURRENT CONCERNS AND NEVER HAVE GOTTEN A CALL BACK. I ALSO EMAILED SO I JUST AM DISAPPOINTED. I KNOW THAT WE COULD DO BETTER THAN THIS. DISABLED PEOPLE ARE -- WE PAY OUR TAXES, WE ARE CONSUMERS AND EVERY RIDE IS ESSENTIAL. WE WOULDN'T BE RIDING IF IT WASN'T ESSENTIAL. I THANK YOU FOR THIS OPPORTUNITY. THANK YOU. >> THANK YOU. MR. PRESIDENT. THAT CONCLUDES THE ADDRESSES TO COUNCIL. >> THANK YOU, MADAM CLARK. SO NOW, THE FINAL THING I'LL SAY, AND THIS WAS BROUGHT UP DURING THE DEBATE AND IT'S A GOOD POINT. MEDIUM DENSITY IS DESCRIBED AS 12 UNITS PER ACRE OR LESS.
