(Pursuant to Louisville Metro Ordinance Section 21.03)

Metro Officers, as defined in LMCO Section 21.01, are required to file this Financial Disclosure Statement no later than April 30 of each year. A newly appointed Metro Officer must file this statement no later than twenty-one (21) days after the date of appointment. A candidate for an elected Metro Officer position must file this statement no later than thirty (30) days after the date on which the person becomes a candidate for that elected office.

Metro's ordinance includes a relatively narrow definition of family ("Disclosure-Reporting Relationship") for most disclosures and a much broader definition ("Relative") for a few disclosures involving known interactions with Louisville Metro Government. Definitions of those terms are at the end of this document and should be reviewed before completing the statement.

Nothing in the ordinance or any section of this statement requires any Metro Officer or candidate to disclose any specific dollar amounts nor the names of individual clients or customers of businesses listed as sources of income in any section of this statement.
