Gina Enneking read from the Plan 2040 (see recording for detailed presentation). The area is meant to be rural/natural and the character is supposed to be rural residential, R-R and agricultural (see recording for detailed presentation).

John Smith said his property is very close to the proposed property's entrance. The traffic is heavy currently and safety may be an issue later. Other concerns are as follows: noise; size; and property values (see recording for detailed presentation).

Cheri Stillwell said the proposal will have a huge impact. Increased traffic will increase accidents (see recording for detailed presentation).

Brian Gillis said he has seen an increase of collisions in front of his house. The proposed right-turn lane won't help much (see recording for detailed presentation).

Dr. Davis Chrisman said he agrees with the previous speakers. The roads are country roads (see recording for detailed presentation). This is one of the few green zones remaining in the Louisville Metropolitan area and the air quality will be significantly impacted (see recording for detailed presentation).
