WITHOUT FURTHER ADO I WOULD LIKE TO INTRODUCE TO YOU MAYOR GREG FISCHER TO INTRODUCE THE 22-23 BUDGET.

>>THANKS EVERYBODY.

I THINK OF MUHAMMED ALI, LOUISVILLE'S FAVORITE SON, HE ONLY COUNTED HIS SIT UPS WHEN THEY STARTED HURTING BECAUSE THEY ARE THE ONLY ONES THAT COUNT. OUR BUDGET REMINDED ME OF THOSE SIT-UPS, OUR CHOICES WERE OFTEN PAINFUL.

THAT IS NOT THE CASE TODAY, BECAUSE THE RESOURCES WE NOW HAVE.

TODAY I AM PRESENTING TO YOU THE OPERATING CAPITAL BUDGETS FOR FISCAL YEAR 23, AND OUTLINING THE FEDERAL AMERICAN RESCUE PLAN WILL IMPACT OUR CITY OVER THE COMING YEARS WITH POTENTIALLY 1 BILLION DOLLARS COMING OUR WAY.

WE HAVE NEVER SEEN THIS AMOUNT OF FUNDING FROM THE FEDERAL GOVERNMENT PLUS FUNDS FROM CARES AND THE EMERGENCY RENTAL ASSISTANCE PROGRAM.

CAN I GET AN AMEN TO THAT?

WE'VE BEEN WAITING FOR A BUDGET LIKE THIS.

LET'S REMEMBER WHAT A BUDGET CAN PRODUCE.

THE PAST 11 BUDGETS HAVE PAID OFF.

AMONG THOSE INVESTMENTS THE OHIO RIVER BRIDGES PROJECT WITH 32 MILLION VEHICLE CROSSINGS LAST YEAR.

THE EXISTENCE OF THESE BRIDGES AFTER 40 YEARS OF DISCUSSIONS SHOWS OUR PROGRESS.

20,000 PEOPLE MOVING OUT OF POVERTY AND ANOTHER 20,000 FAMILIES MOVING INTO HE MIDDLE CLASS.

MORE THAN \$475,000,000 FOR AFFORDABLE HOUSING, EVICTION PREVENTION, HOME REPAIRS AND TACKLING HOMELESSNESS.

80,000 NEW JOBS, 3,500 NEW COMPANIES.

MAKING LOUISVILLE A SOCCER CITY WITH MEN'S AND WOMEN'S AND YOUTH TEAMS.

WE WERE NAMED ONE OF THE BEST SOCCER CITIES IN AMERICA.

CREATING A NEW HOSPITALITY CONCEPT, URBANISM.
WITH LOUISVILLE AS A TRAILHEAD WITH 10 NEW
DISTILLERY AND BOURBON EXPERIENCES, WITH WHISKEY
ROW AND 15 NEW HOTELS IN DOWNTOWN ALONE.
UNPRECEDENTED INVESTMENTS IN OUR RESIDENTS IN PARKS,
LIBRARIES, HEALTHCARE SO MANY AREAS THAT MADE
DIFFERENCES IN PEOPLE'S LIVES.

WE LAID THE GROUNDWORK IN THE BUDGET I AM PRESENTING TODAY TO PLANT SEEDS FOR EVEN MORE PROGRESS. THE STRONG ECONOMY SHOWS THAT METROS IS RETURNING TO PRE-PANDEMIC REVENUE LEVELS.

SO BRIEFLY THE OVERALL BUDGET IS INCREASING FROM \$1.1 BILLION DOLLARS TO \$1.3 BILLION DOLLARS.
OUR GENERAL FUND IS \$715 MILLION DOLLARS REFLECTING AN INCREASE OF \$57 MILLION OVER THE CURRENT YEAR.
BECAUSE OF FEDERAL FUNDING WE ARE ABLE TO PRESENT A CAPITAL BUDGET OF \$343 MILLION DOLLARS COMPARED TO \$167 MILLION IN FY 22.

WE KNOW A BUDGET IS MORE THAN NUMBERS.

IT'S A STATEMENT ABOUT OUR VALUES.

THIS WILL BE MY LAST PROPOSED BUDGET AS MAYOR.

I AM ASKING TO WORK TOGETHER TO PUT OUR MONEY WHERE OUR VALUES ARE.

OUR VALUES ARE ALL ABOUT IMPROVING HEALTH,

CONTINUING DEDICATION TO LIFELONG LEARNING, AND BE A COMPASSIONATE CITY.

AT THE BEGINNING OF MY FIRST TERM, BECAUSE OF A

HISTORIC RECESSION WE FACED A \$22.5 MILLION

DEFICIT, 10% UNEMPLOYMENT AND TREMENDOUS ANXIETY.

IN A YEAR AND A HALF INTO BEING ELECTED INTO A THIRD

TERM, WE EXPERIENCED A PANDEMIC, AND CALLS FOR

RACIAL JUSTICE ACROSS THE COUNTRY.

BETWEEN THOSE CHALLENGES WE RESHAPED OUR GOVERNMENT TO REFLECT 21ST CENTURY REALITIES AND PLAN FOR OUR

FUTURE FOR ALL AREAS OF LOUISVILLE.

AS IN LIFE WE MUST CHANGE OR WE WITHER AWAY.

WE HAVE RESPONDED BY RESHAPING AND MODERNIZING

GOVERNMENT TO MEET CHALLENGES AND SEIZE ON OPPORTUNITIES.

THAT MODERNIZATION IS WHY WE CREATED AN OFFICE FOR

SAFE AND HEALTHY NEIGHBORHOODS, AN OFFICE

FOR EQUITY, LOUISVILLE FORWARD, AN OFFICE FOR

SUSTAINABILITY, AN OFFICE FOR PERFORMANCE

IMPROVEMENT AND INNOVATION, GLOBALIZATION

AND ONE WATER, WHICH HAS HELPED KEEP CONSUMER RATES

LOWER AND IS WORKING TO REGIONALIZE WATER AND

WASTEWATER SERVICES.

OUR STEWARDSHIP TOGETHER HAS ALSO MEANT BALANCING

THE BUDGET WHILE MAXIMIZING EFFICIENCY OF

REVENUE GENERATED BY HARDWORKING TAX PAYERS.

THIS OVERSIGHT HAS REQUIRED A LOT OF

DIFFICULT DECISIONS.

IN 2011 WHEN I TOOK OFFICE, WE HAVE 5,400 FULL

TIME EMPLOYEES.

NOW WE ARE RIGHT AROUND 5.000.

SOME OF THIS WAS BECAUSE OF INTENTIONAL

EFFICIENCIES, HARD CHOICES ALSO HAD TO BE MADE.

WE HAVE CONTINUED TO DELIVER SERVICES AND GROW AS A CITY, WHILE HAVING FEWER AND FEWER EMPLOYEES TO DO THE WORK.

WE HAVE BEEN RECOGNIZED NATIONALLY FOR THIS.

LOUISVILLE IS ONE OF ONLY TWO CITIES TO ACHIEVE

PLATINUM CERTIFICATION FOR OUR USE OF DATA TO GUIDE OUR WORK.

AND TO ACHIEVE TOP BOND RATINGS, AAA AND A1 FROM FITCH AND MOODIES.

WE HAVE RECEIVED THESE RECOGNITIONS BECAUSE OF MEASURABLE, QUANTIFIABLE RESULTS.

FOR INSTANCE, WE MADE 21 1/2 MILLION DOLLARS IN CAPITAL

INVESTMENTS WHICH ARE NOT JUST BRICK AND MORTAR, THEY TRANSFORM THE COMMUNITY AND THE PEOPLE WHO LIVE THERE.

THEY'VE INCLUDED NEW LIBRARIES IN SOUTH CENTRAL, SOUTHWEST AND EAST LOUISVILLE.

-- COLONIAL GARDENS AND OTHER PLACES.

NORTON HEALTHCARE SPORTS AND LEARNING CENTER, THE WEST END OPPORTUNITY PARTNERSHIP AND THE WESTWARD EXPANSION OF WATERFRONT PARK.

[APPLAUSE]

THIS FISCAL YEAR ALONE, WE COMPETED FOR AND WON 43 BUSINESS ATTRACTION AND EXPANSION PROJECTS WITH THE FINANCIAL COMMITMENT OF MORE THAN \$1 BILLION AND OVER 4,300 JOBS.

OUR ECONOMIC DEVELOPMENT FOCUS KEEPS OUR ECONOMY PUMPING THROUGH

THE PANDEMIC AND INFLATION. IT IS WELL-DESIGNED TO GROW AND WITHSTAND DOWNTURNS. LOGISTICS WILL CONTINUE TO GROW WITH INCREASING ONLINE ACTIVITIES. STAGING AND WELLNESS SECTOR WILL GROW WITHIN OLDER AMERICA.

ADVANCED MANUFACTURING WILL CONTINUE TO GO TAND EXPAND FIELDBUS FINANCE FROM THE RECENTLY ELECTRIC BATTERY MANUFACTURING PLANTS. AND FOOD AND BEVERAGE WILL CONTINUE TO SURGE.

IT'S NOT JUST NUMBERS. YOU CAN SEE IT ALL AROUND YOU.

WORKERS AND CONVENTIONEERS ARE RETURNING TO DOWNTOWN. JUST LAST WEEK, LOUISVILLE WELCOMED 12,000 CONVENTION GOERS TO THE CITY.

AND IT WAS GREAT TO SEE OUR SIDEWALKS, COFFEE SHOPS, HOTELS AND BUSINESSES ONCE AGAIN BUSTLING WITH PEOPLE.

WE MUST RECOGNIZE THE DOWNTOWNS ARE FOREVER CHANGED BY THE PANDEMIC. THE MANY OFFICE JOBS ARE NOW BEING DONE FROM HOME. SO THE COMMUNITY WILL WELCOME LOUISVILLE DOWNTOWN PARTNERSHIPS UPCOMING 10 YEAR STRATEGIC PLAN TO HELP US ADDRESS THE SHIFT. THE OVERALL RESEARCHING ECONOMY IS WHAT FUNDS THE BUDGET AND IS ECONOMIC ENGINE OF THE STATE, THE ENTIRE COMMONWEALTH BENEFITS

FROM OUR HARD WORK AND SUCCESSES. THIS BUDGET PROPOSAL WILL CONTINUE THE MOMENTUM.

IT KEEPS PUBLIC SAFETY AS PARTY NUMBER ONE, IT MAINTAINS RESPONSIBLE EYE ON EXPENSES, DEDICATED TO DELIVERING QUALITY MODERN SERVICES THROUGH CONTINUOUS IMPROVEMENT AND INNOVATION AND

IT IS DONE WITH AN EQUITY LENS IN ALL OF OUR OPERATIONS AND EFFORTS. LET'S START WITH PUBLIC SAFETY.

AS IT HAS BEEN THROUGHOUT MY THREE TERMS AS MAYOR, PUBLIC SAFETY REMAINS MY NUMBER ONE PRIORITY. NOTHING ELSE MATTERS IF OUR PEOPLE ARE NOT SAFE AND ABLE TO LIVE

AND WORK COMFORTABLY THROUGHOUT OUR CITY.

WE ARE CURRENTLY EXPERIENCING A REDUCTION YEAR TO DATE OF 15 PERCENT AND VIOLENT CRIME, 35 PERCENT REDUCTION IN SHOOTING, AND OVERALL REDUCTION IN THE CRIME RATE OF EIGHT PERCENT.

BUT IT IS NO SECRET GUN VIOLENCE IS A PROBLEM ALL ACROSS AMERICA AND RIGHT HERE AT HOME.

OUR CRIMINAL HOMICIDE NUMBERS ARE ABOUT THE SAME AS LAST YEARS. THAT JUST REMAINS UNACCEPTABLE.

WITH THAT FIRST GROUNDED IN COMMUNITY INVOLVEMENT WE ARE FUNDING LAW ENFORCEMENT, VIOLENCE INTERRUPTION PROGRAMS AND INITIATIVES TO REBUILD TRUST BETWEEN POLICE AND THE COMMUNITY THAT THEY SERVE.

AS THE CITY OF BREONNA TAYLOR LOUISVILLE HAS A RESPONSIBILITY TO LEAD AMERICA REBUILDING TRUST.

[APPLAUSE] WE CAN BE PRO-REFORM AND PRO-POLICE.

WE CAN BE PRO-ACCOUNTABILITY AND FOR THOSE WHO CONTINUE TO COMMIT VIOLENT CRIMES, PRO-INVESTMENT IN THE YOUNG PEOPLE.

SO THEY NEVER GO DOWN A PATH OF VIOLENCE.

THIS BUDGET FUNDS THREE LMPD CLASSES BRINGING HEADCOUNT TO 1,100 BY THE END OF FISCAL YEAR 23 INCLUDING LATERAL AND REHIRES. THIS IS PART OF A THREE-YEAR PLAN TO GET LMPD STAFFING UP TO 1,200 BY THE END OF FISCAL YEAR 25.

TO ENHANCE TRAINING WERE ALLOCATED \$6 MILLION FOR THE FIRST PHASE OF BUILDING A NEW FACILITY WITH LAND ACQUISITION AND DESIGN. OUR GOVERNMENT APPROACH TO PUBLIC SAFETY ALSO CONTINUES A ROBUST NON-LAW ENFORCEMENT RESPONSE TO VIOLENCE IN OUR COMMUNITIES THROUGH A NUMBER OF EFFORTS. WE CREATED THE OFFICE FOR SAFE AND HEALTHY NEIGHBORHOODS IN 2,013, TO DEVELOP AND NURTURE SAFE NEIGHBORHOODS WHERE EVERYONE IS SECURE.

FREE OF VIOLENCE AND PREPARED FOR SUCCESS. WITH FEDERAL ARBOR FUNDS, WE'VE ONLY RECENTLY BEGUN TO ADEQUATELY FUND THIS CRITICAL WORK AND THE BUDGET CONTINUES THAT FUNDING.

OUR GROUP VIOLENCE INTERVENTION PROGRAM BRINGS TOGETHER LAW ENFORCEMENT, SOCIAL SERVICES AND FAITH-BASED PARTNERS TO CONNECT

WITH THE DRIVERS OF VIOLENCE TO PREVENT FURTHER VIOLENCE TO BUILD TRUST AND SUPPORT AT RISK RESIDENTS IN THE ENHANCED ACCOUNTABILITY FOR PARTICIPANTS.

OUR OFFICE OF YOUTH DEVELOPMENT ADVOCATES FOR YOUTH TO HELP ACHIEVE EQUITABLE HEALTHY AND HAPPY LIVES USING IN HALF MILLION DOLLARS TO OVER THREE YEARS CREATE A DATA-DRIVEN YOUTH DEVELOPMENT SYSTEM TO 10 TO 24-YEAR-OLDS.

PUBLIC SAFETY ALSO MEANS GIVING KIDS SAFE PLACES TO BE OFF THE STREETS AND OUT OF TROUBLE. ESPECIALLY AT THE TIME OF DAY WHEN PARENTS ARE NOT AT HOME.

THAT'S WHY I PROPOSE A \$412,000 TO EXPAND THE HOURS IN PROGRAMMING THAT THE COMMUNITY CENTERS HAVE.
[APPLAUSE]

AN IMPORTANT PUBLIC SAFETY INITIATIVE WITH OUR COMMUNITY AMBASSADORS PROGRAM. INVESTIGATORS WORK BLOCK BY BLOCK IN DOWNTOWN, WATERFRONT PARK, WEST AND SOUTH OF LOUISVILLE AND ANSWERING OUESTIONS AND KEEPING

AREAS CLEAN. WE PROPOSE A \$180,000 FOR THAT PROGRAM.

WE KNOW CLEANLINESS SETS THE TONE OF THE CITY AND WE HAVE SEEN GREAT RESULTS WITH CLEAN COLLABORATIVE.

WHICH BRINGS TOGETHER EMPLOYEES FROM THROUGHOUT METRO GOVERNMENT

TO COORDINATE AND MAXIMIZE EFFORTS TO KEEP THE NEIGHBORHOODS CLEAN. THAT'S WHY WE ARE ADDING \$500,000 TO EXPAND THEIR GOOD WORK. AND BECAUSE SAFE AND SMOOTH ROADS AND SIDEWALKS ARE ALSO CRITICAL FOR EACH AND EVERY NEIGHBORHOOD, THIS BUDGET INCLUDES \$22 MILLION FOR ROADS AND SIDEWALKS, AND \$500,000 FOR SCOOTER AND BIKE LANES. THAT IS ON TOP OF 2,000 MILES OF ROADS WE PAVED SINCE I TOOK OFFICE.

FISCAL YEAR 23 PROJECT SPANNED THE CITY. AND INCLUDE SOUTH WATERSON TRAIL FROM BARDSTOWN TO -- MORE IMPROVEMENTS FOR DIXIE HIGHWAY, AND CATAWBA STREET AND VIRGINIA

AVENUE TO WILSON AVENUE.

THE KENTUCKY GENERAL ASSEMBLY RECENTLY PASSED ITS BIANNUAL ROAD PLAN INCLUDING ALMOST \$,380 MILLION IN PROJECTS FOR LOUISVILLE SUCH AS THE WIDENING AND REALIGNMENT OF US 60, EXTENSION PROJECT, PLANT SIDE DRIVE THAT INCLUDED THREE LANE ROUTE AND BICYCLE AND PEDESTRIAN ACCOMMODATIONS. AND DESIGN MADE TO IMPROVE SAFETY AT THE SOUTHBOUND RAMP OF I-65 AT BROOK STREET.

TO BUILD ON EFFORTS, INTEGRATE THE CRITICAL TRUST NEEDED BETWEEN LAW ENFORCEMENT AND COMMUNITIES THEY SERVE, THIS BUDGET CONTINUES TO FUND THE RECOMMENDATIONS OFFERED BY THE -- REPORT AND TRUTH OF TRANSFORMATION AND LEAN INTO LOUISVILLE EFFORTS.

THE VERY PROMISING POLICE ACTIVITIES LEAGUE TO BUILD CONNECTIONS BETWEEN YOUTH AND POLICE WILL EXPERIENCE ITS FIRST FULL YEAR OF ACTIVITY.

OTHER AREAS OF PUBLIC SAFETY, FOR FIREFIGHTERS, \$1.4 MILLION FOR A BURN BUILDING ESPECIALLY STRUCTURE USED TO TRAIN FIREFIGHTERS PLUS FUNDING FOR LOUISVILLE FIRE RECRUIT CLASS WILL START MAY 2.023.

WE WILL FUND SECURITY, SAFETY AND FACILITY IMPROVEMENTS FOR THE DEPARTMENT OF CORRECTIONS. INCLUDING A \$3.7 MILLION CAPITAL INVESTMENT FOR EXPANSION OF CAMERA SYSTEMS, ADDITIONAL MONITORING EQUIPMENT FOR THE

OBSERVATIONS OF HIGH-RISK INMATES, AND MORE BODY SCANNERS AT ENTRANCES.

AND IN EMERGENCY SERVICES, WE WILL CONTINUE FUNDING FOR THE 911 CALL PRIORITIZATION AND DEFLECTION PROGRAM. WE LAUNCHED THE PILOT PROGRAM LAST MONTH AND ARE ADAPTING AS IT

MOVES FORWARD WORKING TO REDUCE POLICE RESPONSE FOR PEOPLE THAT NEED HELP BUT DON'T NEED THE POLICE. THE BUDGET ALSO INCLUDES ALMOST 11 1/2 MILLION DOLLARS TO

COMPLETE A \$29 MILLION STATE-OF-THE-ART COMPUTER DISPATCH AND RECORDS MANAGEMENT SYSTEM.

WE ARE INVESTING \$1.25 MILLION IN A NEW MOBILE EMERGENCY OPERATIONS CENTER.

TWO WEEKS AGO, WHEN A TORNADO HIT NEAR FERN CREEK, OUR MOBILE CENTER WAS PULLED OFF OF A S.W.A.T.

CALL OUT TO HELP RESPOND TO THE TORNADO.

AS WE SEE MORE WEATHER RELATED EMERGENCIES, IN A VEHICLE WITH THE MOST UP-TO-DATE TECHNOLOGY IS CRITICAL FOR REDUNDANCY.

WHAT YOU JUST HEARD IS A LIST OF AGGRESSIVE INVESTMENTS TO MAKE THE CITIES SAFER AND MORE SECURE.

WE MUST JUST AS AGGRESSIVELY, FUND TOOLS TO LIFT UP EACH INDIVIDUAL SO THEY CAN ALL ACHIEVE SUCCESS AND HAPPINESS. ONE OF THE MAIN REASONS I RAN FOR ONE THIRD TERM, WAS TO ENSURE

FUNDING FOR OUR EVOLVE 500 TO PROMISE SCHOLARSHIP PROGRAM.

THIS COMMUNITY PARTNERSHIP WORKS TO ENSURE EVERY JCPS STUDENT CAN GO TO COLLEGE TUITION FREE.

TO DATE, EVOLVE 502 HAS RECEIVED ENOUGH FUNDING SO ALL STUDENTS EIGHTH GRADE AND UP, ARE ELIGIBLE.

BY ASSURING ACCESS TO COLLEGE EDUCATION, FOR PUBLIC SCHOOL STUDENTS, WE ARE REMOVING THE NUMBER ONE BARRIER TO POVERTY. THIS IS ONE OF THE GREAT ACCOMPLISHMENTS THAT WE HAVE ACHIEVED TOGETHER.
