The mailings were sent yesterday from the 7th st Post Office as soon as I left your office.

Thank you for taking the time to review my application for an exception to the 600 Foot rule.

- 1. There are 27 parcels listed as APOs as identified during my meeting with Planning and Design. 10 of those parcels are zoned Commercial/Industrial or Business/Office. Additionally I am only one parcel away from neighboring a commercially zoned property.
- 2. When I completed both the pre-application and the formal application, there were no other approved CUP at that time. The recently approved CUP is approximately 580 feet away from my property. My delay in the application was to ensure that the property was a safe place to hold my neighborhood meeting.
- 3. The property has been prepared to have out of town guests. A 20' x 22' off street parking pad was installed to allow for 2 offstreet parking places. An electrician is in the process of installing exterior motion lighting, and wiring the home for exterior cameras. These items are to ensure the safety and allow for remote monitoring of the property.
- 4. As the owner and the host, I live approximately 2.6 miles away from the property.

As you know this case is scheduled for the June 13 BOZA meeting. Based on the BOZA meeting yesterday staff learned that we will not have a quorum for June 13. There are two options for you to consider in this situation.
