As you know, Gagel Farms sits in the middle of many established neighborhoods that have existed and grown organically for decades. Dropping 1k additional people right smack in the middle of the neighborhoods will be a recipe for disaster regarding traffic, crime, and noise/visual pollution. The surrounding roads are already too congested and the stores overcrowded. Grandel Farms will now be sandwiched on both sides by section 8 housing, the existing side (Feyhurst) already leads to high crime in and around our neighborhood. Auto break-ins have been increasing in the neighborhood with one resulting in shot fired at the homeowner, and the residents are STILL reeling from the hit and run incident where a heroin influenced driver ran over and killed a young boy in front of his parents while riding his bike through our neighborhood. These are \$300k+ homes that people have spent their life obtaining and maintaining. If you allow the property value to plummet to squeeze in some unnecessary apartments this will be the final nail in the coffin for the south end. The people in these neighborhoods grew up in the south end, they stayed in the south end after obtaining higher education and well paying jobs (while many others fled to safer, nicer parts of town), they wanted to stay true and help the south end grow and succeed the way they remembered it growing up. If you take away the remaining strongholds by watering them down with low-income housing, you will be saying goodbye to your college educated, high salary constituents.

Does all of that sound snobby? Yes it does, but it is a fact that property values, safety and quality of life will plummet in surrounding areas with this development. Low income options are great. Building low income options at the expense of high income neighborhoods is NOT great. There are plenty of other locations around Louisville that they can be built without complete disruption to the surrounding neighborhoods, ones with crucial resources such as bus lines, grocery stores and pharmacies nearby. This location is not that. This will affect a large number of your voters and the future of your district. Please take these concerns very seriously and let us know that you will help protect our neighborhoods from over-development.

Please do not approve the rezoning of the Gagel Farm property for low income apartments. The surrounding area consists of decades old, organically grown, established neighborhoods. Dropping 1k new people on a small plot will create a logistical nightmare for the people in the region. Traffic is already bad on the main roads, the sight-lines will be ruined, littering will be rampant, the stores overcrowded (they already are!), and crime will increase. The cut-through traffic and speeding in local neighborhoods is so bad we have had to erect speed bumps (finally approved after a young boy was killed in front of his parents by a heroin-influenced driver while said boy was riding his bike on a neighborhood sidewalk). Hunters Point and Grandel Farms are 2 of a very small handful of higher income housing in PRP, dropping low income housing in the middle of these neighborhoods will not bring up the quality of low income areas, it will instead cause the few remaining higher value areas to plummet. Many of us have roots in the south end going back multiple generations. As a 40 year old, many of my peers that have been educated and out-earn their parents made an immediate dash to the east end. Some of us stayed around, injecting our paychecks back into the place we grew up in an effort to rejuvenate the area....and we have been quite successful to date as evidenced by the business boom on Dixie the last 10-15 years. Unfortunately, the city's efforts to plant low-income apartments on any and every empty plot of land in-between our safe, established neighborhoods is seriously undercutting our efforts. Grandel Farms is already bordered by lowincome, extremely HIGH crime apartments to the south. Adding another 190 units to the north makes the neighborhood a direct route connecting the 2, effectively killing the value of the neighborhood overnight for everyone that has invested their life's savings into their homes here.

My family and neighbors have recently found out about the planned affordable housing apartment complex being planned on Lower Hunters Trace. My in-laws and I both reside on Nigel Dr., which is about a block and a half from the proposed site. We live in the Wilke Heights neighborhood directly across from the property (off of Mt Everest). We received no notifications of the proposed building plans and were only alerted to the issue through Facebook postings on our neighborhood group pages.

Everything I have seen so far says that the complex is supposed to have an urban feel. The surrounding neighborhoods are suburbs. The residents have chosen a suburban lifestyle and the majority have no desire to make our part of town more city like. Many of the residents in these neighborhoods have been here for multiple decades, including my husband, who grew up on Nigel Dr, and his parents. There are so many negative effects that this complex will bring and we hope you consider the pleas of the community and place the complex elsewhere.

Traffic on Lower Hunters is already heavy. Getting out of the neighborhood at Mt Everest is already difficult depending on the time of day. By adding a complex that holds hundreds of additional residents, it will gridlock an already overpopulated traffic situation. We received no notifications of the proposed building plans and were only alerted to the issue through Facebook postings on our neighborhood group pages.

As a lifelong resident of Pleasure Ridge Park in Southwest Jefferson County, who lives less than five minutes from the proposed construction site, and as someone who after becoming the first person in my family to earn a degree only to end up back home, cohabitating with my parents due to medical bills and student loans; I am very concerned about Louisville's lack of low-income and affordable housing.

In the past year, Louisville's homeless population has increased exponentially. This past February, we experienced record low temperatures and thousands of people including battered women, innocent, children, and our veterans had no shelter. Our Metro Government had put aside no emergency funds and were it not for local groups such as Hip Hop Cares providing necessities and Douglass Boulevard Christian Church raising money to put them up in hotels, hundred of our neighbors would have frozen to death.

Louisville has a severe lack of affordable housing and the cost of rent (let alone buying a home) isn't affordable for a person making minimum wage, working full-time in any U.S. state.

I have worked hard my entire life. I graduated high school valedictorian, earned \$60,000 scholarships, and graduated college with honors. Thank you and your constituents for taking the time tonight to hear from the community regarding the proposal for Gagel Farm.

I'd to to summarize some of the concerns we voiced in tonight's meeting.

- 1. a. Please consider two-story, or single story units near homeowners on Cady and countering Gagel's asking price to accommodate.
- 1. b. 3-stories. There's another development of 3-stories nearby on cane run (LIH) and those neighbors look at skyscrapers (see pic below).
- 1. c. No privacy in our back yards from three stories. Many of us have women and children that play in our pools. I have two daughters. Also, neighbors across the street complain of noise and lack of privacy from the 2 story apts. in existence. Please consider, as the local realtor suggested, keeping it r4 for the cady side, or at least single-story.
- 1. d. How tall (age) will the trees be and evergreen? Please consider evergreens of at least 5 years old, (see picture below of immature deciduous trees that will only provide privacy for 6months out of the year after several years) for the neighbors that back up to Cady and join the property with a buttress for sound, light, privacy, etc.
- 2. Drainage. We already have drainage problems and have a concrete culvert built along Cady to try and deal with it. MSD even recently regraded our front yards in still more effort to deal with the runoff during these heavy storms we get living just a couple miles from the Ohio River.
- 3. a. Traffic: 2lanes with no left hand turning lane max 10,000 AADT. Lower Hunters already had 12930 AADT in 2018 (+17.48% over 2015) so likely 15,000+ in 2021, or 50% above the max level. 192 units would add 1344 to that number, or +10% based on a small % of frontage.

3. b. Studies have shown that living within 100m of a major thoroughfare (20,000AADT) increases risk of
heart attack and stroke by up to 30% and also increases developmental delays in children. The pollution from
Lower Hunter's trace already is not an insignificant issue given it's a residential street.

- 4. Additionally, if you could lease limit noise (car stereo's, partying, etc...) from the residents by having a strict no-tolerance policy. I'm sure you would given how nice Moss creek appears to be from greenwood.
- 5. Also, please keep trash collection away from the neighboring residences.
- 6. You did a great job of addressing light pollution with regard to downward pointing and limiting the foot candles, but if you could consider using amber lights, as opposed to the LED bright white, it would give it a much better neighborhood and less industrial feel.
