

UPON ARRIVAL THERE WAS A SMALL TRAILER WITH APPROXIMATELY 24 CARDBOARD BOXES OF ASSORTED MEAT FOR RETAIL STORE. STORE OWNER LES STATED THAT HE HAD PICKED IT UP FROM MANUFACTURER APPROXIMATELY 2 HOURS PRIOR. TEMP CHECKS FROM RANDOM BOXES WERE TAKEN AND ALL MEAT WAS STILL FROZEN WITH EXCEPTION OF TOP INDIVIDUAL PACKAGES OF MEAT IN TOP BOXES. TEMPS FOR THIS TOP LAYER WERE 43°F AROUND EDGES OF MEAT CUTS. ALSO TOOK TEMPS OF SUPPLY INSIDE WALK IN COOLER WITH ALL TEMPS BELOW 45°F. INSTRUCTED STAFF TO UNLOAD MEAT SUPPLY WHICH THEY IMMEDIATELY DID AND PLACED ALL OF IT IN WALK IN COOLER. SPOKE TO OWNER LES DURING TODAY'S VISIT. LES ADVISED THAT HE IS PURCHASING THE BUILDING AND IS HAVING THE ROOF AND OUTER OPENINGS REPAIRED. NO GARBAGE/CARD-BOARD PRESENT DURING TODAY'S VISIT AS CITED IN COMPLAINT REPORT. LES STATED THAT EVERYTHING WAS Hauled AWAY YESTERDAY AS ORDERED TO DO SO BY CODE ENFORCEMENT/IPL. OUTSIDE BUILDING PERIMETER WAS CLEAN & MAINTAINED PROPERLY TODAY. ON INSIDE OF STORE THERE WAS NOT ANY INSECT/RODENT PROBLEMS OBSERVED DUE TO OUTER OPENINGS NOT PROTECTED. 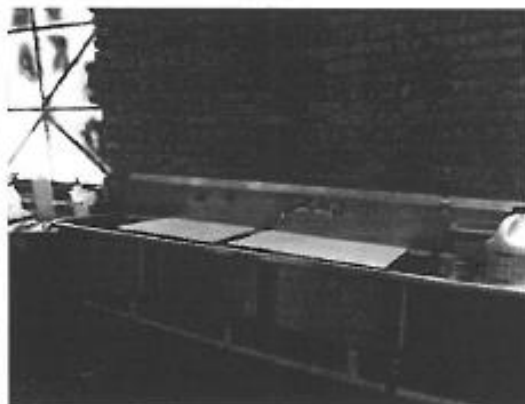
