The Committee schedule also includes two opportunities for the public to speak about the budget, via WebEx. Those public hearings, conducted virtually, are scheduled for May 7 at 5:00 pm and May 13 at 6:00 pm. Beginning May 4, the Metro Council Clerk's website will have information about signing up to speak at the meeting via WebEx. All applicants for External Agency funding who wish to speak about their applications or funding (it is not required) are strongly encouraged to speak on May 7.
