AND FOR THE LAST 16 YEARS WITH THE METROPOLITAN HOUSING
COALITION, THE LAST 15 YEARS AS EXECUTIVE DIRECTOR OF THE
COALITION.

I WILL MISS WORKING WITH KATHY A LOT OF ISSUES BUT MORE

PEOPLE COME TO LOUISVILLE DUE TO THE CENTRAL BUSINESS DISTRICT TO ACKNOWLEDGE AND RECOGNIZE AND CELEBRATE INDIGENOUS PEOPLE'S DAY.

AND WE'RE IN THE ABLE TO GATHER AND DO THAT THIS YEAR.

WE TYPICALLY HAVE BEAUTIFUL SONGS, BEAUTIFUL SPOKEN WORDS,

BEAUTIFUL DANCE AND PEOPLE FROM ALL OVER THE COUNTRY ARE HERE TO

RECOGNIZE INDIGENOUS PEOPLE'S DAY.

THIS COMING MONDAY, OCTOBER 12TH, 2020, WILL BE RECOGNIZED AND CELEBRATED OFFICIALLY IN MANY CITIES AND MANY STATES IN OUR NATION.

HOWEVER, IT IS NOT YET OFFICIALLY CELEBRATED IN LOUISVILLE AND IN FRANKFURT AND THROUGHOUT THE COMMONWEALTH OF KENTUCKY WHICH IS I BRING FORTH THE PROCLAMATION THIS YEAR IN HOPES WE'LL EVENTUALLY BE ABLE TO DO THAT.

AND OF THEIR CONTRIBUTIONS AND INFLUENCES IN OUR OUR CITIES HISTORY AND CULTURE.

SO INDIGENOUS PEOPLE'S DAY IS CELEBRATED AS A HOLIDAY AND IT IS KNOWN AS NATIVE-AMERICANS PEOPLE.

IT IS CELEBRATED ACROSS THE NATION.

AND ALWAYS DONE THE SECOND MONDAY IN OCTOBER.

SO AS A DESCENDANT OF OUR PRINCIPAL PEOPLE, THAT'S THE ORIGINAL NAME, OTHER PEOPLE NAMED US THE CHEROKEE NATION, IT IS AN HONOR AND MY MOTHER AND MY GRANDMOTHER AND MY GREAT GRANDMOTHER AND GREAT GRANDMOTHER TO BRING THIS TO YOU TO BRING YOU TO GATTLIVE KENTUCKY IN THE MOUNTAINS.

THIS IS MY LAST OPPORTUNITY IT RECOGNIZE INDIGENOUS PEOPLE'S DAY.

MAY PEACE BE WITH YOU EVERY DAY.

LIES SAYING I'M MADE RACIAL SLURS AT THE HOUSING AUTHORITY WITH

A CASE WORKER NAMED SAM WILSON AND IT IS LIKE -- IT IS -- THAT'S

I I RECORDED THE CONVERSATION AND PLAYED IT TO LISA AND IT WAS
THE FACT THAT SHE CLAIMED THAT SHE ENDED UP HEARING ME SAY THIS
STUFF AND HER OFFICE STAFF BOTH AND THIS WAS AFTER TALKING TO A
PROPERTY MANAGEMENT THAT WAS RETALIATING ALSO.

AT AGE 18 I HAD IN PARENTS TO SUPPORT ME AND I HAD NO OUTLETS FOR A FEW YEARS.

AS A PERSON THAT ENDURES POVERTY AND EXPERIENCED HOMELESSNESS I WAS NOT GIVEN AN EXCUSE TO FAIL.

NO ONE WOULD LET ME STAY AT THEIR HOME AND I DON'T LIKE STAYING AT THE SHELTERS.

WHEN I REFLECT ON MY PAST, EXCUSES WERE NOT OPTIONS.

EVERY BAD HABIT, UNSAFE INFLUENCE, HANGING OUT SPOT AND DEMEANING LIE THAT I'M NOT ENOUGH, AND I SWUNG A SLEDGEHAMMER TOO.

I KNOCKED THE UNSTABLE WALLS DOWN BUT I DIDN'T DO IT ALONE.

REBUILDING BASIC NEEDS IN PURSUIT OF BETTER VERSION OF MYSELF

ENTAILS RELENTLESS EFFORT AND REFUSAL TO ACCEPT LESS.

MY WHOLE LIFE I HAD TO FIGHT.

THIS IS NATURAL TO ME.

TO GET UP, OPEN MY EYES AND FACE THE DAY, I HAVE TO FIGHT.

TO STAY AWAY FROM NEGATIVITY I HAVE TO FIGHT.
