



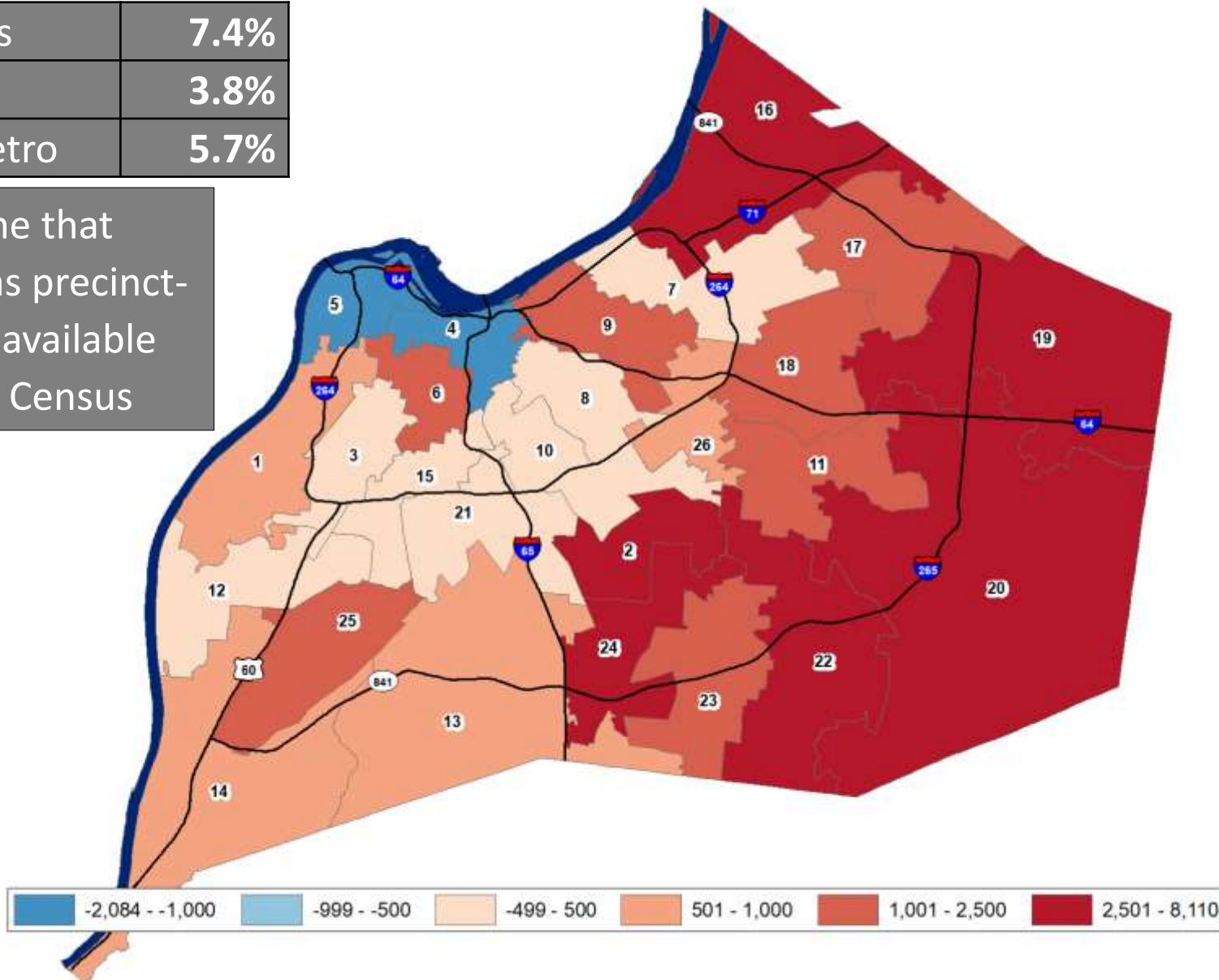
Louisville/Jefferson County Demographic Change 2010-2020

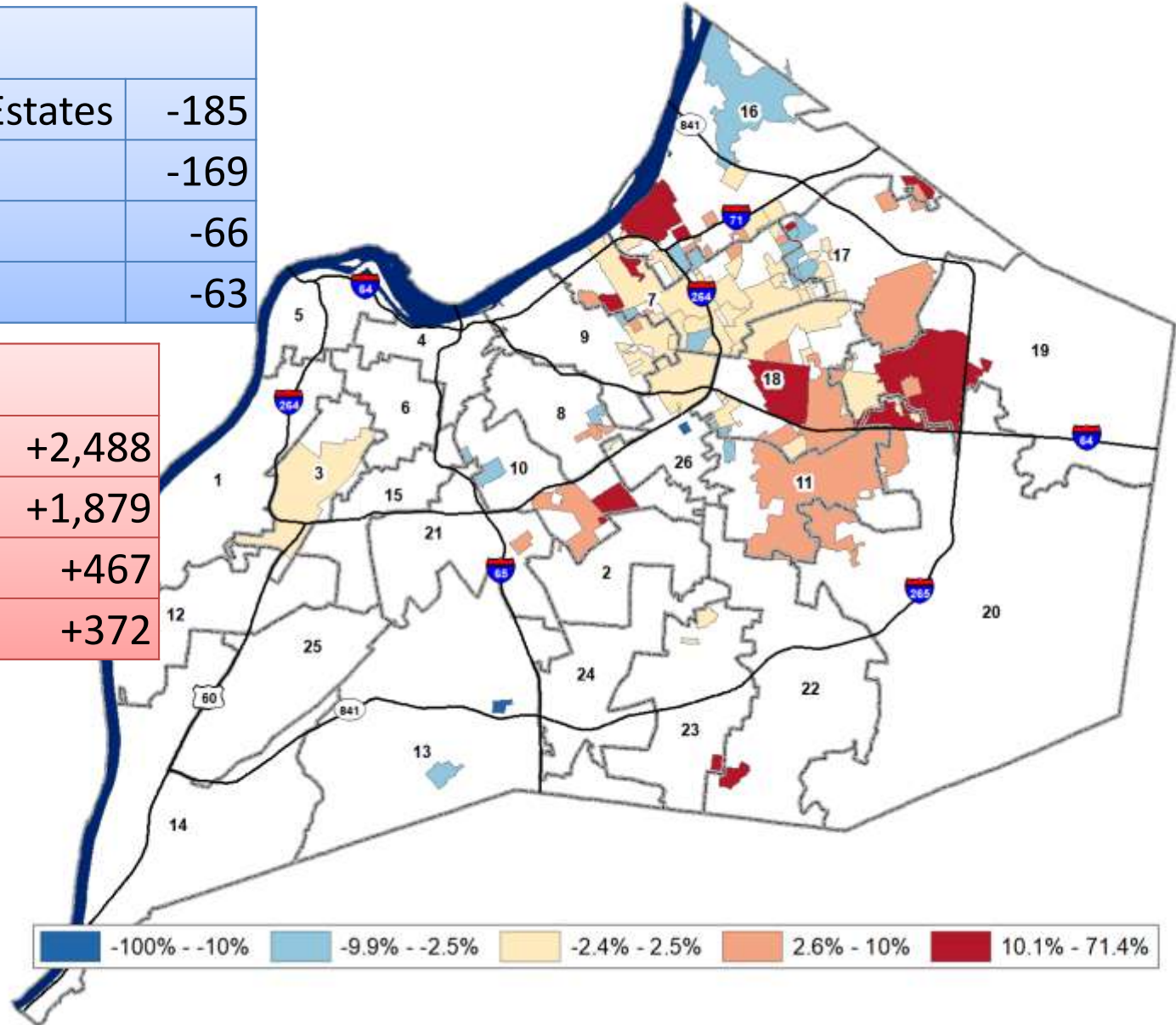

- Important points are that individuals can choose more than one racial group and that Hispanic or Latino ethnicity is considered separately from race

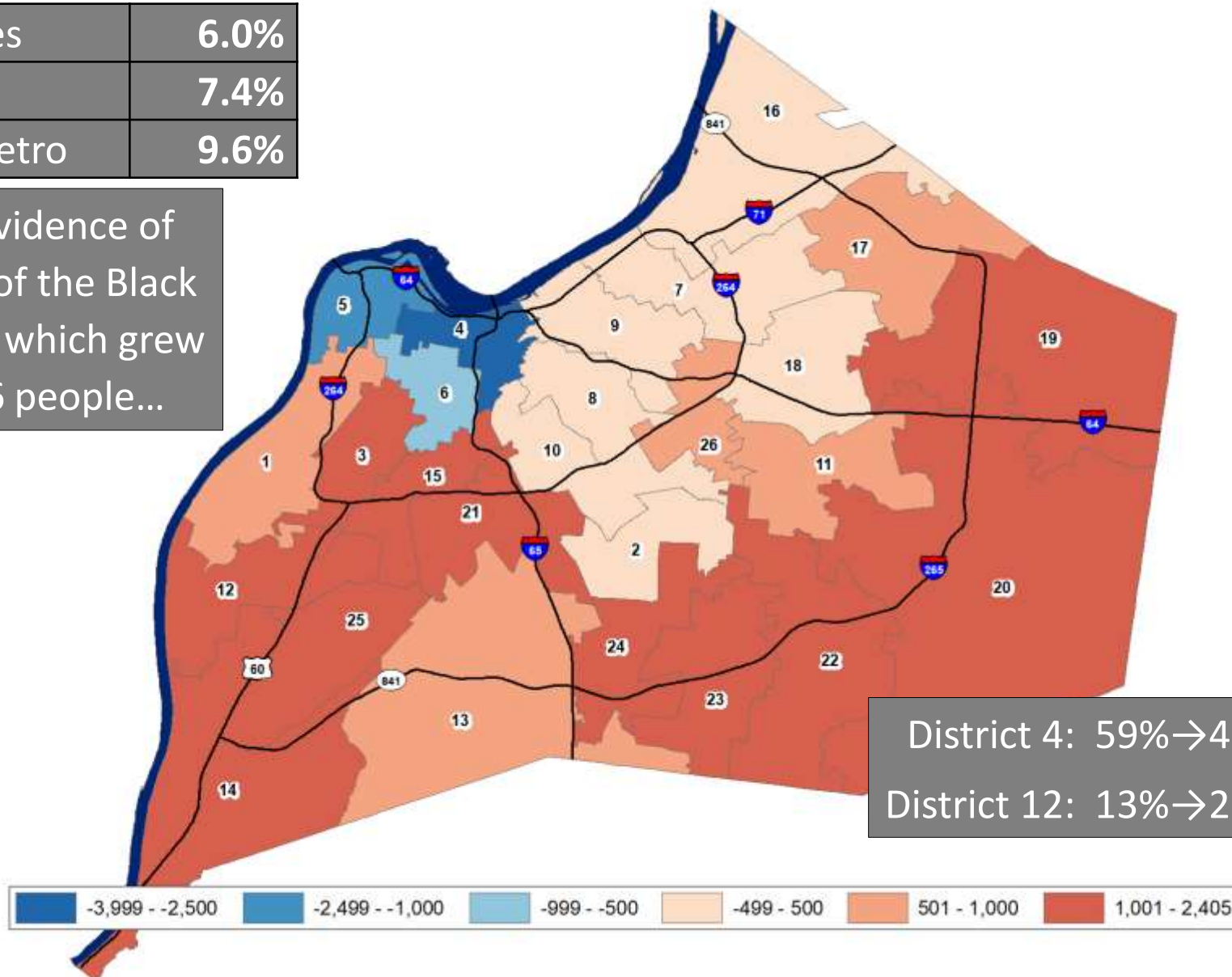

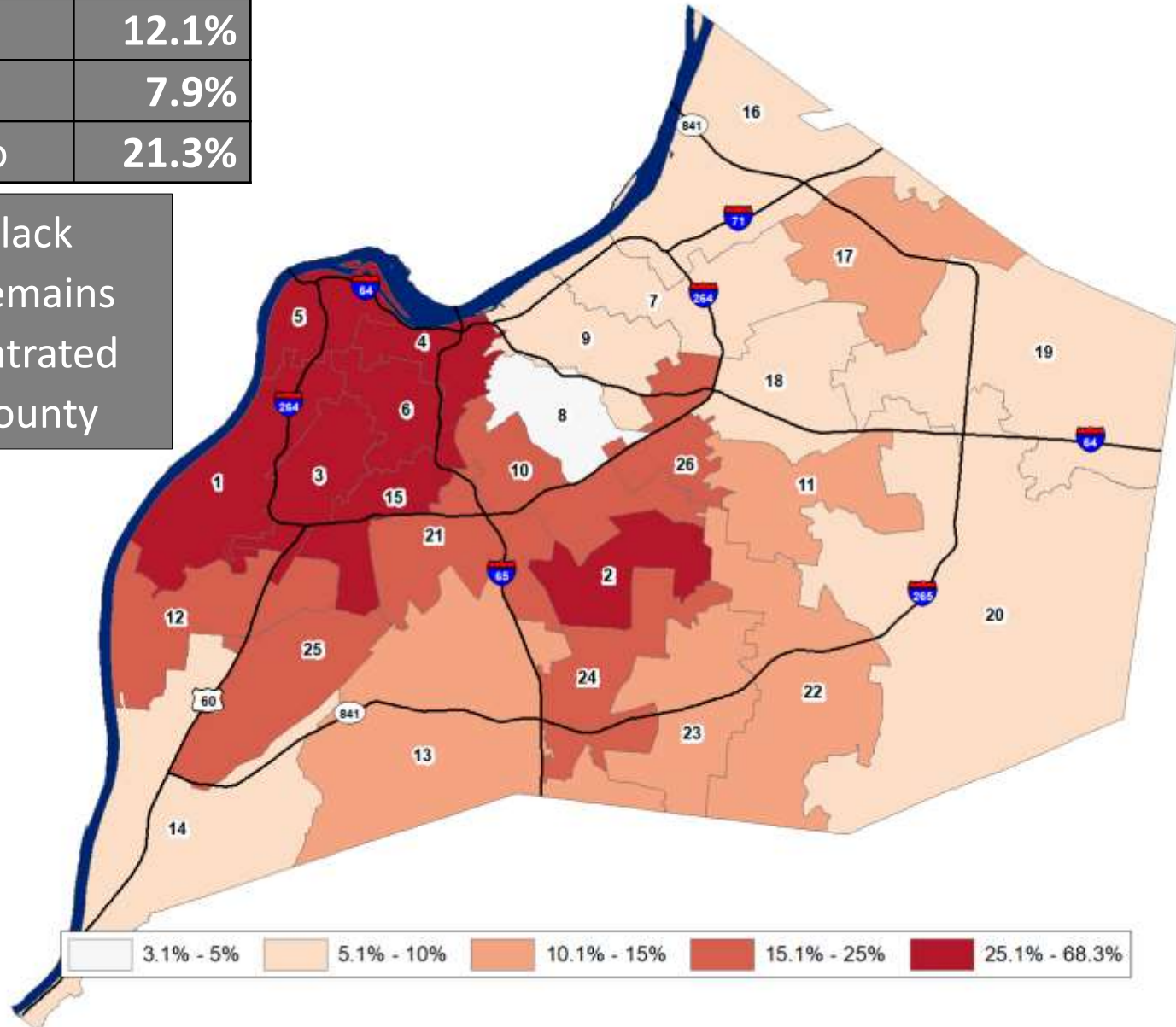
There is evidence of dispersion of the Black population, which grew by 14,616 people...

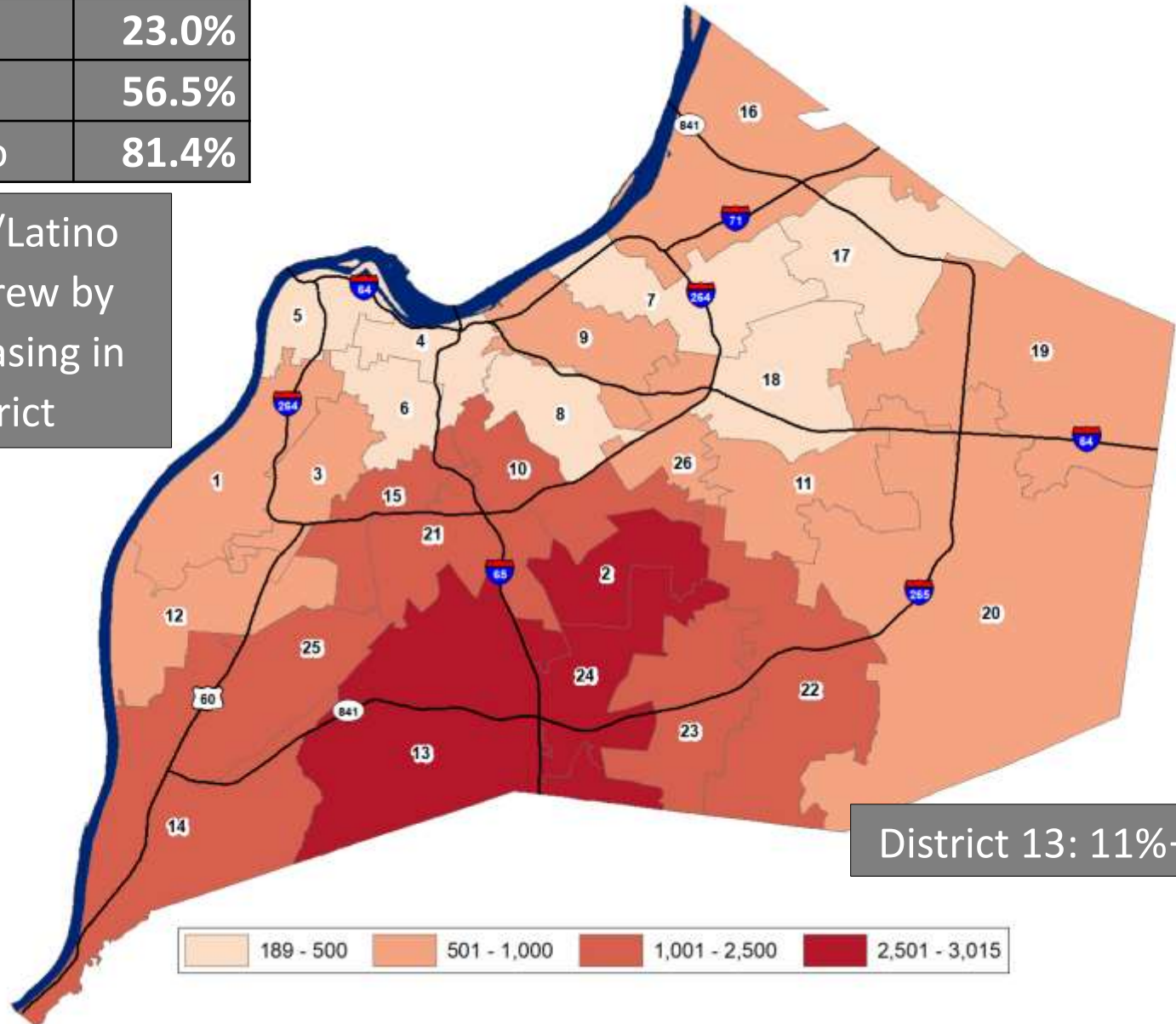
...but the Black population remains highly concentrated within the county

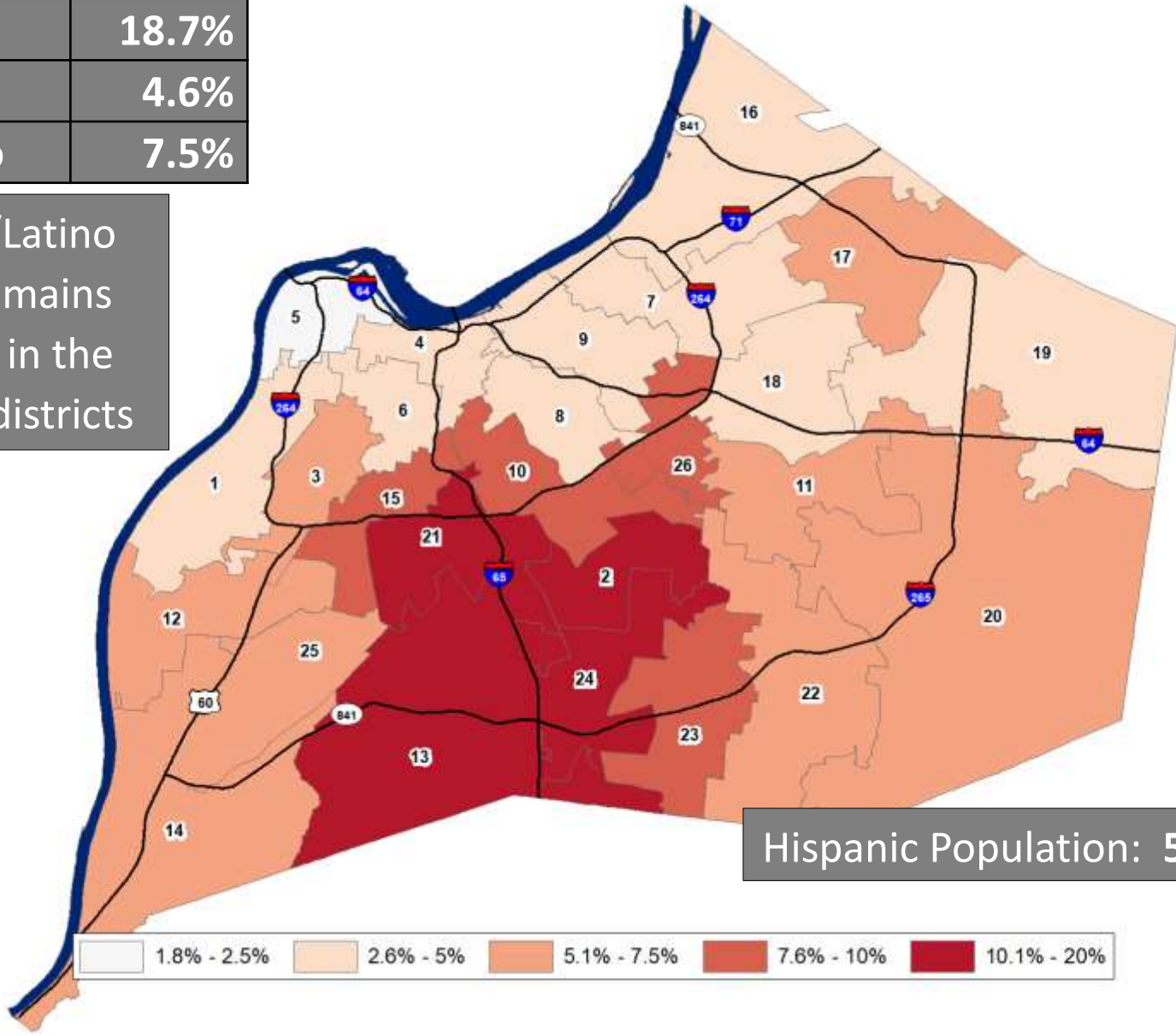
The Hispanic/Latino population grew by 26,479, increasing in every district

The Hispanic/Latino population remains concentrated in the south-central districts



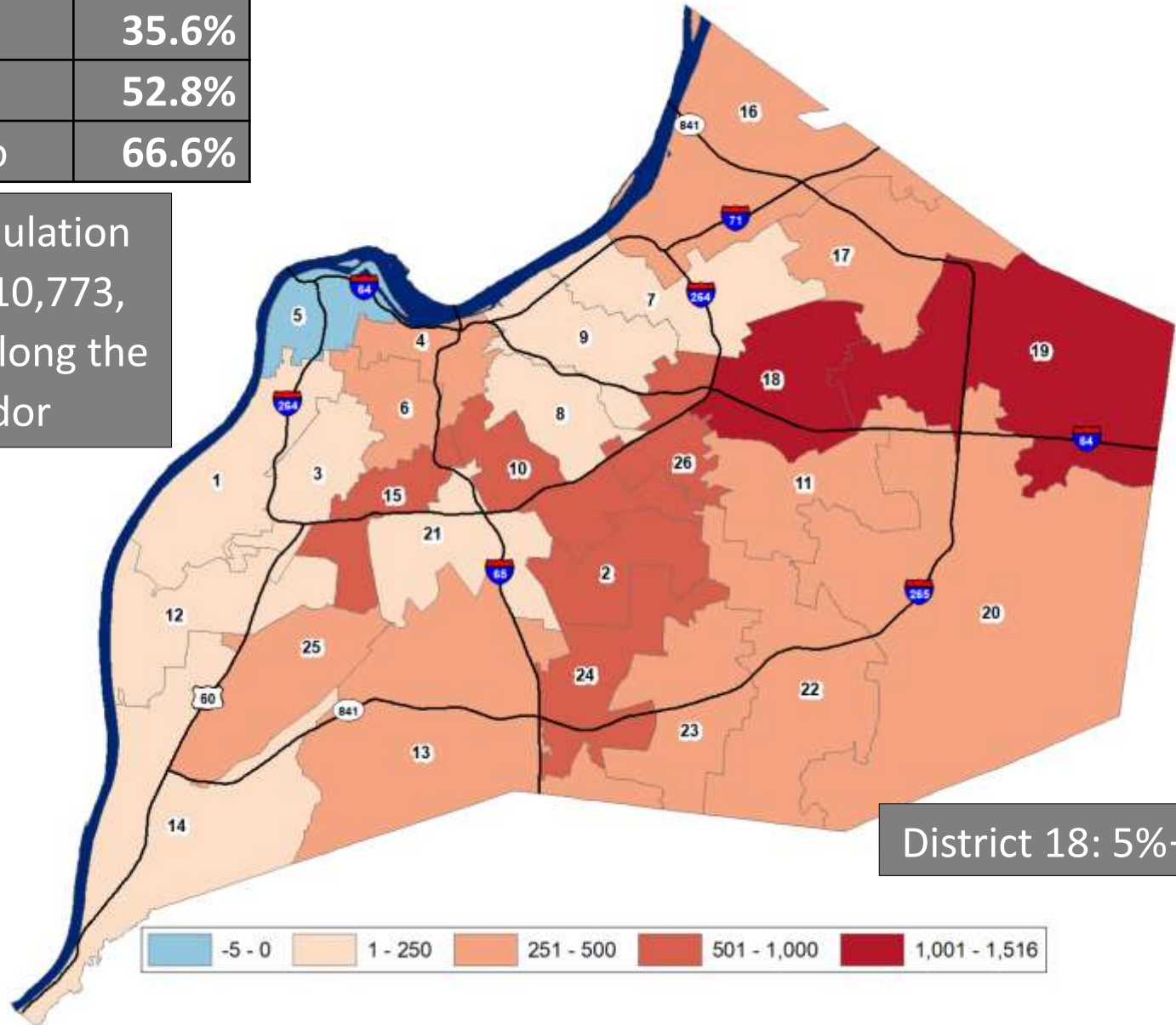

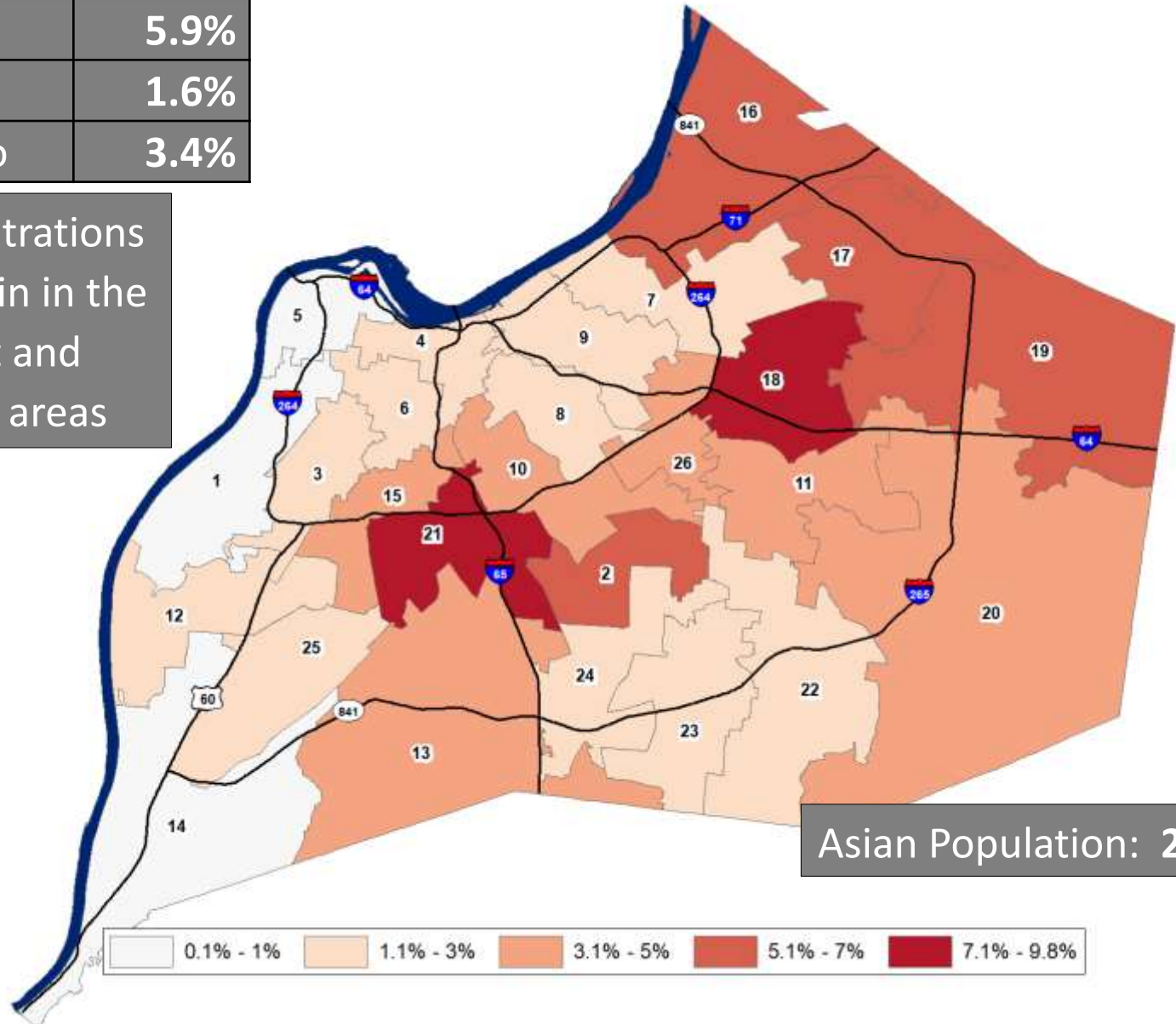
The Asian population increased by 10,773, most notably along the I-64 corridor

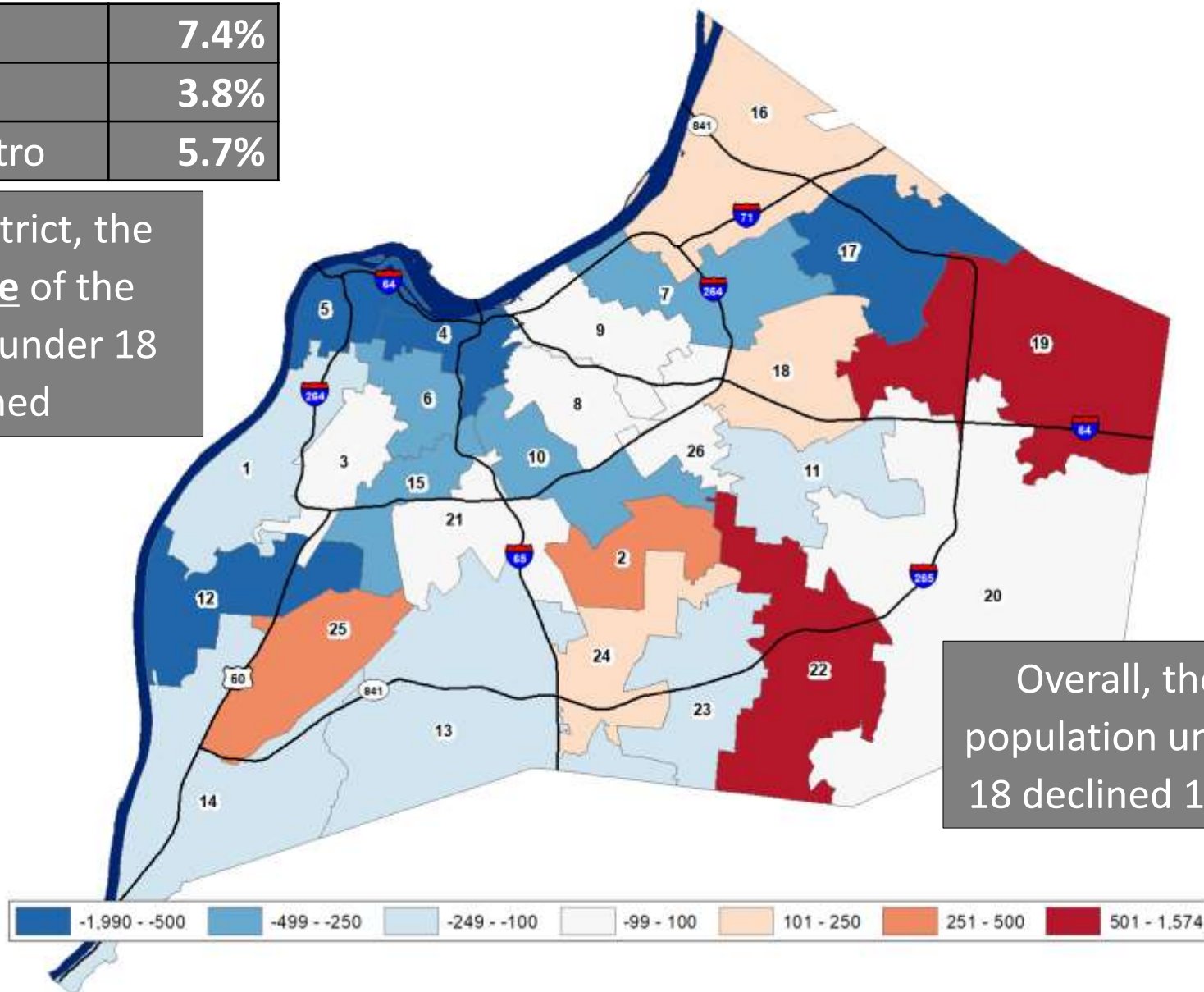
Largest concentrations

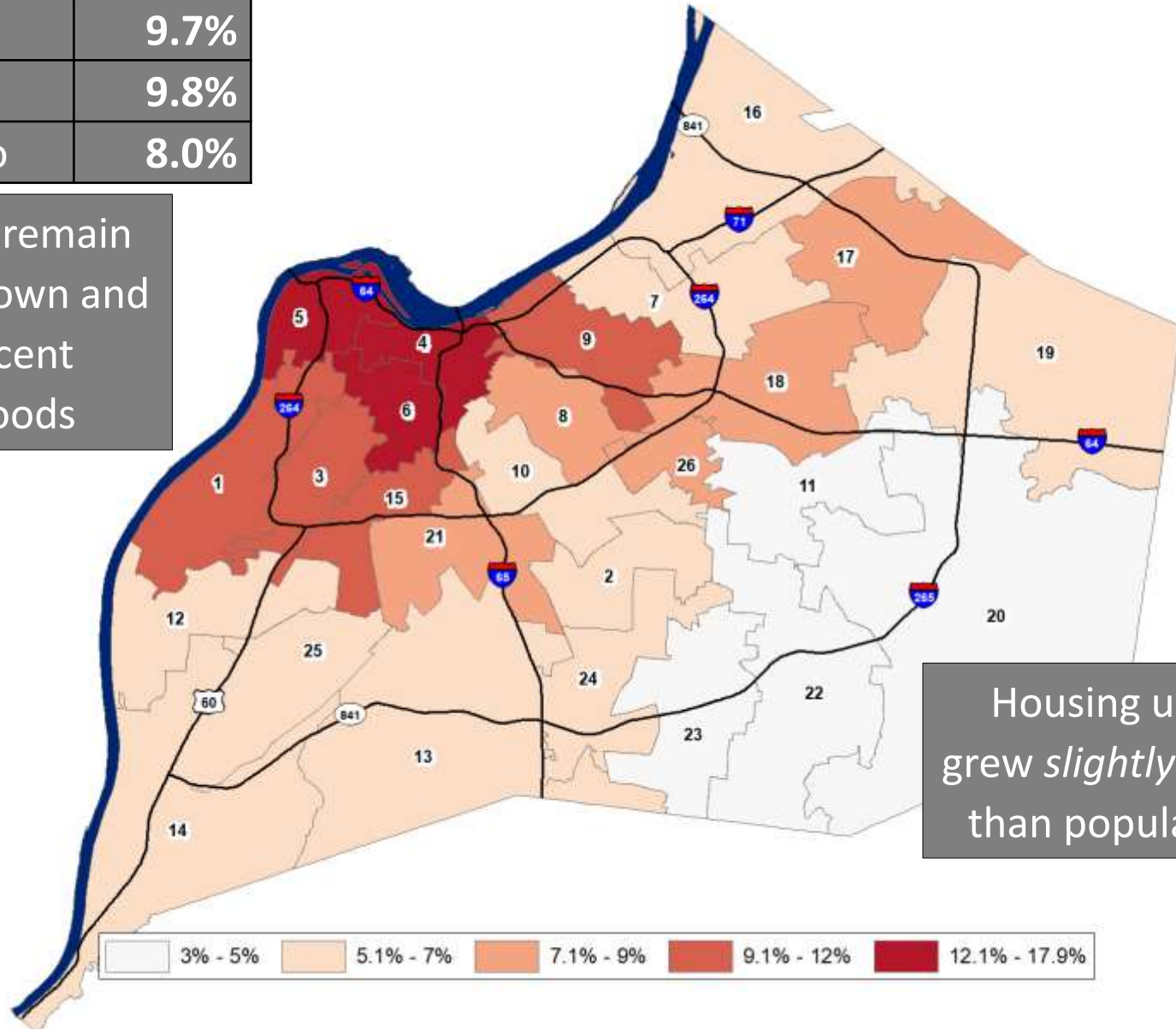
In every district, the percentage of the population under 18 declined

Vacancy rates remain highest Downtown and in the adjacent neighborhoods

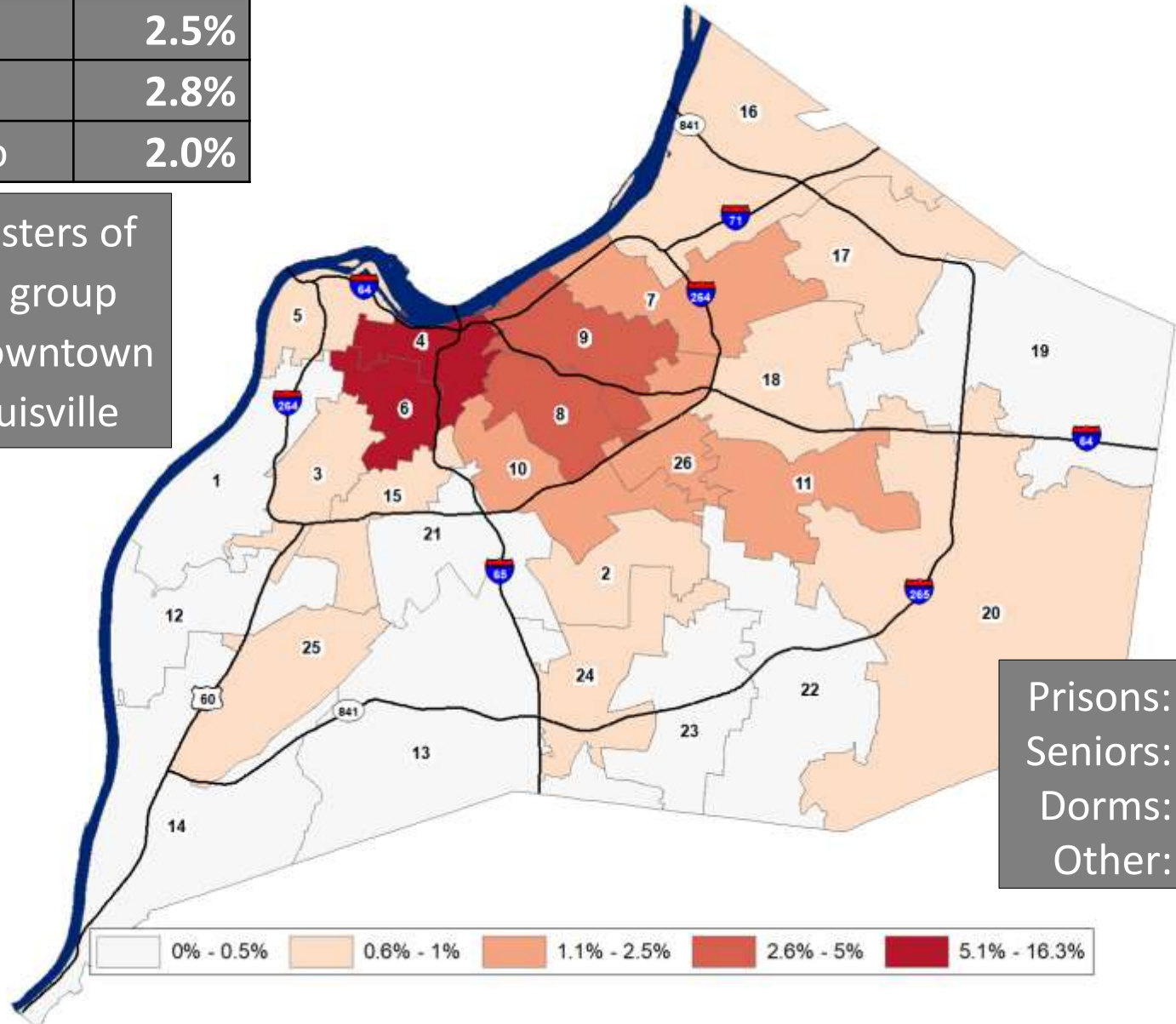


Housing units grew *slightly* faster than population

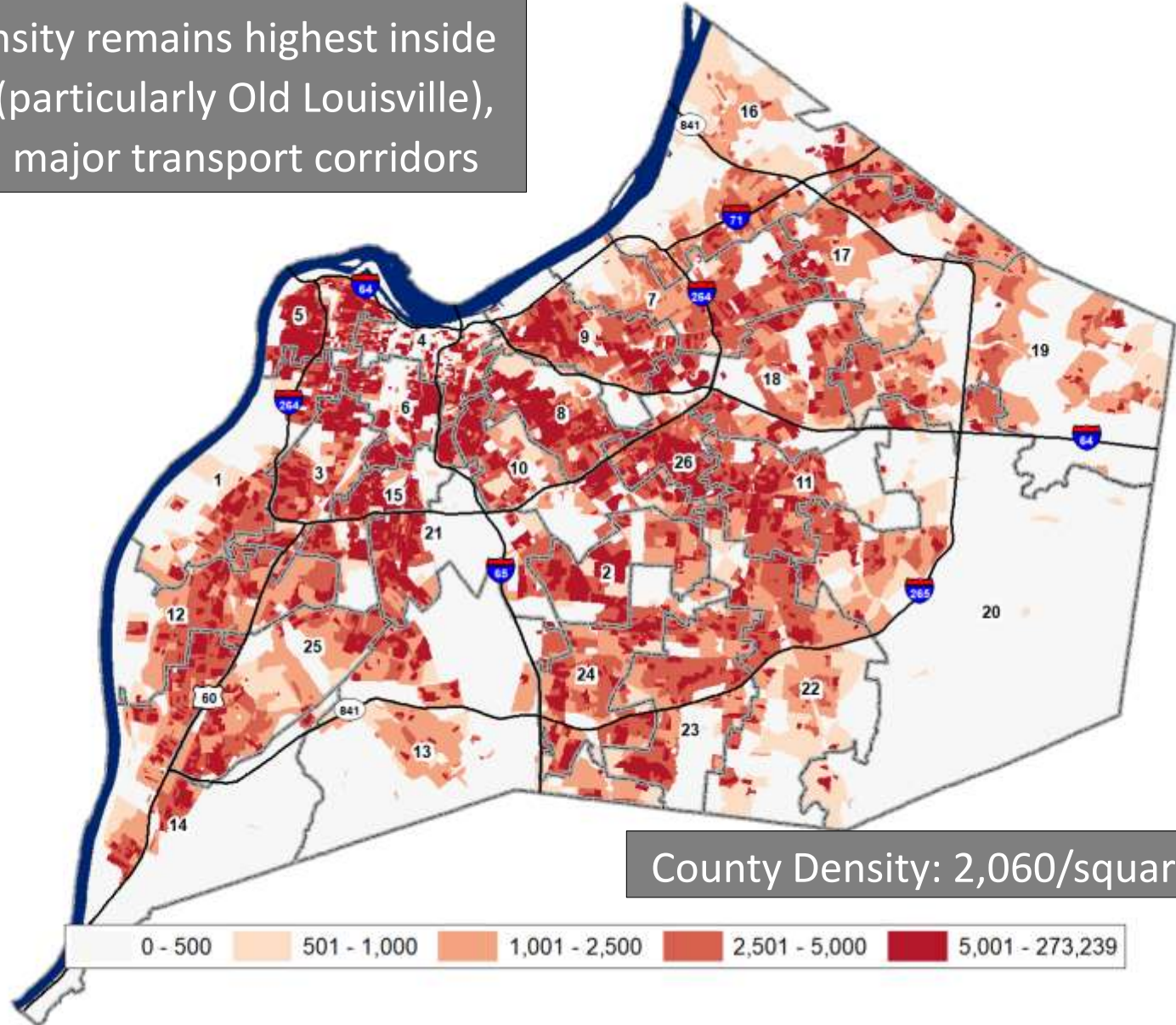
The largest clusters of population in group quarters are Downtown and in Old Louisville

Population per Square Mile 2020

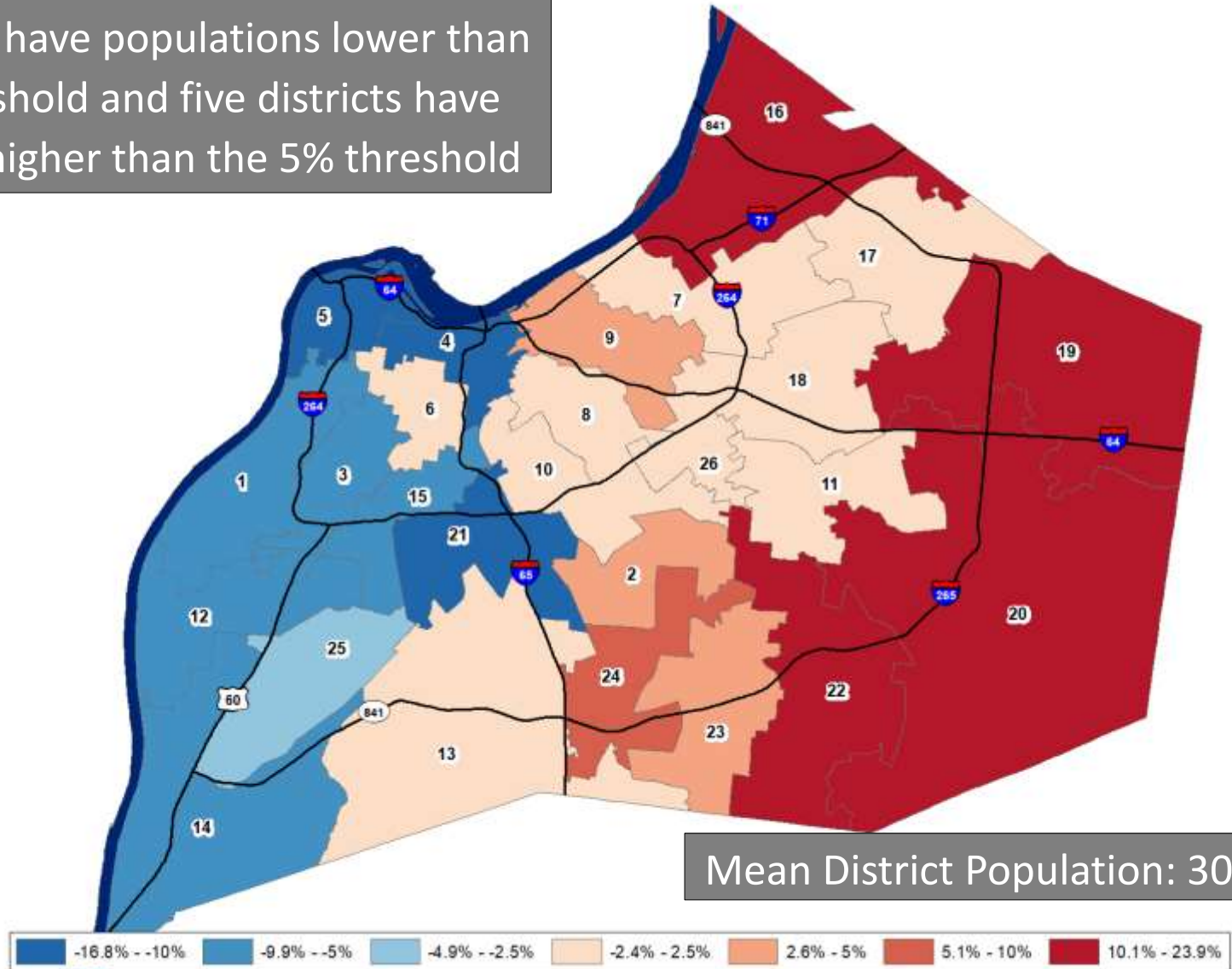
Population density remains highest inside the Waterson (particularly Old Louisville), and along the major transport corridors
