Situated along South English Station Road in Louisville, Kentucky and being all of a 3.229 acre tract and all of a 4.017 acre tract as conveyed by deed to James Lee Greiner and Callie Alexis Greiner in Deed Book 10266, Page 460 of the Jefferson County, Kentucky Clerk's records and being more particularly described as follows:

Beginning at a mag nail set over a railroad spike found in the center of the north bound lane of South English Station Road at the northwesterly most corner of the grantor's 3.229 acre tract, thence leaving said English Station Road and becoming the line of Stephen T. Noland (D.B. 9753, Page 73) and becoming the line of Woods of Landis Land Subdivision, Section 3 (P.B. 50, Page 22) N 79°09'36" E passing a 1" pipe found bent at 14.84', also passing a 1/2" iron pin found stamped Wink 3492 at 274.12', passing a 1/2" iron pin and cap found stamped Wink 3492 at 438.51' and passing a 1/2" iron pin and cap found stamped Wink 3492 at 517.01' a total distance of 703.77' to a nail found in the top of a 2" pipe filled with concrete in the line of The Reserves of Landis Springs (P.B. 54, Page 84);

Thence with the line of said Reserves of Landis Springs S 16°08'14" E 198.91' to a 2" pipe found at the northeasterly most corner of the grantor's 4.017 acre tract;

Thence continuing with the line of said Reserves of Landis Springs S 15°47'38" E passing a 1/2" iron pin and cap found stamped Wink 3492 at 40.33', passing a 1" pipe found at 44.56', passing a 1/2" iron pin and cap found stamped Wink 3492 at 120.35', passing a 1/2" iron pin found stamped Wink 3492 at 200.40' a total distance of 250.00' to a 12" wood post found at the northeasterly most corner of Lake Village at Landis Lake Condominium (D.B. 9117, Page 431);

Thence with the northerly line of said Lake Village at Landis Lake Condominium S 79°08'48" W passing an iron pin set at 10.00' a total distance of 697.03' to a mag nail set over a railroad spike found in the center of the northbound lane of South English Station Road at the southwesterly most corner of the grantor's 4.017 acre tract;

Thence with the center of the northbound lane of South English Station Road with the westerly line of the grantor's 4.017 acre tract N 16°47'57" E 449.72' to the beginning containing 7.194 acres of land more or less.

Being subject to all legal highways and easements of record.

The above legal description is based on an actual land survey completed by Matthew D. Sibole, PLS 3869 on September 8, 2015.

All iron pins set are 1/2" diameter by 24" in length with green plastic cap stamped "M. Sibole, PLS 3869". All mag nails set have aluminum washers stamped "M. Sibole, PLS 3869".

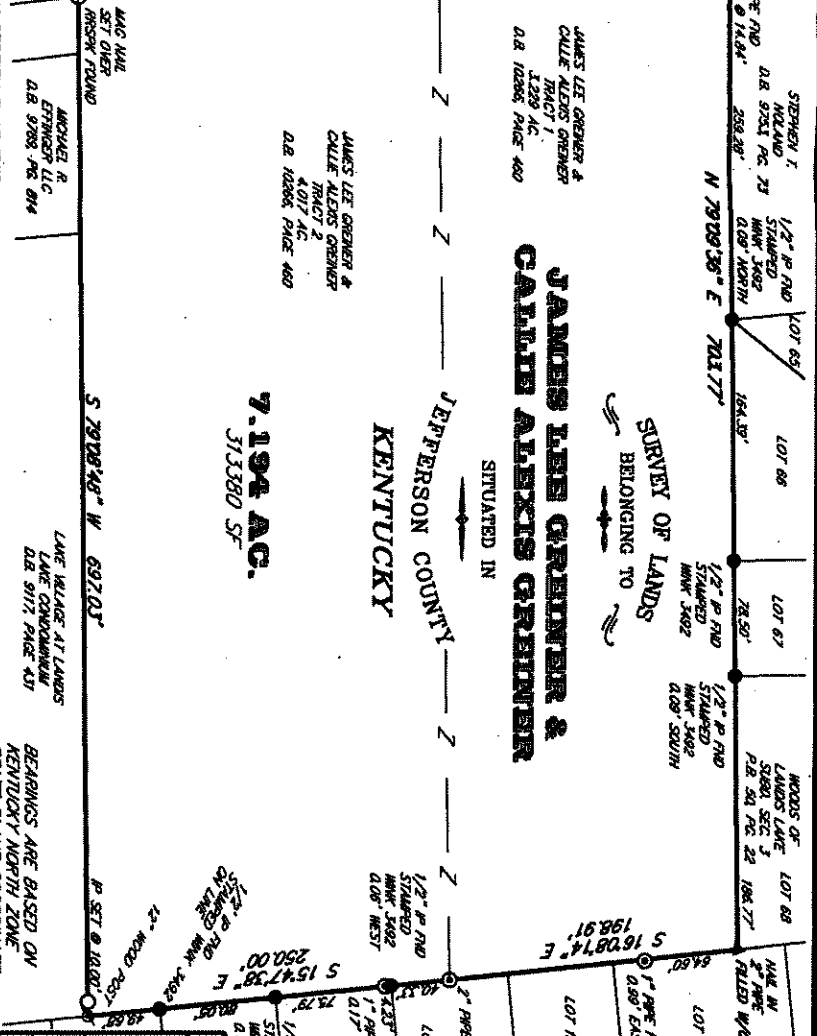

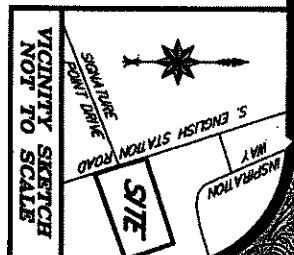
