AN ORDINANCE APPROPRIATING ~~\$5,000~~ ~~\$7,500~~ \$9,450 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 15; AND \$500 EACH FROM DISTRICTS 1, 10, 12, 13, AND 21, 23, AND 24; AND \$250 EACH FROM DISTRICTS 6, 8, AND 14; AND \$200 FROM DISTRICT 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO MOMENTS MATTER, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH YOUTH DAY (AS AMENDED).

SPONSORED BY: COUNCIL MEMBERS TRIPLETT, BOWENS, MULVIHILL, BLACKWELL, FOX, PEDEN, GEORGE, FLOOD, CHAMBERS ARMSTRONG, FOWLER, WINKLER, AND PRESIDENT JAMES

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of ~~\$5,000~~ ~~\$7,500~~ \$9,450 from Neighborhood Development Funds in the following manner: \$5,000 from District 15; and \$500 each from Districts 1, 10, 12, 13, and 21, 23, and 24; and \$250 each from Districts 6, 8, and 14; and \$200 from District 17; through the Office of Management and Budget, to Moments Matter, Inc. for programming expenses associated with Youth Day.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
