## **Application Information**

**Project Description:** This wall is a non-load bearing, yellow-brick wall, added in the 2nd half of the

20th century. Prior to that (beginning in 1922, when the house was expanded

for commercial purposes), the facade was panel glass & wood.

The wall is not historically fitting with the rest of the property, and is prone to being tagged with graffiti, which has happened several times. It is very difficult to clean, compared with the historically correct glazed reddish-brown brick that

the rest of the facade has.

This is project intends to:

a) match the color of the brick to the rest of the facade

b) conceal the present graffiti (and vestiges of previous graffiti) on the wall; as

well as make future mitigation much more straightforward

The wall has been primed and is ready for paint. Intention is to use a reddish base coat, and brown glaze, to provide depth and match the rest of the facade

as closely as possible.

Future permit will be sought to remove the facade entirely, and replace it will
