**AN ORDINANCE AMENDING ORDINANCE NO. 187, SERIES 2021 APPROPRIATING \$42,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$ 6,800 FROM DISTRICTS ~~2~~ AND 12; \$5,100 FROM DISTRICT 24; AND \$3,400 EACH FROM DISTRICTS 1, ~~8~~, 9, ~~10~~, 17, 21, AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE COMMONWEALTH THEATRE CENTER TO BRING AUDIO IMMERSIVE STORY, ZAYNAB'S NIGHT OF DESTINY, TO SCHOOLS IN JEFFERSON COUNTY GRADES K-6; AND \$6,800 FROM DISTRICT 2; AND \$3,400 FROM DISTRICTS 8 AND 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO COMMONWEALTH THEATRE CENTER TO BRING AUDIO IMMERSIVE STORY, ZAYNAB'S NIGHT OF DESTINY, TO SCHOOLS IN JEFFERSON COUNTY, COMMUNITY CENTERS, AND LIBRARIES.**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:**

**SECTION I:** Ordinance No. 187, Series 2021 is hereby amended and appropriates \$42,500 from Neighborhood Development Funds in the following manner: \$6,800 from Districts ~~2~~ and 12; \$5,100 from District 24; and \$3,400 each from Districts 1, ~~8~~, 9, ~~10~~, 17, 21, and 25; through the Office of Management and Budget, to the Commonwealth Theatre Centre to bring audio immersive story, Zaynab's Night of Destiny to schools in Jefferson County grades K-6; and \$6,800 from District 2; and \$3,400 from Districts 8 and 10; through the Office of Management and Budget, to Commonwealth Theatre Center to bring audio immersive story, Zaynab's Night of Destiny, to schools in Jefferson County, community centers, and libraries.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
