Field Release is a community-based alternative to detention program provided by the Contractor staffed 24 hours a day, including weekends and holidays. Field Release is available to all juveniles within Jefferson County who commit non-detainable offenses with the goal of ensuring the safe return of referred youth to their parents/guardians when a responding officer is not able to do this in a timely manner.

### JUSTIFICATION FOR NON-COMPETITIVE GOOD/SERVICE (Attach additional documentation if necessary)
