**AN ORDINANCE APPROPRIATING ~~\$2,000~~ ~~\$3,500~~ \$10,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 8; \$1,000 EACH FROM DISTRICTS 7, 9, 10, AND 26; AND \$500 EACH FROM DISTRICTS 1, 2, 4, 6, 15, 21, AND 25; AND \$250 EACH FROM DISTRICTS 3 AND 14, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LOUISVILLE PRIDE FOUNDATION, INC. FOR OPERATIONAL COSTS ASSOCIATED WITH THE LOUISVILLE PRIDE FESTIVAL (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$2,000~~ ~~\$3,500~~ \$10,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 8; \$1,000 each from Districts 7, 9, 10, and 26; and \$500 each from Districts 1, 2, 4, 6, 15, 21, and 25; and \$250 each from Districts 3 and 14, through the Office of Management and Budget, to Louisville Pride Foundation, Inc. for operational costs associated with the Louisville Pride Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
