## **Findings Summary:**

The applicant submitted property value assessments, PVA information, newspaper ads, directory listings, and a notarized affidavit. According to the LDC, the applicant must prove the use was being exercised consistently since 1971. The applicant nor research conducted by planning and design staff could provide sufficient evidence the use existing in 1971. To recognize nonconforming rights, conclusive evidence showing the use's establishment and continuous existence since 1971 must be provided.
