Project Description (use additional sheets if needed):

The full projects intent is to prepare, stabilize and seal the entirety of the exterior buildings on the property. The house was a rental for years, and there have been numerous mediocre to poor attempts to paint/seal various aspects of the house. The garage has never been painted. All surfaces need to be prepped which includes any/all of the following: scraping all surfaces, caulking or wood puttying gaps and holes, sanding wood surfaces, pressure washing, tuck pointing, and scrubbing/washing. To stabilize the surfaces and to beautify the house, the intent is to double coat all surfaces with lifetime quality paint (PPG Perminizer).

Portions of project have been completed, including the removal of old paint and replacement of rotten boards and roof shingles, and caulking/puttying gaps. Further, all wood surfaces that had been prepared were painted before winter to seal them from the elements. And a portion of the house has been tuck pointed. The garage has been fully sealed and painted, but the color is planned to change to match the house.

When the weather allows, the future intent is to finish tuck pointing the brick of the house, to prepare/replace/seal the remain wood on the house, and to paint/seal all of exterior portions of the house and garage.

FENCE: I'm not sure this needed, but the cedar fence surrounding the property has had the outside pressure washed and sealed, and the future intent is to pressure wash and seal the interior portions. The product used was termed semi-transparent, but I am not happy with the color so it will be changed to a tobacco brown color.
