ARTICLES OF INCORPORATION

WE, the undersigned, hereby nutually agree to unite and associate ourselves as a corporation, and for such purpose we hereby make, execute and adopt the following articles of incorporation:

ARTICLE I

The name of the corporation shall be VALLEY VIEW BAPTIST CHURCH, incorporated.

ARTICLE II

The period of the existence and the duration of the life of this corporation shall be perpetual.

ARTICLE III

The principal office and place of business of this corporation shall be in the VALLEY VIEW BAPTIST CHURCH, incorporated, edifice, on Third Street Road, Valley Station, Kentucky.

ARTICLE IV

The seal of this corporation shall be a two inch disk on which shall be inscribed the words VALLEY VIEW BAPPIST CHURCH, Valley Station, Kentucky, approximately ons-quarter inch from the parimeter and further inscribed thereon approximately one inch from the perimeter thereof the words, incorporated, seal.

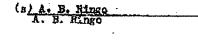
