Our growth-through-diversification strategy allows us to push boundaries and increase profitability while still being true to our roots and what has made the Churchill Downs brand one of the best in the business.

Much has changed since that first Kentucky Derby Day in 1875, but one thing hasn't: our commitment to building a profitable, vibrant company that is valued by our customers, investors, employees and business and community partners for generations to come. CD's diversification relies on increased use of technology & on-line gaming. CD currently has software and technology offices in Mountain View, California and Atlanta. They plan to consolidate a divisional office in one location, preferably in Louisville. KBI Tax Incentives will make or break this deal. Within the first two years of operation, CD plans a total investment of \$4,000,000 in office lease expenses and capital equipment. They plan to 50 jobs with a total payroll of \$6.24 million by 3Q2014.
