Stuart,

Your report and proposal was discussed at the January 19, 2015 Cherokee Triangle Association meeting. Members were most appreciative of the excellent documentation/photographs you provided. We will proceed with a determination of our budgetary resources. When those funds are confirmed, I will then make contact with you, and the other appropriate individuals, to schedule the work.

Questions:

*Is it possible for new signs to be coated with anti-graffiti paint, an important application due to the fact the Association will be charged with maintenance responsibility of newly replaced signage; Yes, but it will add an additional cost of \$5 per sign.

*What will timetable be for work completion from fabrication to installation; Approximately 5 weeks as long as we receive everything we need to schedule fabrication and installation by February 6th, 2015.

*What is proposed gauge of metal used for signs. 0.08

Per our conversation this morning, the two photograph markers that we want to change are the following:

*Number 3: Grinstead Drive at alley just past Speedway: existing sign is to remain and be replaced with newly designed version; OK.

*Number 4: Cherokee Road at Grinstead Drive intersection, across from Highland Baptist Church: existing sign is to be removed. OK.

We still need to confirm wording from new signs, whether it is "Cherokee Triangle Historic Preservation District" or "Cherokee Triangle Preservation District." Please advise how the other six Metro preservation districts have worded signs; consistency might be a good rule to maintain here. Concern is that the 30"x30" triangular sign not be filled with wording. I am not familiar with the particular wording of the other districts. We can accommodate whatever wording you would like to use.

We soon hope to be in discussion with Councilman Tom Owen with regard to available dollars from the Councilman's neighborhood discretionary fund, as well as the Association's budgetary capital improvement allowance.

Again, your assistance and input have been extremely helpful.
