- Saunders Avenue is mostly concrete. We won't pave over existing concrete because it won't last. It really needs to be thoroughly inspected when the weather improves. To repave the asphalt portion of Saunders and do the maximum amount of concrete repairs, the cost would be \$73,000. The cost could decrease after a thorough inspection is complete.
- Country Club Road - \$41,000 is good.
- South Hite Avenue - \$75,000 is the new estimate.
