AN ORDINANCE APPROPRIATING \$7,100 \$8,000 \$8.500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 EACH FROM DISTRICTS 15, 21; \$1,000 EACH FROM DISTRICTS 12, 13, 25; \$100 FROM DISTRICT 6; \$900 FROM DISTRICT 10, \$500 FROM DISTRICT 14; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE SOUTH LOUISVILLE COMMUNITY MINISTRIES. INC. (SLCM) FOR **40**<sup>TH</sup> **ASSOCIATED** WITH THE **ANNIVERSARY** CELEBRATION "FAMILIES HELPING FAMILIES" FUNDRAISING PROJECT AND TO SUPPORT OPERATING AND PROGRAMMING EXPENSES CONNECTED WITH PROGRAMS SUCH AS MEALS ON WHEELS, FOOD PANTRY, MEDICATION ASSISTANCE, ADULT DAY CENTER, MARRIAGE AND FAMILY COUNSELING (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,100 \$8,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 each from Districts 15, 21; \$1,000 each from Districts 12, 13, 25; \$100 from District 6; \$900 from District 10, \$500 from District 14; through the Office of Management and Budget, to the South Louisville Community Ministries, Inc. (SLCM) for expenses associated with the SLCM 40<sup>th</sup> anniversary celebration "Families Helping Families" Fundraising Project and to support operating and programming expenses connected with programs such as Meals on Wheels, food pantry, medication assistance, adult day center, marriage and family counseling.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
