INTERVIEW WITH INGRAM QUICK



On October 1, 2014, at approximately 1450 hours an interview was conducted with Ingram Quick. Mr. Quick is more specifically identified as:

Ingram Quick



The interview was conducted at the Office of Internal Audit located at 609 West Jefferson. Also present during the interview was Sergeant Marcus Laytham and Assistant Director Mayria Porter. Mr. Quick was employed with Louisville Metro Government, Office of Internal Audit during the time frame of this investigation. Mr. Quick's interview was taken in the form of a sworn statement and the following are the key aspects of the interview:

- Mr. Quick received this complaint through the ethics tip line, and also through the Louisville Metro Police Department in late August. Mr. Quick's responsibility was to review financial records, and to determine if there was any misappropriation of funds specific to Sadie.
- Based on the internal documentation, Mr. Quick did not find any criminal wrongdoing by Louisville Metro Animal Services concerning funds specific to Sadie.
- Mr. Quick noted a significant non-compliance issue regarding the metro donation policy. It is the department director's responsibility to ensure the ordinances and records are compliant. Mr. Quick said he believes Donald Robinson was the department director at the time.

Thank you. And we're meeting to discuss the completed audit uhh that you prepared. And if you would, could you just go over what your responsibility was?

Quick

Just to be clear, this wasn't an actual audit. It was more of a review that we did. Cause we didn't follow any of our auditing standards when we was actually doing this. So we didn't make that qualification within the final report. But our—our responsibility in this object, we uhh actually received this through the ethics tip line. It initially went to the uhh Poli—Louisville Police Department. And then based upon the uhh fraud—it being a fraud incident type and police then they (Inaudible) much far here. And we wanted to pass this on to you so you could see if there was any type of misappropriation of funding. Then they can basically—we basically pass it back to the police if we did see any criminal. Uhh that was actually taken upon us uhh I don't know the exact date, but it was somewhere late August. Uhh so we actually received that uhh request from Louisville Metro Police Department. And that what actually how we got involved in this situation. Then upon that, our scope and objective of the review was—was to determine what the funds that came in designated specifically for Sadie uhh whether they was used for other purposes within Animal Services.

Kessinger

Okay. And during your review, did you find any funds that were used, that was specific for Sadie, did you all uncover any funds for Sadie that was used elsewhere?

Quick

Uhh, no we did not. Not as being identified as specific to Sadie. Based on all internal documentation we reviewed.

Kessinger	Did you uncover anything that would lead to any criminal wrong doing when you looked at this?
Quick	No, we did not.
Kessinger	Sergeant Laytham?
Laytham	I was just pursuing through the report that you uhh handed (Inaudible) earlier. Of course this is just a draft.
Quick	Uh-huh.
Laytham	So with that being said, uhh, it appears, referring to what you told you uhh Sergeant Kessinger that there's no criminal activity that you can determine at this point. Correct?
Quick	Correct.
Laytham	Uhh what type of deficiencies did you note within the Louisville Metro Animal Services?
Quick	Uhh we noted a significant non-compliance issue with the Metro donation policy. Which basically is what—the donation policy was set up to actually prevent any violation of the actual Louisville Metro Ordinance 20.15.
Laytham	Okay. And who all is totally responsible for making sure that those ordinances and their records are compliant?
Quick	Uhh that would be the department director. I believe. To my understanding.
Laytham	Okay. I don't think I have anything else.
Kessinger	And do you recall who at the time was the department director?
Quick	At the time of this, I believe the department director was uhh Donald Robinson. At that point in time.
