

### INTERVIEW WITH MARGARET ANN BROSKO

On November 3, 2014, at approximately 0804 hours an interview was conducted with Margaret Ann Brosko. Mrs. Brosko is more specifically identified as:



The interview was conducted at the office of the Public Integrity Unit located at 810 Barret Avenue. Also present during the interview was Sergeant Marcus Laytham. Mrs. Brosco was employed at Louisville Metro Animal Services (LMAS) as the Public Information Supervisor during the time frame of this investigation. Mrs. Brosco's interview was taken in the form of a sworn statement and the following are the key aspects of the interview:

- Assistant Director Donald Robinson was the Acting Director of LMAS in the absence of an appointed director during the time frame this investigation encompasses
- Mrs. Brosco assumed more responsibilities and roles in the absence of a director to include but not limited to grants and working with National Partners
- Mrs. Brosco confirmed email communication with Heather Adkins (individual identified as
  fostering Sadie) in regards to Sadie: estimated cost of surgery, Sadie being treated at Mrs.
  Adkins personal veterinarian and the veterinarians diagnosis that Sadie would be okay until
  funds could be raised for the surgery
- In December 2013, Mrs. Adkins was granted permission by Mrs. Brosco to begin raising money for Sadie's surgery
- Individuals fostering animals had unlimited access to the veterinarian staff at LMAS during normal business hours; outside normal business hours or in emergency situations they could contact dispatch in order to speak with the on call veterinarian
- The fostering party, in this case Mrs. Adkins, is responsible for the day to day care of the animal for which they are fostering
- Mrs. Adkins never brought Sadie to LMAS to be treated by the veterinarian staff
- LMAS does not conduct home visits on animals in foster care
- LMAS Foster Coordinator explains requirements and responsibilities of being a foster, additionally each foster is given a manual and are checked through LMAS database for any previous issues regarding the mistreatment of animals
- LMAS was aware Sadie had an injury, but Mrs. Adkins was not required to bring her in for evaluation and/or treatment at any time during the six month foster period

This interview was audio recorded and shall be mad a part of this file.

Okay. And at the time that Miss Adkins came to you what was your role, your responsibility at...

...At Metro Animal Services?

Kessinger

...At Louisville Metro Animal Services? Yes.

Brosko

I was the Public Information supervisor at that time, so uh, obviously my job duties were a lot of community engagement, uh, media outreach, those types of things... Uh, also, within my role uhm, I would do different things as part of the management team.

Kessinger

Um-hmm...

...so we had a very open style. So we all worked together. At that time uh, we did not have a director, uhm, so i was doing a little bit more in the sense of grants, uhm, working with our national partners, those types of things.

It was a joint fund-raiser, so initially what was talked about was there was a vet who in the past had done surgery uh, as part of a donation.

Kessinger

Um-hmm.

**Brosko** 

Uh, unfortunately that didn't work out, so we were looking at another option. So the second option that we were gonna do is we were gonna raise funds jointly. Uh, so she said that she was able to raise funds through her family and friends...we said we would try to help as well. Uh, so at that point it was a...it was a dual campaign, if you will...

Kessinger

...Okay...

Brosko

...to raise funds.

Kessinger

And who was it joint with?

**Brosko** 

Uh, Metro Animal Services and Miss Adkins.

Kessinger

And Miss Adkins.

Brosko

Correct.

Kessinger

Was you ever aware of the cost associated with the surgery?

**Brosko** 

Yeah, there were two different uh, cost estimates. I think uh, initially one was like uh, 545, and then this one is 575. So...that was my understanding.

Now was there ever a press release done...

Okay. Was there ever any money came in specific for Sadie, that you're aware of?

Brosko

There, there was some money that came in, uh...a couple of checks came in uh, that, that were specifically to help Sadie. I believe those were from uh, people who knew Miss Adkins.

Kessinger

Okay. And apparently there was an email that said Brosko was gonna push a story and it would be pro'bly pretty big. Do you recall that being said?

Brosko

No, sir.

Kessinger

and I believe in late December you sent an email to Heather allowing her to start raising money on her own.

That's correct.

For, for Sadie.

**Brosko** 

Um-hmm.

Kessinger

Were you ever given updates on the dog's condition throughout this?

Brosko

Uh, one, one time. Uhm, I was given an update on the dog's condition. At that point I talked to Miss Adkins and uh, i asked her uh,

what, what the condition of the dog was and uh, if there was anything that needed to be done. At that point she told me that she was going to her own personal vet, uh, and that the vet said that the dog would be okay until the money was raised for the surgery.

And do you know who her own personal vet

would be?

Brosko

Uh, I believe it's, it's the same vet that, that she

had here, uh, Stephanie Pollitt.

Kessinger

Okay. And what was the condition of the dog

when she updated you on it?

Brosko

She said that the dog was tryin' to get out of its cone, uh, and...and uh, take the bandages off the leg, uhm, is what she had said, and so I asked her uhm, you know, if there, if there was anything that we needed to do and she said that she went to her vet and the vet said that it

would be fine until we raised the money.

Okay. And I believe in December you emailed Heather Adkins and said you needed to speak

with the spot board. Is...

Uhm, the senior management team was Donald, myself, and then Justin Scally, the former director...and then otherwise, as far as the managers, uh, there's, there's supervisors in charge of each division. Uhm, so that would be Tabitha Gray, Adam Hamilton, and Amanda Ball. All of us are (inaudible) in charge of community engagement and I'm not sure at that particular time uh, Rebecca Riggs was the adoption supervisor, and I, I don't remember exactly when, when she left. I think she was there at parts of that, of those times.

Okay. When, it's to my understanding that Sadie was out being fostered by Heather Adkins. Would that be accurate to say?

Brosko

That's correct.

Laytham

Okay. Who oversees the fostering aspect of...

The adoption supervisor.

Laytham

The adoption, which you think was Rebecca Riggs at the time?

Okay. Now do you have any intimate knowledge on how uh, fostering the process is up there?

Yeah, I have a basic knowledge of, of how fos...fostering works.

Heather Adkins' care or foster, approximate early September. That sound...

...pretty accurate?

Brosko

Um-hmm.

Laytham

Okay. Is...when you're fostering a dog uh, is there...is the vet available to the person who's fostering that dog?

Brosko

Yes, it is. So to help fosters in general, their open hours every day Monday through Friday...so if a foster has any questions or concerns they can bring the animal in to see our vet staff at any time. Uh, and then in emergency situations uh, our dispatch line uh, is open uh, I believe until 11 pm, so from like 7 in the morning till 11 pm...so if it's an emergency situation then they're instructed to call dispatch, and we have a vet that's on call, and so then that on call vet would assist the foster.

Laytham

Okay. I believe Heather...like we said, Adkins, took uh, was foster this dog early September...

Brosko

Um-hmm...

Laytham

...until it was euthanized on February 28th. That sound pretty accurate?

Brosko

Believe...believe so, yes.

Laytham

Okay.

Laytham Now did Miss Adkins ever bring Sadie in to be

seen by the vet at Louisville Metro Animal

Laytham Okay. But Heather Adkins was responsible for

the daily care of that dog.

Brosko That's correct. So the dog was at Heather's uh,

Heather's house...the, the entire time.

Said, "I wanted you send"..."I wanted to send you my vet's name and number because I'm pretty sure when she quoted \$575 that covers everything, including equipment, pain meds, board etc., so we wouldn't be responsible for any cost or ordering anything extra for the surgery, if you wanted to open conversation with her about it." The, vet's name at the bottom, Dr. Stephanie Pollitt. Correct?

Brosko Um-hmm. Correct.

Kessinger And was there any conversation made with her about this with the vet?

No.

about this with the vot

Kessinger Alright. And it looks like Heather Adkins

emailed you on November 16th...I believe it'd be you and Miss Tabitha Gray. Says "Any decision on her amputation yet; uh, and the subject of this is Sadie. Says "My vet is willing to do this ASAP and if I need to cover some of the surgery cost to get this done I will happily do it." Apparently here's the email

here...do you recall ever getting that one?

Yes.

It says uh...I'll finish this... it says, "I will happily do it. I came home yesterday having her broken leg through her e-collar and chewed on her paw again, a bloody, gross mess. This arm needs to go." Now Sgt. Laytham said a moment ago...and I'd just like to touch on it

again...

A bloody gross mess. The arm needs to go." Now if the dog needed medical attention you all have a vet on staff. Correct?

Brosko

That's correct.

Kessinger

So would you all deny...deny seeing the dog

for any reason?

No. For no reason at all.

Kessinger

And if the dog...if she brought the dog in

would the dog be seen?

**Brosko** 

Absolutely.

Kessinger

And do you recall if she ever brought the dog

in?

**Brosko** 

She did not.

Kessinger

Is there anything that, that you wanna state for

the record about this?

**Brosko** 

I think that the important thing to note is that

uh, not only was there vet care available...

...Um-hmm...

**Brosko** 

...we've really tried to work with Miss Adkins to, to save the dog and to do what we can to uh, you know, to help out. And I think that,

you know, it's an unfortunate situation, it really is...but I think that, you know, over all, we really, you know, have a, have a commitment to saving lives. And that's what we were trying to, to do in this particular case.

Kessinger

And again, when a...when a dog is being fostered, when someone takes the dog in...whether it's Sadie or any other dog, cat, or animal at Animal Services...who is responsible for providing medical attention for that dog, if needed?

**Brosko** 

If medical attention is...

Kessinger

...If it...if it is being fostered...

**Brosko** 

If it's being fostered uhm, Metro Animal Services, it, will provide medical attention for that dog.

Kessinger

But whose responsibility is it to bring that dog in to be seen?

**Brosko** 

It's the, it's the foster's responsibility. If the animal is in the foster's home uhm, it's not in the, the shelter environment or in a, in a location where any Metro Animal Services staff is taking care of it, so it's the responsibility of the foster uhm, to bring that animal in.

Kessinger

Now...and you might not be aware...I'm gonna ask you this anyway...while a dog is being fostered...

...Um-hmm...

...does anyone from Animal Services periodically go out and do a home visit or a check on that dog to check the condition?

Brosko

No.

Kessinger

Is the dog or, required to come in every so often to be evaluated if it's being fostered?

Brosko

Uh, it depends on the situation, so if it's a kitten or puppy uh, they're required to get shots uhm, every...I believe it's every two weeks. Uh, so at that particular time yes, they are required to bring the animal in to get its booster shots, like for a kid. Uh, but other than that, no, they're not required to bring the animal in.

Kessinger

Okay. And I believe that Kim Ward put in an email, she said...let me flip to it real quick...look like...and Kim Ward appears to send an email saying that it's becoming an issue of neglect on our part, as far as I'm concerned. Do you recall that being said in an email?

**Brosko** 

That...I've, I've read the email since all this has come out, but no, that email was never sent to me, nor did anybody say that. To me.

Kessinger

Okay. And in your opinion, uh, or I'm sorry, not in your opinion, but while you were aware of the incident with Sadie, did you ever feel there was an issue of neglect for Sadie?

No.

Now as far as what kind of uh, procedure does somebody have to go through to be considered a foster for one of y'all's animals?

Brosko

It, it's uh, a longer application process, so basically what happens is they'll fill out a packet uh, of information and then it comes with a foster manual that explains exactly what's required of the fosters and then the foster coordinator will actually sit down with that individual and talk to them uh, just to try to figure out their experience level and ask 'em questions about uh, you know, how many animals they have in the, in the home...what kind of animals that they're willing to foster, those types of things...and then uh, once that happens then, just like a normal adoption process, that individual uh, their name and address is searched in our database uh, so it's basically just to make sure that there, there's no previous history of any issues with animals. And then once that is done then the, the individual uh, can become a foster.

Laytham

Okay. So there is a manual that this uh, that

fosters get?

**Brosko** 

That's correct.

Laytham

And in that manual does it cover that they're responsible for the daily care of the animal?

Brosko

Sure. Um-hmm.

Laytham

Uh, now when y'all do a search to make sure they haven't had any incidents, as far as any previous complaints to neglect or anything of that nature?

Brosko

That's correct.

Laytham

Uh, now do all your fosters have to be a Louisville or a Jefferson County resident?

Brosko

They, they do not. We're a little bit more selective uh, as far as fosters out of county because we don't have jurisdiction uh, so tho...that's a situation where uh, it's on a very, very limited basis if there's a foster that's outside of the county.

Laytham

Do you know whether or not Miss Adkins lived in the county or not?

Brosko

I'm, I'm not sure if she did. I know that we...if they're outside of the county I know we do uh, a home visit just to make sure...we do a home visit on two different...two different occasions. One if they're out of the county 'cause we don't have any records uh, of the past. And then two, if they have uh, more than ten animals uh, we would do that...we would do that home visit.

Now if they live out of the county do you
