INTERVIEW WITH OFFICER LISA NAGLE

On October 20, 2014, at approximately 1523 hours an interview was conducted with Lisa Marie Nagle. Ms. Nagle is employed by the Louisville Metro Police Department.

The interview was conducted at the office of the Public Integrity Unit located at 810 Barret Avenue. Also present during the interview was Sergeant Marcus Laytham. Lisa Nagle has been employed with the Louisville Metro Police Department for approximately eight years. During the time frame of this incident Officer Nagle has been assigned to the First Division located at 416 North 29th Street Louisville KY. Officer Nagle gave a recorded statement and provided the following key aspects of the interview:

- Officer Nagle learned of Sadie's case from the media after the dog had been euthanized.
- Officer Nagle had no involvement with this case or any prior knowledge of Sadie's injuries.

I was requested by Metro Council members Kelly Downard and Cindy Fowler to speak with Officer Lisa Nagle regarding this case. Officer Nagle has no knowledge of any wrongdoing on the part of LMAS and was not aware of Sadie until this case went public by the media.
