

INTERVIEW WITH AMANDA CROOK

On November 5, 2014, at approximately 1148 hours an interview was conducted with Amanda Nicole Crook. Mrs. Crook is more specifically identified as:



The interview was conducted at Louisville Metro Animals Services located at 3705 Manslick Road. Also present during the interview was Sergeant Marcus Laytham. Mrs. Crook was employed at Louisville Metro Animal Services (LMAS) as the Rescue/Adoption Coordinator during the time frame of this investigation. Mrs. Crook's interview was taken in the form of a sworn statement and the following are the key aspects of the interview:

- Amanda Crook was made aware of Sadie when Rebecca Eaves (President of Arrow Fund) called her personal phone and requested she transfer the dog over to the Arrow Fund. Mrs. Crook stated "it's no questions asked."
- Amanda Crook's position at LMAS, is to coordinate all animal transfers to rescue organizations, either local or out of state.
- Heather Adkins was employed with LMAS.
- LMAS provides fosters with dog and cat manuals, to include instructions if medical needs are required. These manuals include general care, general wellness and LMAS hours of operation, along with contact information.
- Amanda Crook knows Heather Adkins, but was unaware that Heather Adkins was fostering Sadie, until she received this information from Rebecca Eaves.
- Heather Adkins did not contact Amanda Crook to inform her of Sadie's condition or medical needs.
- Amanda Crook said most dog fosters that she has dealt with in the past, are healthy with no medical issues.
- Once the animal has been transferred to the Arrow Fund, LMAS has no control over the animal and is no longer the property of LMAS.

- The night Rebecca Eaves called Amanda Crook and requested the dog be transferred to the Arrow Fund, Sadie was on the way to Blue Pearl Hospital. Sadie was in the custody and care of Heather Adkins.
- Kim Ward was the foster coordinator with LMAS and responsible for facilitating animals that go into foster care.

I was cleaning...I was early shift at Animal House, and she called my personal phone and she asked me to transfer a dog out to the Arrow Fund. And when Rebecca asked...asked me to do that, because she has in the past, it's no questions asked, I just immediately ask for the ID number and she gave it to me, I went in and looked it all up, change it in Chameleon, outed it to the Arrow Fund.

Okay. Have you, were you ever made aware of, of Sadie's injuries prior to gettin' a phone

call from Miss Eaves?

Crook

No, I was not.

Kessinger

Did Miss...did Miss Eaves ever tell you the

condition of the dog?

Crook

She told me the situation after I had transferred

the dog to the Arrow Fund.

Okay. And if you would, your position at the

time when Sadie was in care of Animal Services and then the foster, Heather Adkins, could you tell me what your position was here at Animal Services?

Crook

I was uh, the rescue coordinator.

Kessinger

Which you currently are now.

Crook

Yes.

Kessinger

And explain what, what your job or your

position is, please.

Crook

Uh...I am...I coordinate all animal transfers to rescue organizations that uh, either local or out of state. Uh, this does include medical cases, uh...I facilitate transports uh, out of state, uh, make sure that the animals are worked up medically, and all the paperwork is ready for when the animal is picked up or transferred out of state.

Kessinger

Okay. Uh, do you know Miss Adkins?

Crook

Yes.

Kessinger

Was you aware that she was fostering the dog,

Sadie?

Crook

Not until Rebecca called me.

Kessinger

Okay. At any time had, had Miss Adkins ever come to you with any complaints or stating anything in regards to the condition of Sadie...

Crook

...No...

And at the time was Miss Adkins employed here? Animal Services while she was fostering

Sadie?

Crook

Yes. She was still employed.

Kessinger

Now when dogs go out to be fostered what...can, can you explain to me what they're provided? To be uh, to take control of a dog? Are they given any paperwork? Any manuals?

Crook

They're...we have the...once someone fills out the uh, foster application and it's approved, we are required to give them a foster manual, which is pretty basic uh, dog and cat manuals, uh, just general care, general wellness...uh, and then also like our hours, if the animal gets sick...uh...what do. who contact...uh...instructions on, you know, if...if the dog needs to be adopted...general...just general things like that. Uh...in a medical situation like this, I...I would...I would assume would vou need little further...uhm...documentation and kinda like here's what you need to do...but again I...most of the fosters that I've dealt with, or dog fosters are like healthy. they don't have medical issues like that.

Okay. And you said Miss Eaves contacted you

by phone...

Kessinger So whatever medical attention it's, it's given or

whatever decision is made to, to either treat the

animal or to euthanize the animal that is...

Crook ...The rescue.

Kessinger ...the rescue who just took custody and care of

that dog.

Crookcorrect. Correct, yes.

Kessinger So when you, when you get an authorization,

you said you get the ID number...

...and everything over and you released the care to, to the Arrow Fund. Correct?

Crook

And do they have to call and say this is what we're doing with the dog?

Crook

When...if it is a dog that's not uhm, that doesn't' have medical issues, uh, because we have had dogs that went...they go up north uh, to uh, humane societies, I do ask that if the animal has behavior issues or if they want to...if they feel like they need to have a dog euthanized uh, that they let me know...uh, we can make the decision okay, go ahead and proceed with euthanasia or bring, we're gonna reverse the transport and you bring the dog back to us. Uh...but again, these are all healthy dogs, these aren't injured, medical issued dogs because they can't take those. Uh...so I would say...well, they...I mean in Arrow...in Arrow Fund's case the dogs that they pulled from us, are pretty, pretty bad. So if it is a situation where they need, hey feel like the dog needs to be euthanized then I'm in, I'm in complete agreement.

Kessinger

Okay. Now when they called you that night...when Miss Eaves called you...

Crook

...Um-hmm...

Kessinger

...who had possession of Sadie?

When Rebecca called me she said, I need you to transfer a dog to the Arrow Fund, the dog's on its way to Blue Pearl. I didn't ask who the dog, had the dog, what the situation was, until after I transferred the dog. From, from us to Arrow Fund. And then she told me what was goin' on with it.

Kessinger

Okay. Uh...can you...can you tell me...in, in what was said, what was goin' on with, with the dog?

Crook

She said that the dog was in a foster home and it had been in a foster home for a long time, and...oh, Gosh...I...I'm tryin' to think. Can...I mean the gist I got from it was it was one of our fosters, uh, that the dog didn't get what it was supposed to get, and now the dog needed emergency surgery.

Kessinger

Did she say that, what type of surgery...

Crook

...No...

Kessinger

...the dog had, and when, when you refer to "she" who is "she"?

Crook

Rebecca. I'm sorry.

Kessinger

Rebecca Eaves?

Crook

Correct.

Kessinger

Did Miss Eaves ever send any paperwork...medical paperwork or anything...after Sadie was euthanized...do, do they send paperwork back to you all here?

Not unless it's a court case. Uh, if we were to prosecute uh, there have been situations where I think she's done that.

Kessinger

Okay. Can you explain to me what the Chameleon report is?

Crook

Oh, which one?

Kessinger

Okay. The one that you said that when you got the ID number and then you got in to the Chameleon...

Crook

Uh, when you go in to the computer uh, you can find animals by, finding them primarily uh, a kennel number, uh, a foster's name, uh, but the fastest way for me to do it is to get in to the re...just the regular kennel screen and I look up an ID number, and...and she gave me that ID number and I found it, I used it fine in Chameleon, it'll pop up, and at the bottom of the screen, and I clicked on it to where the animal ID number came up. At the outcome, at the bottom part I, I put, I switched it to the Arrow Fund. Uh, and then transferred it out. I mean I can show you, if you...

Kessinger

Okay. Sgt. Laytham, do you have any questions?

Laytham

Yeah, and some of it's pro'bly just gonna be recapping, but uh, Rebecca Eaves called you and asked you to have the dog transferred to the Arrow Fund.

Crook

Correct.

Laytham

Do you recall the date that that happened?

transferred the dog that you find out what was

time, so...uh...

You...well, it depends on specifically if you wanna foster uh, you know, dogs or cats, obviously...uh, make sure that you are allowed to have animals on your property, any current animals in the home have to be up to date on vaccines and licensed...you know...ordinance requirement...uh, that you...we, we try to make sure that you don't take on something that you can't handle, uh...I'm tryin' to think...uh, that you're able to bring the animals in for uh, vaccinations, uh...and work-ups, if they need work-ups. Sometimes animals go in and they haven't been spayed or neutered, they uh, they go in to foster if they're sick...uh, and then they come back with their work-ups. Uh...it's pretty general, uh...but we don't get a lot of situations like, like Sadie's case.

Okay. Now as far as being uh, approved to be a foster, are home visits conducted by Louisville Metro Animal Services?

Crook

Sometimes. Yes.

Laytham

And what cases would those be, you think?

Crook

Uh...if...when, when Margaret was here it was

if they had 10 animals and up, she did uh, foster...or she did home visits...if there were uh, complaints uh, in, in our Chameleon database uh...neglect or uh, if we had documented cases of fosters coming in with their animals sick, uh, and, and not in the best of shape...uh, sh...I did go on one home visit with Margaret when she first started in Metro...uh, we went to a cat foster's apartment. Uh, I knew this foster 'cause she was a long-time foster. We just walked around in the apartment and made sure everything was clean, saw the animals that were currently in the house...they turned out they were, they were healthy.

Laytham

Okay. Now is it required that the foster live within Jefferson County to be a foster?

Crook

Yes. Uh...the only stipulation to that is if they are a Metro Animal Services employee.

Laytham

Okay. So if they're a Louisville Metro Animal Services employee they're allowed, they can live out of the county.

Crook

...Correct. Yes.

Laytham

And do you know whether or not that was the case with Miss Adkins?

Crook

I don't think so, I thought Heather lived in Louisville.

Female

Excuse me. I'm so sorry. Did you want me to sit in on here? By chance?

Kessinger

Uh, if you don't mind I just like to speak with
