Hi Cynthia, Thanks for talking with me this morning regarding the request to assist the Nicholas Meadows subdivision. This development is off Manslick Road with rear fencing along 15-20 homes along Manslick Road. The fence is actually on the easement. We have had numerous issues with the wood fence planks deteriorating, being hit by vehicles and/or destroyed via vandalism.
