Please allow the record to reflect that Councilman Kramer, Stuckel, Yates have excused absences for this evening.

MR. CLERK: So noted.

PRESIDENT TANDY: Colleagues, with regard to Councilman Yates, if you would, I would like to ask you to join me in a moment of silence in recognition of Councilman Yates' mother. As many of us know, maybe some of the public knows that Councilman Yates unexpectedly lost his mother over the weekend and so his family is certainly in our thoughts and prayers. So if you would please join me in a moment of silence. Thank you.

Next, Mr. Clerk, we have introduction of our page for the evening.

Councilman Owen, would you please introduce us to your page.

COUNCILMAN OWEN: I will. Our page this evening is my firstborn granddaughter, Zoe Ann Peterworth. She is a resident of the eighth district. She lives with her sister Kate and her father Jamie Peterworth and her mom, my daughter, my firstborn child, Alyssa Owen. She, Zoe, is six years old. She attends Bloom Elementary School. When I ask her, what do you like? She said I like school, I like to ride my scooter, I like to

run -- I can testify to that -- and she likes to go to the zoo. And I said, I know it's early, but if you can imagine, what would you like to be when you become an adult? And her answer is two-fold. She would like to be an artist and a zookeeper. So I think holding those two things would be a challenge, at least at this point. So, Mr. President and colleagues, welcome Zoe Ann Peterworth as our page tonight this evening.

PRESIDENT TANDY: All right. Well, thank you, Zoe. We are glad you are here to help us keep your granddad in line. We will be looking at you for help.

Next we have addresses to council. Mr. Clerk, if you would please call your first addressee.

MR. CLERK: Bob Schiavone.

BOB SCHIAVONE: Yes, sir.

PRESIDENT TANDY: Mr. Schiavone, I say this for all the people, so it is not directed to you, but we will remind everyone who is addressing the council to please refrain from profanity or refrain from making derogatory statements to council members. So with that said, your time will begin once you start speaking.

BOB SCHIAVONE: Members of council, I want to thank you for allowing me to speak this evening. My name is Bob Schiavone representing One Plus One Equals Two, giving a chance for the people in Louisville. I want to introduce my teammates, Margaret Dunbar, Anika, been with us the whole eight years, Jocelyn, and Edmond. We have several members not here with us tonight. I commend you for building and putting a lot of money into infrastructure in the city of Louisville but mainly the focus in the west end. I would like you to know we are trying to invest in the

infrastructure of our youth and children, keep them out of trouble, in school, and help them know the difference between an ACT score and a GED.

In front of you, you have packets that give you a glance of what one plus one is all about. This weekend is a perfect time for us. We have our eighth annual lock-in retreat. I invite each and every one of you, if you have time, I know you have busy schedules, stop and visit us at Harris Creek Church to see what we are doing. We don't just lock the children in -- these are high school students -- we teach them the ins and outs of life. We have programs the entire day. We have ice cream. Food is given the whole time, but we are locked in for 48 hours. We have the summer program, which is mainly the focus in July. That is held at the Shawnee Arts and Cultural Center.

A big focus of this last year was working with a therapist and getting the gang "YNO" off the street and more in line with the rest of the city of Louisville. We also have a brief look at some of the civic-minded duties we do as a board to set the kids straight, let them know there are right choices, being a mentor. We have been working out of Central High School for eight years and proud to say that by the end of the summer we will be at 40th and Muhammad Ali in the heart of where we work with the children in the west end of Louisville.

You also have testimonials here in your packet. And looking at it as I wrap up, we are building in buildings, we want to build into human character and know that we can make a difference, not only through government, through school, but mentoring and letting kids know that there is a place they do matter. A lot of them don't have fathers or mothers or they are separated, the aunts or grandmothers are raising them. They look to Margaret, she worked effortlessly for eight hours. I challenge you to

come to our retreat and see what we are about with the kids we are working with. My whole focus is to bring awareness to this. We survive on grants, and I ask you when you do your budgetary processes, I know a lot of people hit you up for money, but we are working with our youth. That matters in each and every one of your districts. The buzzer is up. I thank you for your time and attention and hopefully we can see you soon.

MR. CLERK: Ted Gatlin. Ted Gatlin.

MARIA SMITH: Good evening. Thank you for allowing us to be here tonight. I represent Harbor House. And Harbor House is a training center for individuals with disabilities. We strive every day to empower those individuals to live fulfilled and productive lives and to offer services for their families. So you know what happens on September 26th this year? Yes, the Kentucky Derby. And you have in front of you our media kit, what we did and where we were. Jefferson County Public Schools allowed us to come in, you'll see the art contest and the T-shirts. Those who sponsored us last year you will have your gifts forthcoming. But JCPS got behind us last year and did the posters and T-shirts, so you will have that coming.

About ten weeks before the derby we will be adopting ducks out for \$5 a duck. That winning duck wins a brand new car from Sam Swope Honda World. This year also the person who sells that winning duck is going to win at least a thousand dollars' worth of gift certificates they can use within our community. This year the race will include a festival of music with the Monarchs. We will have a lot of food vendors and activities and things for the children. I know many of you have taken advantage and joined us at Joe's Crab Shack. That's where the race takes

place. But this year we are also adding the community outing for companies. Companies are sponsoring the day for their employees. Joe's Crab Shack is joining us and helping us with that. So there will be food for employees and a tent for the different employers who are sponsoring us this year. Last year we raised over 165,000, and this year we want to make it an even bigger success, and we are having for your help to do that.

We started a new program and what comes from the duck sales goes back into the programs and services that we deliver. Home sweet home is a new service delivery program combining individuals who want to who can to go into seniors' homes, to be paid for the work they do and help seniors with required housekeeping duties, cooking, laundry, grocery shopping. We started that program and piloted it for a year. Very successful. We are in about 15 to 20 homes now. So the money that you give and the support that you give goes back to help support not only our individuals with disabilities but our seniors in our community who need these services as well.

So we encourage each of you to come up. We are always open to tours. And for those of you who have supported us, we are very, very grateful. So thank you again. I know I have ten seconds. We appreciate your support and what you do for Harbor House in supporting individuals with disabilities. Thank you.

MR. CLERK: Travis Yates.

TRAVIS YATES: Hello, and thank you for letting me come tonight and speak in front of you. I'm here tonight because I would like to speak in support of the affordable housing trust fund. I'm a property manager by trade and I do affordable housing. I'm the president and CEO of a



for-profit and not-for-profit property management and developer for affordable housing in the state of Kentucky. We have 4,000 units, 1,600 here.

About a year and a half ago I was asked to serve on the Affordable Housing Trust Fund Board with no expectation as to what that meant. And I truly dealt with affordable housing funds as a project, especially across the street, but I never heard of it in Louisville. As a result, I went to sit thinking I don't know where I'm going with this, but at least I can listen. I have plenty of opinions. I was fascinated quickly at the expertise of that board. And not just -- I figured it was going to be more folks like me, I figured it would be more developers like me, but, no, there were council members, there were attorneys, bankers, other coalition members that comprised it and that mix of opinions. And I was afraid there would be some unwritten rules when I sat down. That mix of opinions -- nobody held back. And I had a myriad of questions. I'm sure I annoyed them with my questions the first three or four times that I showed up but they listened to me and we really worked through them and I was amazed at their efficiency. I know that they were given 178,000 and they took it out and turned that into one and a half million dollars' worth of real estate transactions in 17 affordable housing units and then they were given a million dollars of home funds, which was not new to the city but they were allowed to administer them and got them out within two months through an RFP process, which I thought was incredible for a group that has not done it too many times.

But what the board has lacked is dedicated funding resources. I went to Lexington and I had two projects down there that literally back to back I met down there and they had a small thing to do and they had a big

thing to do. And back to back meetings without knowing it I met their affordable housing trust fund person and said there is no reason Louisville can't do this. The one is multifamily. I was amazed at the lack of red tape behind it and I'm really fascinated to see what this city can do with a dedicated funding source, a large dedicated funding source that hit every year with that same type of flexibility and ingenuity that goes into it from folks that just really want to hit that mission. Thank you for listening to me and I appreciate you all hearing me out.

COUNCILWOMAN FLOOD: Thank you, Mr. President. Colleagues, I would like to take the opportunity, if I can have my guests stand up. They are the Knights of Columbus Troop 376. Please stand, guys. St. John's, the 23rd council working on their merit badges. One of them I have known since he was very small, I won't call him out by name, but if you look you are on TV, you can wave to your family. These are a bright addition to our future.

PRESIDENT TANDY: Let's give them a round of applause, please.

Thank y'all for coming and the work that you do throughout the community.

I want to take a point of personal privilege as well tonight. May is National Bike Month and we all know that tomorrow is Ride Your Bike to Work Day in our city. We have among us an avid bike rider in the form of Councilman Tom Owen. And every day when he comes down to city hall he takes his bike and he locks it up on one of the rails that we have --

COUNCILMAN OWEN: Wait a minute. Where is this going?

PRESIDENT TANDY: -- in front of city hall. And I knew this was bike month. We kept looking at city hall and I said, we don't have a bike rack at city hall. And it is bike month at city hall and Tom Owen always rides his bike to work.

So, Jess, if you would, we are having installed a bike rack, and this is the plaque.

And this is the plaque that is going to go by that bike rack, and it reads:

In dedication to Councilman Tom L. Owen, a dedicated public servant, avid cyclist, and firm believer in public transportation, presented by the Louisville Metro Council May 15th, 2015, in recognition of National Bike Month.

COUNCILMAN OWEN: Thank you very, very much.

PRESIDENT TANDY: So we kept this a secret from him.

COUNCILMAN OWEN: It's a secret, all right. And I have always said when my bike is tied with my lock to the railing out there -- I said,

I'm not sure. If somebody complains, tell them the mayor said I can do it. Now I don't have to do it. I have a legitimate bicycle rack. Thank you.

PRESIDENT TANDY: So we encourage anybody else who comes here riding their bike, they can do so.

COUNCILMAN OWEN: I'll use it.

PRESIDENT TANDY: But we do appreciate the efforts that you use, Councilman Owen, to make sure that public transportation here in our and biking, for that matter, is well-recognized and well-received. So we appreciate you.

MR. CLERK: There are 20 yes votes and six not voting.

COUNCILWOMAN LEET: Yes, I would like to make a motion to invoke Rule 7.12.

>> Second.

PRESIDENT TANDY: Properly moved and seconded to invoke Rule 7.12 -- with regard to what particular piece of legislation?

COUNCILWOMAN LEET: Item number -- help me out --

>> 63.

COUNCILWOMAN LEET: 63.

PRESIDENT TANDY: All right.

COUNCILWOMAN LEET: Thank you.

>> Second.

PRESIDENT TANDY: So it has been properly moved and seconded that Rule 7.12, which is our rule on the council that will suspend Rule 7.01, requiring two readings of an item to be voted on -- an ordinance to be read twice before it can be passed by the council. So that everybody is clear, what we are voting on is whether or not to suspend the rule itself. You are not voting on the merit of the ordinance itself, okay. And this is an item that is a non-debatable item. So we are not debating the merits of whether or not the rule should be invoked or not.

Councilman Owen.

COUNCILMAN OWEN: A point of personal privilege. I was out for just a brief moment when this was introduced. So a no vote on this motion would be not to suspend the rule.

PRESIDENT TANDY: That's correct.

COUNCILMAN OWEN: I understand.

PRESIDENT TANDY: That's correct.

Councilwoman Flood.

COUNCILWOMAN FLOOD: Just to make sure it is clarified. A yes vote means we will be voting on this issue tonight?

PRESIDENT TANDY: That's correct.

COUNCILWOMAN FLOOD: Thank you.

COUNCILWOMAN WOOLRIDGE: Mr. President.

PRESIDENT TANDY: Councilwoman Woolridge.

COUNCILWOMAN WOOLRIDGE: This first vote we are taking, is that a majority vote?

PRESIDENT TANDY: No. Per our rules, this requires 18 votes in the affirmative to support suspension of the rules and in support of the motion that is being made.

COUNCILWOMAN WOOLRIDGE: Thank you.

PRESIDENT TANDY: Everybody clear? Any other questions? All right.

Madame Clerk, please open the voting. The voting is closing. And the voting is closed.

MR. CLERK: 16 yes votes, five no votes and five not voting.

PRESIDENT TANDY: The motion fails. So it will be introduced as new business and assigned to committee.

Our next item of business is item number 37.

Mr. Clerk, a reading of that item.

MR. PRESIDENT TANDY: Is there a motion?

>> So moved.

>> Second.

PRESIDENT TANDY: Properly moved and seconded. It is now before us.

Councilman Hollander, do you wish to speak to this ordinance?

COUNCILMAN HOLLANDER: Yes. This is before us on Old Business because two council districts added some money at the appropriations committee. This is money for programming costs to the Louisville Independent Business Alliance for the buy local fair, which is this Sunday at Louisville water tower park. A majority of the council districts are involved in the funding of this. At noon this Sunday, \$5 to park or you can bring your bicycle. I would urge approval on this. This is to support local businesses throughout our entire community.

PRESIDENT TANDY: Is there any further discussion? Seeing none -- it just popped up on there.

Councilman Downard.

COUNCILMAN DOWNARD: Thank you, Mr. President. I would like to add \$250 from District 16.

PRESIDENT TANDY: Councilman James.

COUNCILMAN JAMES: I can see that I have already done it. Thank you.

PRESIDENT TANDY: We are glad you did it.

Any other additions?

Seeing none, we will take that in the form of an amendment.

>> Second.

PRESIDENT TANDY: Properly moved and seconded. All in favor of the amendment say aye. All opposed? The ayes have it.

We now have the amended amended committee version before us. Any discussion on the ordinance?

Seeing none, Madame Clerk, please open the voting. The voting is closing. And the voting is closed.

MR. CLERK: 20 yes votes six not voting.

PRESIDENT TANDY: The ordinance as amended passes.

Mr. Clerk, please also allow the record to reflect that Councilman Ackerson will have an excused absence for the rest of the meeting.

MR. CLERK: So noted.

PRESIDENT TANDY: All right. Mr. Clerk, a reading of item number 38.

>> Second.

PRESIDENT TANDY: Properly moved and seconded. We now have the motion before us.

Councilwoman Denton.

COUNCILWOMAN DENTON: Thank you, Mr. President. This is a renewal of a service contract they already have with the University of Louisville to do research in conjunction with Louisville Metro police.

PRESIDENT TANDY: All right. Is there any further discussion?

COUNCILMAN OWEN: Point of personal privilege.

PRESIDENT TANDY: Council Member Owen.

COUNCILMAN OWEN: Yes. Colleagues, I will be abstaining on this. It is fair to say I'm a veteran employee of the University of Louisville, and in order to avoid possible appearance of conflict of interest, I'll be abstaining.

COUNCILMAN JAMES: And for the same reason, Mr. President. I'm not quite the veteran employee that Councilman Owen is, but I'm an employee at the University of Louisville and also wish to avoid any conflicts of interest.

PRESIDENT TANDY: Thank you, Councilman James.

Any further discussion? Seeing none, this is a resolution that normally would call for a voice vote but we are going to ask the clerk to open the voting so we can record those abstentions. So please vote now. The voting is closing. The voting is closed.

MR. CLERK: 18 yes votes, two abstentions and six not voting. The two abstentions are Council Members James and Owen.

PRESIDENT TANDY: The resolution passes.

Next item of business is item number 39.

Mr. Clerk, a second reading of this ordinance.

MR. CLERK: AN ORDINANCE APPROVING THE DETAILED DISTRICT DEVELOPMENT PLAN ON PROPERTY ZONED R-8A MULTIFAMILY AND LOCATED AT 1418 AND 1426 WILLOW AVENUE AND BEING IN LOUISVILLE METRO (CASE NO. 17822).

PRESIDENT TANDY: Is there a motion?

>> So moved.

>> Second.

PRESIDENT TANDY: Properly moved and seconded. It is before us. Councilman Owen.

COUNCILMAN OWEN: Thank you, colleagues. Both in committee and as well as here at the council I will be leaving the chambers in case there is discussion of this item. I have what is easily perceived as a conflict. My brother owns about a 14-plex immediately across the street from this proposed site. And for fear of a blatant conflict of interest, I will be leaving the chamber for discussion.

PRESIDENT TANDY: All right.

Councilwoman Flood.

COUNCILWOMAN FLOOD: Thank you, Mr. President. Unlike most of the things that come in front of the Planning and Zoning Committee, this is not a change in zoning nor foreclosure of an alleyway. This was for a detailed plan on the Willow Grand. It has been reduced from two floors, going from 201.67 feet tall. The variance on the setback of 70 feet was because landmarks had actually asked for that to be done because of the size and shape of the lot they are building on. This is a 216-foot building and the Willows is 217 feet tall. So they have reduced it by two stories. This came out of the planning commission unanimously and came out of our committee unanimously.

PRESIDENT TANDY: Any further discussion?

Seeing none, this is an ordinance calling for a roll call vote. So, Madame Clerk, please open the voting. The voting is closing. And the voting is closed.

MR. CLERK: There are 13 yes votes, six no votes, and seven not voting. The no votes are Council Members Green, Shanklin, Woolridge, Hamilton, James, and Denton.

PRESIDENT TANDY: All right. The ordinance passes.

Next item of business is item number 40.

Mr. Clerk, a reading of this ordinance.

PRESIDENT TANDY: Is there a motion?

Councilwoman Flood.

COUNCILWOMAN FLOOD: Thank you, Mr. President.

This is an existing industrial site in Councilman David James' district. It is going to be converted into office space. There are 432 parking spaces. It will also adhere to the Brownfield restrictions and the proposal retains the buildings on site. This is in Councilman James' district. He may want to address the council.

PRESIDENT TANDY: Councilman James.

COUNCILMAN JAMES: Thank you, Mr. President. I would just recommend passage of this.

PRESIDENT TANDY: Any further discussion?

Seeing none, Madame Clerk, please open the voting. The voting is closing. The voting is closed.

MR. CLERK: 20 yes votes and six not voting.

PRESIDENT TANDY: The ordinance passes.

Our next item of business is item number 41.

Mr. Clerk, a reading of this ordinance.

COUNCILWOMAN FLOOD: Thank you, Mr. President. This is an auto sales facility site. It will actually remain an auto facility site. The improvements to the area will include landscaping, repairs, and striping of the parking lot. The only person who spoke against it -- it really wasn't against it. They were afraid that it could become an adult entertainment place, and it was explained to them by the commission that is only allowed in M-3. But subsequently a binding element, number seven, was added to there that further states there shall be no automobile



repair, tavern, saloons or bars permitted on the site. This is an auto sales facility.

This is also in Councilwoman Marianne Butler's district. She may want to address the council.

PRESIDENT TANDY: Councilwoman Butler.

COUNCILWOMAN BUTLER: This currently is a little convenience store. It was a restaurant at one time. Hopefully with the landscaping and the repairs they are doing it will help clean up the corner. We are looking forward to that. They agreed to the binding elements. I hope it is a plus to the neighborhood and they are good neighbors to everyone that is there. So I urge you to support it.

PRESIDENT TANDY: Any further discussion?

Seeing none, Madame Clerk, please open the voting. The voting is closing. The voting is closed.

MR. CLERK: 20 yes and six not voting.

PRESIDENT TANDY: The ordinance passes.

Next item of business is ordinance 42.

It is well under the density of 14.2 dwellings per acre. This is in Councilwoman Marilyn Parker's district, and she may want to address the council.

PRESIDENT TANDY: Councilwoman Parker.

COUNCILWOMAN PARKER: Thank you. This is in my district. I believe there are very few that showed up at the public hearing and I think there was maybe one that spoke against it. It is not actually -- it is actually next to a neighborhood in my district, but I think that they are complying with the concerns of the neighborhood and the binding elements.

PRESIDENT TANDY: All right. Any further discussion? All right.

Seeing none, Madame Clerk, please open the voting. The voting is closing. The voting is closed.

MR. CLERK: 20 yes votes and six not voting.

PRESIDENT TANDY: The ordinance passes.

Our next item of business is New Business. Colleagues, as you leave the chambers, please do so quietly so that the clerk may read the new business. I ask those council members who wish to make announcements to please remain in the chambers and request to speak on your voting system once it has been opened up to do so.
