There is a wire can there now on dirt however can a permanent one be placed on the sidewalk, not requiring a pad? OK, should be able to place on existing concrete walk without need for new pad, just not in walking path.
- 7.) On Preston Street at Eastern Parkway, the N.E. corner by the bench there. This is a new can. A heavy plastic Metro can is there currently. OK, should be able to place on existing concrete walk without need for new pad, just not in walking path.
- 8.) On Eastern Parkway at Preston Street, the N.W. corner at the bus stop. This is a new can. OK, should be able to place on existing concrete walk without need for new pad, just not in walking path.
- 9.) On the S.E. or S.W. corner at either Bicknell Ave & Craig Ave or Bicknell Ave & Wheeler Ave. P.W. has OK'D either site, however we are working with Metro Parks on a 3 x 3 concrete pad to be poured for this location. We want to order the "HAZELWOOD NEIGHBORHOOD" receptacle now, however installation must wait for pouring that 1 concrete pad. This is the only pad needed!

- 6.) At the bus stop on Eastern Parkway at Preston Street (S.W. corner) in front of Family Dollar This is a new can. There is a wire can there now on dirt however can a permanent one be placed on the sidewalk, not requiring a pad?
