OVERVIEW

The West-end Kickball league is pleased to submit this proposal for services to support Councilwoman Mary Woolridge in achieving its goals for improving the west-end/ Algonquin park area by providing family, friendly kick back, get your Barbeque grill out, kickball games. These games will be held on Sundays tentatively starting May 31st 2015 and tentatively ending Sunday September 20th 2015.

The Objective

The Solution
