Vacant Lots Abatement

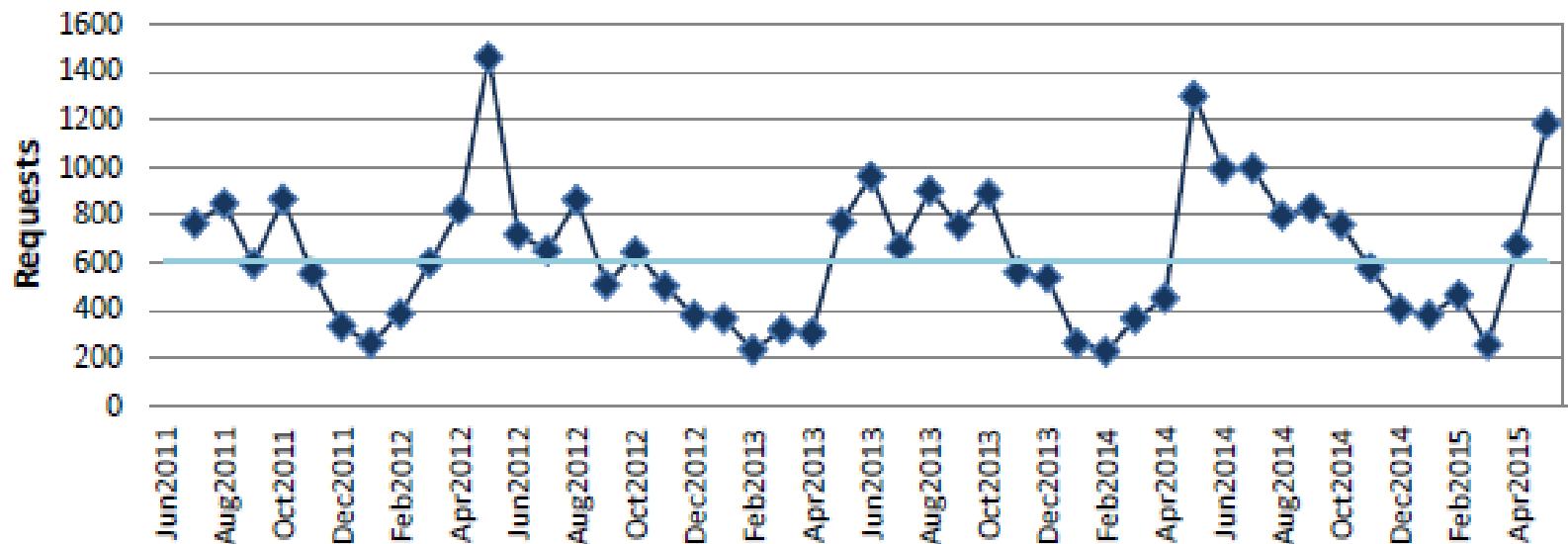
- ❖ Division Abates Property Maintenance Violation Referrals on Vacant Properties (Boarding & Cleanings).
- ❖ Maintains over 400 Metro controlled vacant lots.
- ❖ Responsible for 10 Metro Snow Routes.
- ❖ June 2014 – May 2015, Resolved 8,429 referrals.
- ❖ Partners with Corrections to run 3 inmate crews.
- ❖ Summer Works Program utilizing youth workers to assist in cleaning and boarding properties.

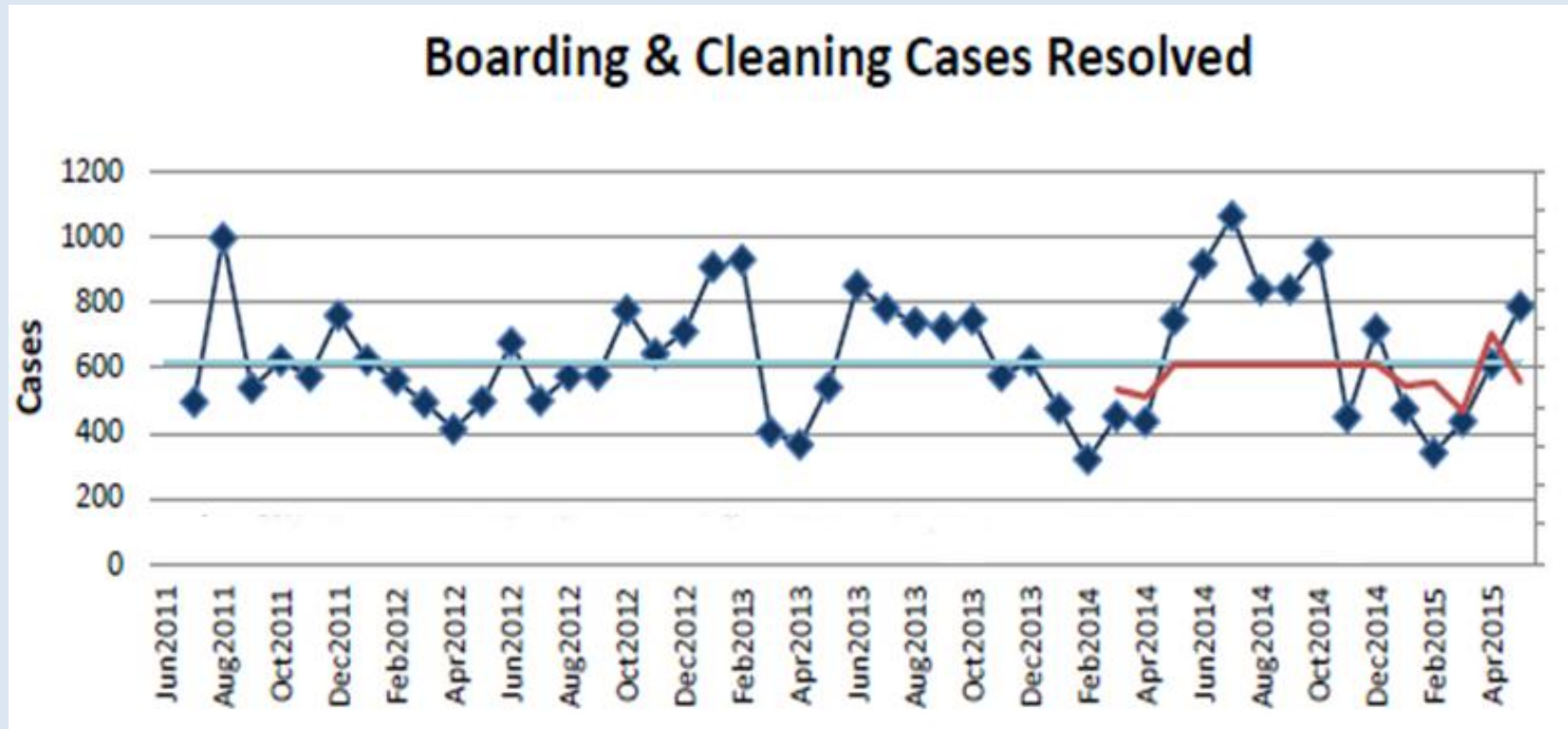
Vacant Lots Abatement

May 2015, 1,183 Requests Received

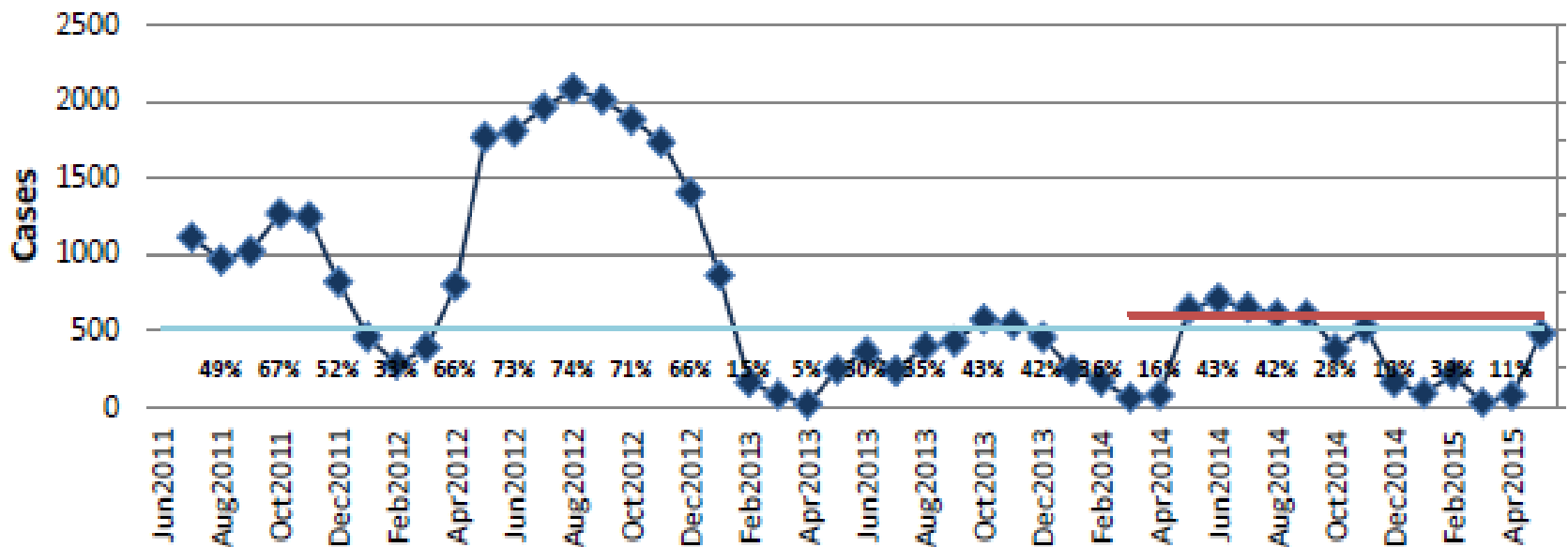
Vacant Lots Abatement

Property Maintenance

- ❖ Responds to Metro Call service requests regarding Property Maintenance Code concerns.
- ❖ Conducts Section 8 inspections for Louisville Metro Housing Authority.
- ❖ Customer Service team schedules hearings and maintains Code Enforcement & PM/Nuisance Hearing Boards records.
- ❖ Performed over 77,000 inspections fiscal year to date.
- ❖ Division currently has over 13,000 open PM cases.

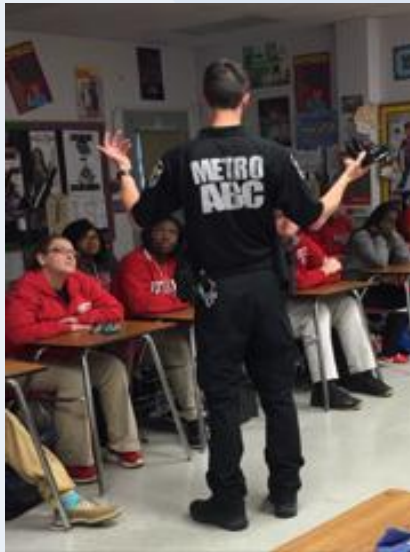

Miscellaneous types Licenses & Permits

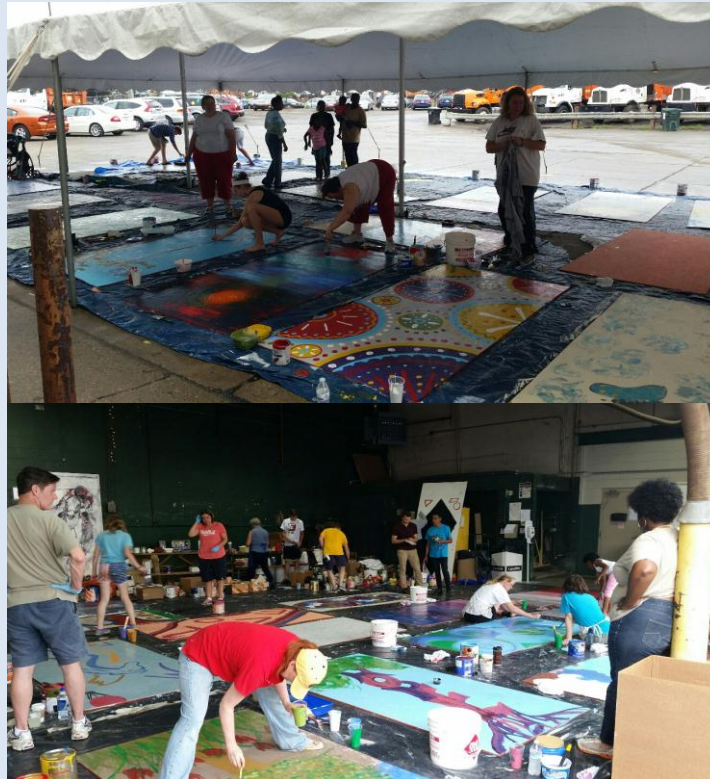
- ❖ ABC Licenses, Ground Transportation Companies, Ground Transportation Drivers, Charitable Organizations, Armed Security Companies, Armed Security Guards, Pawn Brokers, Street Vendors, Mobile Food Trucks, Adult Entertainment, Horse Carriages, Amusement Devices, Escort Licenses & Special Events.
- ❖ Performed over 5,400 inspections fiscal year to date.
- ❖ Issued and renewed over 3,500 license & Permits year to date.
- ❖ Presented Project Choices class to 15 Schools year to date.
- ❖ Performed 104 Minor Decoy visits fiscal year to date (10 Citations).


