PRO TEM JAMES: Thank you, Mr. Clerk. And please let the record reflect that President Tandy, Councilman Benson, Engel, Councilwoman Hamilton, Councilman Kramer, Peden, and Owen all have excused absences.

MR. CLERK: So noted.

PRO TEM JAMES: And we gladly welcome Councilman Downard to the other side.

COUNCILMAN DOWNARD: On a part-time basis.

PRO TEM JAMES: On a part-time basis.

Councilman Magre, please introduce your pages.

COUNCILMAN MAGRE: Actually, it is one page. And it is my pleasure. I laughed when I was texted today by Carrie that the resume, if you will, for Ethan. And normally these younger children, you think, well, would they really be able to have a resume yet? And actually this young man is pretty close. Ethan is a student at Walden School and the Russian School of mathematics. He is a member of the Duke University Talent Identification Program, the John Hopkins Center for Talented Youth, and Kentuckiana MENSA. Ethan will attend a Duke University program in North Carolina this summer, studying the environmental and engineering challenges of oil spills. He plays golf at Louisville's first tee program and tennis at the Louisville tennis center. He enjoys planting trees with his parents for Go-Green Germantown, which is a subset to the Schnitzelburg Area Community Council. Parents are Brian and Susan Brunton, who live in Schnitzelburg. In fact, Susan is the vice president of the Schnitzelburg area community council. I move Ethan as our page for this evening and commend him for how well he is doing in obviously academics, in his schooling.

PRO TEM JAMES: Mr. Clerk, are there any addresses to Council?

MR. CLERK: There are.

PRO TEM JAMES: For those that are going to address the council, let me say this to you. I'm not saying it to you in particular, but I say this to everyone that addresses the council. Please refrain from any profanity or from making any derogatory statements to council members.

MR. CLERK: Curtis Stauffer.

CURTIS STAUFFER: Good evening. As the clerk said, my name is Curtis Stauffer, the executive director of the Homeless and Housing Council in Kentucky. I want to thank you for the opportunity to speak tonight for the great chance to seize control of the city's affordable housing future.

First I want to applaud Mayor Fischer for Louisville Care proposal in his budget that would create gap financing for affordable housing. I especially want to applaud the mayor for making commitments to not only 1,500 affordable housing units in the first two years of Louisville Care but 24,000 units of affordable housing by 2030.

Louisville Cares is an important first step to meeting the goal but it is not enough. The mayor's press release made it clear. \$11 million will only address five percent of his goal and a recurring source of revenue is needed. Since Louisville Cares is a gap financing loan tool, it cannot create sustainable affordable rental housing that will serve extremely low income households earning less than median income. Metro Council has an opportunity to fund the Louisville affordable housing trust fund by a one percent insurance tax. There is a need for this resource. The National Low Income Housing Coalition finds that 62 percent in the low income houses, or 19,059 households, are cost-burdened, meaning they spend more than half of their income on housing. They found that Louisville needs 20,099 household units just for the people who earn less than median income. The shortage of housing has profound impacts. Louisville -- due to our great shortage of affordable housing units currently only those 16 or higher are being housed. This is evidenced by Kenneth Winfield, who died in the cold. He scored high enough but not high enough to be considered at-risk. Sadly, we cannot depend on the federal government to lead us out of this crisis. The home program's, HUD's, primary funding tools for development, has been cut over 50 percent since 2010. Public housing and voucher choice funding cannot meet great demand locally with over 20,000 households on the affordable housing trust fund wait list. I want to ask the council to ensure that affordable housing can be created throughout the metro by approving the bills before the ad hoc committee. I urge you to approve these changes and create a sustainable funding stream for Louisville affordable housing development by supporting both Louisville Cares and a permanent funding source for the Louisville Housing Trust Fund. Thank you for your consideration.

PRO TEM JAMES: Thank you.

[Applause.]

MR. CLERK: Mariam Williams.

MARIAM WILLIAMS: Good evening. My name is Mariam Williams. I live in District 6 and I'm speaking in support of the affordable housing trust fund on behalf of the Raven Institute for Social Justice Research. In 2013 the Louisville Human Relations Commission released Speaking Louisville, a home for us all, a twenty-year action plan for housing. The

author of the history portion of the report recognized that it was impossible to understand current state of housing in Louisville fully or to envision a fair housing future without first taking stock of the history of residential segregation, wider housing discrimination, and the many steps that citizens took towards progress. Housing in a layer cake pattern of black and white with varying incomes living next to each other before the Civil War to 45 percent of the city's residents living in extreme racial and economic segregation today through deliberate planning at local, state and federal levels. Even when battles against housing segregation and discrimination were won in the US Supreme Court, policies such as redlining, local zoning laws, and urban renewal created new patterns of segregation we still see today.

Point being it wasn't all about choice. And it wasn't at all as an early Louisville city planner suggested blacks' lack of ambition for something better. It wasn't just white flight or the 16,000 white families leaving the west end in the sixties to cause the Ninth Street divide. It was a city plan that demolished Louisville's black business district and middle class black housing, put an interstate in its place but didn't replace the homes and businesses African-Americans were using to try to build wealth they could have passed on to their children. It was zoning that continues to allow multifamily housing to be built on less than only a third of the county plan and that drastically narrows housing choice for people of low income. It was policy. But the good news is policy can be changed. The Human Relations Commission already has a plan to remedy Louisville's housing history in one generation. Louisville Cares is a good and necessary step not even in the report, and I applaud the mayor for laying out the initiative. But 750 affordable housing units over two years is not enough when we know the need is for 65,000. A dedicated public revenue source for the trust fund is still needed. And along with that a change in the zoning code is needed so that affordable housing can be built everywhere and for that people, most of whom are African-Americans, immigrants or refugees, single people living at home, and young professionals starting out aren't confined to neighborhoods where they don't have amenities are far from job centers, don't feel safe or where they and their children can't thrive. Thank you.

COUNCILMAN DOWNARD: Mr. President, council members and members of the public who are listening, I'm here tonight to honor Breana Owen. She is vice president of her junior class, recently selected as vice president of her senior class. She is a member of the national honors society, or she wouldn't be here, mu alpha theta honor's society, Ballard choir, and future business leaders of America. She was also selected to participate in the 2015 governor's scholars program.

But that's not why she is here tonight. She is here tonight because she has been accepted to participate in the University of Pennsylvania's Wharton school of business lead institute. One of only 30 students nationwide selected to attend this prestigious program and the only student selected from Kentucky. After graduating from high school she plans to major in finance, of course, and to eventually become a leader in a Fortune 500 company. Let me read the proclamation, which is fairly short and it repeats some of this but by gosh it is worth repeating.

Know ye that the Louisville Metro Council hereby honors and recognizes Breana Owens in recognition of her acceptance to participate in the University of Pennsylvania's Wharton School of Business Lead Institute. Whereas Breana is one of only 30 students selected nationwide to attend this prestigious program and the only student from Kentucky. And whereas Breana will spend four weeks in an intensive mini MBA program where she will attend lectures by distinguished Wharton school faculty and visit corporations in Philadelphia, Washington D.C., and New York City.

We hereby confer this honor with all the rights, privileges, and responsibilities thereunto appertaining. In testimony whereof, we have caused these letters to be made and the seal of the Louisville Metro Government to be hereunto affixed. Signed this eleventh day of June,

We had an amendment in committee that reduced District 14 by one penny and then added, you see several on there, District 8, 9, 16, 10, 12 and 15 and the numbers are there. The primary sponsor is Councilwoman Fowler, and she may want to speak.

PRO TEM JAMES: Councilwoman Fowler.

COUNCILWOMAN PARKER: Yes. Thank you, President Pro Tem. I would ask for you all to consider giving to this. This is the VITA program that you have heard before on many occasions. The difference this year, the reason for asking for funds at this time of the year is because the IRS stopped doing their onsite programs, and VIT is taking up the difference, having different satellite offices through October, and they just have to make up the difference somewhere so that the IRS -- since they aren't doing it anymore. So I really would appreciate your consideration, as in the past. It is a great program and it helps many low income families and individuals. So I appreciate your consideration. Thank you.

PRO TEM JAMES: Thank you, Councilwoman Fowler. I believe you have inspired some folks.

Councilwoman Shanklin.

COUNCILWOMAN SHANKLIN: Thank you, Pro Tem. District 2 would like to give 500.

PRO TEM JAMES: Okay.

And Councilman Yates.

COUNCILMAN YATES: Thank you. I just wanted to follow-up with Councilwoman Fowler. The return on investment with this is pretty substantial. District 25 would put forward a thousand dollars and hopefully expand the amount of people coming so we return the money back to the community.

PRO TEM JAMES: Thank you.

And Councilwoman Woolridge.

COUNCILWOMAN WOOLRIDGE: Thank you, Mr. President Pro Tem. District 3 would like to allocate \$500. Thank you.

PRO TEM JAMES: Thank you.

And Councilwoman Flood.

COUNCILWOMAN FLOOD: Thank you, Mr. President pro tem. District 24, a thousand dollars.

PRO TEM JAMES: Thank you.

Councilman Stuckel.

COUNCILMAN STUCKEL: District 17, 500.

PRO TEM JAMES: Thank you, Councilman Stuckel.

Councilwoman Leet.

COUNCILWOMAN LEET: District 7 would like to add \$500 as well.

PRO TEM JAMES: Thank you. And district number 6 will add \$500. How are we there, Mr. Clerk?

I'll accept a motion and a second to move this amendment.

PRO TEM JAMES: Councilman Johnson with 500 more. Is that amount correct, Mr. Clerk? An additional 1,500. Okay. Thank you.

So we are on the amended motion for \$1,500. All those in favor say aye. All opposed. The ayes have it.

May I have a vote, Mr. Clerk, on the entire ordinance? The voting is closing. The voting is closed.

MR. CLERK: 19 yes votes and seven not voting.

PRO TEM JAMES: Thank you, sir. The item passes.

Next we have, Mr. Clerk, if you could read item number 27.

PRO TEM JAMES: The ordinance is before us. Is there any discussion?

Councilman Stuckel.

COUNCILMAN STUCKEL: Thank you, President.

This is a request to change the zoning from R4 to M2. And the proposed use is an extension of an existing business, primarily for storage of trailers. This request is needed for a shallow swath of residential that sits between the current building and popular level road. A waiver was granted regarding the internal landscape areas. A public hearing was held on May 7th. No one spoke in opposition. The planning commission unanimously recommended approval 7 to 0, as did our planning and zoning committee 6 to 0. This is in Councilman Magre's district, and he will probably want to comment.

COUNCILMAN MAGRE: -- Yeah, I trust the committee's review of it and there was really no controversy, so I plan on supporting and ask my colleagues to do so.

PRO TEM JAMES: Thank you, Councilman Magre. Any further discussion on this item? Hearing none, this ordinance is requiring a roll call vote.

Mr. Clerk, please open the voting. Without objection, the voting is closing. The voting is closed.

MR. CLERK: There are 19 yes votes and seven not voting.

PRO TEM JAMES: Thank you. The ordinance passes.

Mr. Clerk, a reading of item number 28.

MR. CLERK: AN ORDINANCE CHANGING THE ZONING FROM OR-2 OFFICE/RESIDENTIAL AND C-2 COMMERCIAL TO C-1 COMMERCIAL ON PROPERTY LOCATED AT 4152-4178 TAYLOR BOULEVARD CONTAINING 2.71 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 14ZONE1037). As amended.

Read in full.

PRO TEM JAMES: May I have a motion and second for approval?

>> So moved.

>> Second.

PRO TEM JAMES: Thank you. The committee-amended ordinance is before us. Is there any discussion?

Councilman Stuckel.

COUNCILMAN STUCKEL: Thank you, Mr. President.

This is a request to change the zoning from OR-2 slash C-2 to C-1. This item was tabled in the last Planning/Zoning meeting in May because we didn't have the proper end everything for the buildings. This property is adjacent to Hazelwood Elementary, for a frame of reference. There are currently 11 lots included in this plan. Some are residences and some are office structures and some are vacant. The proposal calls for three buildings totaling about 26,000 square feet and including 147 parking spaces. One of the primary discussion items was the materials to be used for the buildings and the dump center enclosures. A binding element was added to require that the materials used for the dumpster enclosure match that of the buildings. A variance was approved regarding setback, a waiver to permit parking in front of the structure on tract two. A public hearing was held on May 16th. No one spoke in opposition. The planning commission unanimously recommended approval 7 to 0, as did our Planning/Zoning committee, 6 to 0.

This is in Councilwoman Butler's district, and I'm sure she'll want to comment.

PRO TEM JAMES: Councilwoman Butler.

COUNCILWOMAN BUTLER: Yes, thank you. We reviewed it and got an additional binding element in it, and I'm supportive of this and hope that vacant piece of property will become a flourishing business soon.

PRO TEM JAMES: Thank you. Any further discussion? Hearing none, this is an ordinance requiring a roll call vote. Will the clerk please open the voting. Without objection, the voting is closing. The voting is closed.

MR. CLERK: 19 yes votes and seven not voting.

PRO TEM JAMES: Thank you, sir. And the amended ordinance passes.
