STATEMENT TO METRO COUNCIL MEETING, July 16, 2015 by Daniel Cobble, Citizen – Page 1 of 2 –

"Pentagon Attempting to Steal Wellness Maintenance; Removing Corrupt Judges; Connie Marshall Stalker Still Not Pursued"

I am Daniel Cobble. First, please recall on April 16, 2015, I updated you on *Operation: Service-member [Wellness Maintenance]* (OSWM). *Wellness Maintenance* is my in-unit support system that addresses **post-traumatic stress**, **suicides**, and **sexual assaults** for U.S. service-members. This system may also be modified for Our veterans. Recall the evidence that Gov'mt is trying to steal away OSWM from me by refusing to issue an "implementation status."

Then, a few weeks later on May 12, we heard the horrific news report of Fort Knox soldier John Jonas, suffering PTSD, shot and killed his 11-yr-old daughter Tasha prior to killing himself in their front yard. Like everyone else, my heart was broken. I shook my head in disgust and wrote the attached May 29 letter to Sen. John McCain. If the President, Congress, and Pentagon were not playing politics with OSWM, then Tasha and her father could have been saved. **If not for my skin color**, I would be touted a hero for this critical contribution to saving lives. But just as Serena Williams is not being fully recognized for winning her 20th Grand Slam on Saturday, America is trying to ignore me, too.

As a nation, we cannot prevail **without some measure of wisdom**. Anyone who understands the basics of leadership, knows that <u>no good</u> will come from this immoral behavior. Just as Our currently bad monetary policy has "opened the door" to China's new international reserve bank, stealing my wellness system will further weaken our military; children, spouses and service-members will continue to needlessly suffer. Again, 11-year old Tasha and her father did not have to die.

Next, on June 25, 2015, Thomas Reed reported the **Notice of Removals** filed on five judges, as attached here again. Two of these judges, **Irv Maze** and **Anne Haynie**, have liens filed against their indemnity bonds;
thus, today, they are illegally hearing cases. – With refusal to remove these
judges, we are operating invalid government.

And finally, **on March 12, 2015**, Mr. Reed gave you copy of my March 6, 2015 certified letter to Police Chief Robert Conrad, as attached again, providing a photo of a stalker at the residence of Connie Marshall. Since no investigation is affirmed by Chief Conrad, Ms. Marshall still lives under this terroristic threat.

Threats, & Ku Klux Klan in Metro Gov'mt; See Photo of Perpetrator

Dear Chief Conrad,

As you well know, Ms. Connie Marshall has been receiving the many, longtime, racist emailed death threats from persons affiliated with the LMPD. Last year we submitted to you copy of our **March 4, 2014** Request for **Investigation** [of these death threats on Ms. Marshall] to the Louisville F.B.I. (to Special Agent-in-Charge Perrye K. Turner).

Whereby, attached, please see Ms. Marshall's Jan. 9, 2015 1) photograph[flyer] of a perpetrator at her home. Said perpetrator is referenced as an "agent" in both the attached 2) Feb. 11, 2015 & 3) Feb. 27, 2015 emailed death threats. In said 2-27-2015 death threat, for exmaple, it so states, "take down the pictures of our agent..." [from your website]. Here, we now have material evidence, the face of a perpetrator connected to these longtime death threats. For I, too, am threatened in the 2-11-2015 email.

The emails' explicit language of racism exemplifies the <u>Ku Klux Klan</u> within the LMPD / Metro Government . . . such as, "This is a slave state."

Another attachment is the Feb. 11, 2015 4) anonymous email to the Metro Council posing as Ms. Marshall, attempting to cancel her speaking to the Council meeting on Feb. 12, 2015. But Ms. Marshall protested and was allowed to speak.

I first reported these 2015 developments to LMPD on Feb. 14, 2015. Then, on Feb. 22, 2015 I further gave to LMPD Officer Lance T. Kelly (Badge 7134) said photograph[-flyer] and said anonymous email to the Metro Council. See attached the "incomplete" 5) LMPD Police Report #80-15-011883 that does not even specify Ms. Marshall as a "victim." And, the LMPD Sixth Division has not contacted me or returned my phone calls regarding its investigation. – Chief Conrad, LMPD has a legal obligation to investigate this terroristic threatening, intent to murder, etc, and presence of the Ku Klux Klan in our government.
