Good morning all. We have printed 3 honorary signs dedicated to Rev. Kirby and they may be ready to install as early as this coming Monday (7/20/15). Barbara Hall will send everyone an image of the sign if desired. They are our standard honorary signs. There are no variations offered. Typically we like to install these just a day or 2 before the ceremony / unveiling. As I understand it, you would like to schedule this by the end of July and that will certainly work for us. It was wise that 3 signs were requested, as 2 will be installed and 1 may be handed to the recipient during the ceremony. If the ceremony is to be scheduled during regular business hours we will make efforts to have a crew on site. Someone will need to climb a ladder and remove the material covering each sign -- unless you are 10 feet tall like Councilman Tandy -- he likes to do it himself! Anyone may come to our shop and pick up the extra sign (1450 Lexington Rd.- come upstairs and ask anyone). We plan to install each sign at the SOUTH SIDE of Algonquin. One at 23rd & Algonquin and the other at Cypress & Algonquin. Please let us know if you wish them too be placed elsewhere. It will all be smooth sailing from here on out.
