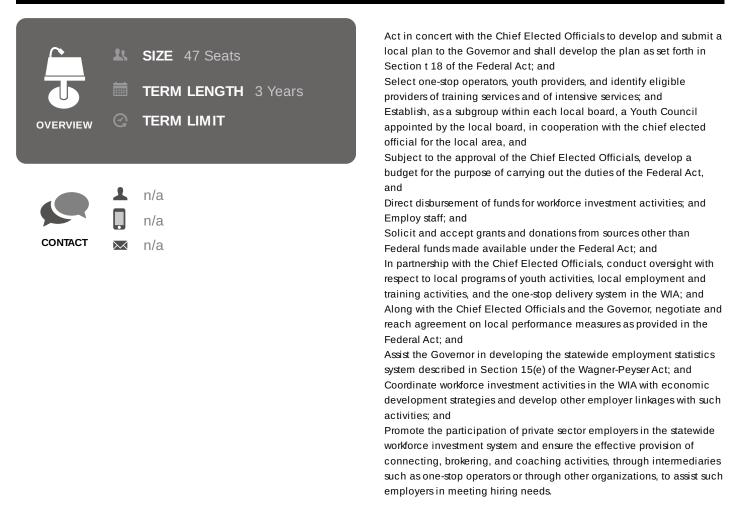

	POWERS	The Corporation shall have all pow ers conferred upon a non-stock, non-profit Corporation under the provisions of KRS 273.161 through 273.287, as amended, and specifically shall have all pow ers necessary and convenient to enable it to

	implement federal, state, local or other law s and/or grants consistent w ith binding local agreements.
REMOVAL	Any director w ho fails to resign w hen such director ceases to ba rep of the interest group from w hich such director w as appointed may, upon notice and opportunity to be heard, be removed as a director by action of at least 2/3rds of the other directors present at a duly constituted meeting called upon notice to consider such removal. Any Director may be removed by majority vote of the board for reason of malfeasance, misfeasance, or neglect of office.

How Appointed	By Mayor and by County Judge/executives of participating counties: Jefferson, Bullitt, Henry, Oldham, Shelby, Spencer, Trimble.
QUALIFICATION OF MEMBERS	<ol> <li>Private Sector. Representatives of business who are owners of businesses, chief executives or operating officers of business, and other business executives or employers with optimum policy making or hiring authority. Representatives shall represent businesses with employment opportunities that reflect the employment opportunities of the Greater Louisville area and shall be appointed from nominations of local business organization and business trade associations in the Greater Louisville area.</li> <li>Labor Organization. Representatives of labor organization, nominated by local labor organizations in the Greater Louisville area, including, not limited to, the Greater Louisville Central Labor Council and the Louisville Building and Construction Trades Council.</li> <li>Community Based Organizations. Representatives of community based organization in the Greater Louisville area (including organizations representing individuals with disabilities and veterans).</li> <li>Economic Development Agency. Representatives of economic development agencies including private sector economic development entities in the Greater Louisville area.</li> <li>One Stop Partner. Representatives of local educational entities from the Greater Louisville area, including reps of local educational agencies, local school boards, entities providing adult education and literacy activites, and postsecondary educational institutions (including reps of community colleges) selected from among individuals nominated by regional or local educational agencies, institutions or organizations representing local educational entities.</li> <li>Members of the board that represent organization, agencies or other entities shall be individuals with optimum policymaking authority within the organizations, agencies and entities.</li> </ol>
PURPOSE	Act in concert with the Chief Elected Officials to develop and submit a local plan to the Governor and shall develop the plan as set forth in Section t 18 of the Federal Act; and Select one-stop operators, youth providers, and identify eligible providers of training services and of intensive services; and

Establish, as a subgroup within each local board, a Youth Council appointed by the local board, in cooperation with the chief elected official for the local area, and Subject to the approval of the Chief Elected Officials, develop a budget for the purpose of carrying out the duties of the Federal Act, and Direct disbursement of funds for workforce investment activities; and Employ staff: and Solicit and accept grants and donations from sources other than Federal funds made available under the Federal Act; and In partnership with the Chief Elected Officials, conduct oversight with respect to local programs of youth activities, local employment and training activities, and the one-stop delivery system in the WIA; and Along with the Chief Elected Officials and the Governor, negotiate and reach agreement on local performance measures as provided in the Federal Act; and Assist the Governor in developing the statewide employment statistics system described in Section 15(e) of the Wagner-Peyser Act; and Coordinate w orkforce investment activities in the WIA with economic development strategies and develop other employer linkages with such activities; and Promote the participation of private sector employers in the statew ide w orkforce investment system and ensure the effective provision of connecting, brokering, and coaching activities, through intermediaries such as one-stop operators or through other organizations, to assist such employers in meeting hiring needs.
