

ORDINANCE NO. 171, SERIES 2015

AN ORDINANCE AMENDING ORDINANCE NO. 136, SERIES 2015 BY ADDING \$400 FROM DISTRICT 11 AND \$600 FROM DISTRICT 21 NEIGHBORHOOD DEVELOPMENT FUNDS TO THE ALREADY APPROVED \$17,250 FOR A NEW TOTAL OF ~~\$17,650~~ \$18,250; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE WAR AGAINST VIOLENCE CORPORATION FOR COSTS ASSOCIATED WITH THE "YOUTH ALERT!" VIOLENCE PREVENTION/HEALTH COMMUNITY OUTREACH PROGRAM (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$400~~ \$1,000 is hereby appropriated from ~~District 11~~ Neighborhood Development Funds as follows: \$400 from District 11; \$600 from District 21, by amending Ordinance No. 136, Series 2015, which approved \$17,250 in funding, for a new total of ~~\$17,650~~ \$18,250; through the Office of Management and Budget, to the War Against Violence Corporation for costs associated with the "YouthAlert!" Violence Prevention/Health Community Outreach Program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
