Vacant & Public Property Administration VAP Foreclosure Outcomes

59 - Properties Auctioned at the Master Commissioner's Sale.

- 285 Cases Filed in Court on behalf of VAP Staff.
- 355 Cases Referred to the Jefferson County Attorney's Office from VAP Staff.

**1,211** - Foreclosure Referrals from residents, business owners, public safety agencies and code enforcement officers.



We've made progress, but there's more to do....

- Code Enforcement Liens elevated in priority.
- Metro begins proactively foreclosing on code liens and taxes.
- Right of Redemption period reduced to 6 months from 12 months.
- HB Bills ### & ### passed the State House of Representatives.
- The Catalytic Fund and Kentucky League of Cities support VAP legislation.
