JUSTIFICATION STATEMENT

The two alleys proposed to be closed are internal to the property owned by Louisville Metro and are not open to use by the general public. All abutting properties are owned by Louisville Metro. The alleys are required to be closed to enable the construction of a \$289 million mixed use project, consisting of a convention hotel, residential apartments, a public parking garage, a full service grocery and other retail, to be constructed on a majority of the block bounded by Muhammad Ali Boulevard, Liberty, Second and Third Streets by Omni Louisville, LLC.
