AN ORDINANCE APPROPRIATING \$14,500 \$15,500 \$16,750 FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUND AS FOLLOWS: \$3000 EACH FROM DISTRICTS 14, 24, AND 25; \$1000 EACH FROM DISTRICTS 12, 2 AND 15; \$500 EACH FROM DISTRICTS 7, 13, 1, 17, 20, 21, 22, AND 23; \$250 EACH FROM DISTRICTS 3, 5 AND 8, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SHIRLEY'S WAY, INC. FOR EXPENSES ASSOCIATED WITH THE SHIRLEY'S WAY FINANCIAL ASSISTANCE PROGRAM (As Amended).

**SECTION I:** The sum of \$14,500 \$15,500 \$16,750 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from Districts 14, 24 and 25; \$1,000 each from Districts 12, 2 and 15; \$500 each from Districts 7, 13, 1, 17, 20, 21, 22, and 23; \$250 from Districts 3, 5 and 8, through the Office of Management and Budget, to Shirley's Way, Inc. for expenses associated with the Shirley's Way Financial Assistance program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
