## RE: The Marginal Personality, Root Cause of Heroin Epidemic

#### **BACKGROUND**

### Dear AG Beshear,

- A. Pursuant to the AG's campaign-promise of "protecting the rights of all Kentuckians," Complainants Daniel Cobble & Connie Marshall prays the AG will "rightly" process the herein *Complaint* for their families, and for setting the example for diminishing corruption in Kentucky.
- B. Since 2011, Complainants have given the public many examples of abuse within the Kentucky "Court of Justice." Abundant evidence shows the judges throughout Kentucky are operating **an unconstitutional**, "silent policy" of denying tax-paying citizens access to civil courts. When Citizen-plaintiffs are injured by gov'mt agencies / officials & corporate officers, these cases are summarily dismissed by Kentucky judges, in violation of the plaintiffs' **1st**, **7th**, & **14**<sup>th</sup> **Amendments** rights, as well as the illegal taking of their filing fees without intent to process these cases.
- C. Amendment 7, for example, guarantees Plaintiff's right to civil jury trial, and for all trials to be heard under "common law..." I.e., the courts must uphold plaintiffs' unanswered Complaints and Affidavits.

# Recommendations for Community Workshop Program to Reverse **PATHOLOGY OF NO-HOPE** by West End Youngsters

According to a 2014 study by the Anne E. Casey Foundation, African American children in Kentucky suffer from the **absence of:** 1) **justice** & 2) **economic opportunity** to create the conditions of no-hope within their fragile mental pathologies.

Wherefore, the West End should consider forming the following **ongoing workshops** & **committees**, as a comprehensive program, for adults "getting out in front" fighting for their children:

- **1. Monthly workshop on legal and constitutional rights**: So adults can learn when their children are violated by authorities. Then, "What to do next."
- **2. Monthly workshop on parental support**: Basic support mechanisms & tasks for parents to become liaisons between their children and authorities (LMPD, JCPS, Seven Counties, Dept of Juvenile Justice, Etc).
- **3. Policy committee on JCPS**: For developing recommendations (& publicizing) on how JCPS can better serve West End children; **such as:** 
  - 1) extending school lunch periods (reasonably to 30 min.),
  - 2) reversing policy on child suspensions,
  - 3) allowing child to attend school close to home,
  - 4) stop drugging Our children unless absolutely necessary.
- **4. Policy committee on dispersing tax dollars**: For submitting (& publicizing) recommendations on projects development in the West End, based proportionally on the taxes **paid by citizens west of the 9th Street corridor**.
- **5. Bi-monthly Youth Workshop for Careers Opportunities**: Experts from West End, Louisville at-large, & state displays availability of the many trades and professions throughout the U.S. Workshop is especially needed to expand consciousness of parents for planning their children's education.
