My contractor let me know that they just replaced the post on 4<sup>th</sup> Street. Also our consultant said it would cost \$944 for them to look into the 4<sup>th</sup> St Viaduct project. Do you have any extra funds to get them started, or would you like me to look into using some of our Urban Bike Network funding?

Below are the post meeting notes from the site visit:

### Meeting Notes

At the request of Councilman James, we met at the 4<sup>th</sup> Street Viaduct to investigate drainage and lighting, associated with safety concerns in the sidewalk and bike lanes.

Hello Councilman James,

Last Friday I met with one of our engineering consultants on site about this project. They are planning on providing a cost that would cover an initial assessment. I will let you know how much this will be to get them started. Depending on the cost, I might be able to cover it with our Urban Bike Network fund. Just wanted to give you an update.

Also, I provided our post contractor notice to proceed with replacing the posts under the via duct. I am hoping they will have these missing posts replaced within two weeks.
