

MEMBERS	No person shall serve on the Board who is a deputy sheriff or who holds any elected public office.
	No person shall be appointed to the Board who is a member of the immediate family of the Jefferson County Sheriff (father, mother, brother, sister, spouse, son, daughter, aunt, uncle, son-in-law, or daughter-in-law.
	No person shall serve on the board who is a deputy sheriff or who holds any elected public office.

COMPENSATION	Only reimbursement for necessary expenses upon submission of proper receipts or documentation of all such expenses. Reasonable and necessary expenses of the Board shall be paid out of the fees and commissions collected by the sheriff.
