## A RESOLUTION HONORING THE LIFE AND LEGACY OF DR. A. RUSSELL AWKARD

### Sponsored By: Councilwoman Jessica Green

**WHEREAS**, Dr. Awkard has been the Pastor of New Zion Baptist Church in Louisville since October 1972.

- **WHEREAS**, Dr. Awkard led the church in building a new edifice in 1973–1974, due to a devastating fire at the church before his arrival, and expanded the facility in 1985–1986.
- WHEREAS, under Dr. Awkard's leadership, numerous outreach projects have been developed by New Zion—at home and abroad—including television, jail and prison ministries.
- **WHEREAS**, under Dr. Awkard's leadership, New Zion sponsored a 122-bed nursing home (1983–2011), a 72,000-square-foot community center (2002–2011), and launched a free boarding school for middle school boys (2006).
- WHEREAS, Dr. Awkard served as President of the Lott Carey Baptist Foreign Mission Convention (1991–1994), Moderator of the Central District Association (1989–1995), and Moderator of the General Association of Baptists in Kentucky (2004–2009).
  - WHEREAS, Dr. Awkard is President of Rodgers-Awkard & Lyons Funeral Home.
- **WHEREAS,** Dr. Awkard is married to the Honorable Pamela E. Bridgewater Awkard, retired United States Ambassador to Benin, Ghana, and Jamaica.
- **WHEREAS**, Dr. Awkard is the father to two daughters, Alicia and Alma, and stepson, Clarence Benboa (Venita). He also is the grandfather to four grandchildren.



## CHURCH HISTORY

Forward by Faith - 1927 and Upward – Little Zion Baptist Church was organized on April 14, 1927, after a ries of prayer meetings in this neighborhood that was then called "Little Africa." There were 25 Charter Memi in the organizational meeting, during which Rev. C. J. Cunningham was elected as Pastor. Deacons, Trustees, Senior Choir and Little Zion Female Quartet were soon organized. A wood frame edifice was built at 3414 Yo Avenue in August of that year. The Pastor operated several small businesses in the community. He was married Mrs. Dollye W. Cunningham, a noted author, instructor and organizer. Her missionary manual is still u by the National Baptist Foreign Mission Board. During this era, the church developed a rich music ministry. C years, New Zion has given thousands of dollars to Simmons in their honor.

1950's - In January 1950, Little Zion Bapitst Church moved to a new brick sanctuary at 34th and South Ave; the name then changed to **New Zion Baptist Church**. At the height of his ministry, Pastor Cunningham was Central District Moderator, Trustee, Treasurer and Instructor at Simmons University (now Simmons College KY).

1970's - Rev. Cunningham died on March, 13, 1971, after serving 43 years and 11 months as shepherd February 1972 the edifice was destroyed by fire. Worship services were moved to Magazine 7th Day Adver Church. Shortly thereafter, Rev. A. Russell Awkard of Fredericksburg, Virginia, was called to be New Zion's sond Pastor. He arrived on the 4th Sunday in October 1972. A new church facility was completed and dedicated April 1974 (41 years ago this month).

Radio and Television ministries began in the 1970's. Live radio services were broadcast over WLOU, beganing in February 1975. Early morning services started in March 1977. Prison Ministry was launched in 1978. To vision services began on Channel 32, four months after the church mortgage was liquidated in December 1979. Television ministry is now seen three times a week on the Faith Channel 19.

1980's – From 1983 to 2010, the church was Sponsor of James S. Taylor Memorial Home, a 122-bed intermed and skilled care facility. The church's expansion project was completed in 1986, adding a chapel, administra offices, and second-story educational wing with a library.

1990's – New Zion began operating an after-school program, and continued the summer youth day camp. A car stewardship campaign elevated our stewardship commitment. Yet, Tithing (10%-Plus) remains the cornerst of our church's financial support.

The 21<sub>st</sub> Century -- A six-million-dollar reconstruction was completed on the James S. Taylor Memorial Ho now Christian Care West. New Zion Community Development Foundation purchased the old Virginia Avenue ementary School in 2002. A food pantry, clothes store, and summer day camp and other services were operated 10 years. West End School was established at the historic site in 2004 as a free boarding school for middle-sch boys.

Including 2014, the Lott Carey Baptist Foreign Mission Convention has held its Annual Session five times in L is ville. New Zion was the Host Church in 1977, 1984, 1992, and 2003. Pastor Awkard was President of Lott Ca (1991-1994). New Zion established a \$50,000 endowment with Lott Carey for foreign students in 2002.

Like his predecessor, Pastor Awkard is an entrepreneur -- President of Rodgers-Awkard & Lyons Funeral Ho He also served as Moderator of Central District Baptist Association (1989-1995) and Moderator of the General sociation of Baptists in Kentucky (2004-2009). His wife, The Honorable Pamela E. Bridgewater Awkard (retir is the former U.S. Ambassador to Benin, Ghana, and Jamaica.

In June 2013, a 21-member delegation traveled to Kingston and Montego Bay, Jamaica, visited Ambassador Bridgewater, and introduced the new concept of "Voluntourism" through their outreach to the **Jamaica National Children's Home.**


