Districts 2 and 25; \$700 from District 6; \$500 each from Districts 5, 8, 9, 10, 11, 12,

<u>16, 17, and 22, 23, 24, and 26;</u> and \$250 each from Districts 7, 10, 13 and 15;

through the Office of Management and Budget, to United Nations Association of the

United States of America Kentucky Division, Ltd. For programming expenses

associated with conducting the Human Trafficking Conference: Local to Global.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
